## Letter From Chief Ward

Citizens and Visitors,

The Wisconsin Dells Police Department had a very successful 2013. Officer Brinker was promoted to Sergeant and officers participated in more training then previous years.

In an effort to increase training and tactical response Sergeant Brinker and Officer Wiese were added to the Columbia County Emergency Response Team. This joint venture proved to be very successful and was the first time an outside agency was able to join the team. Both Brinker and Wiese, who are also firearms trainers, are responsible for instructing all WDPD officers in dynamic entry and active shooter.

Focusing on improving community policing the Community Assigned Patrol (CAP) program was started. Officers are assigned a specific City Ward and are tasked with community clean up, neighborhood watch and giving a personal attachment to a neighborhood.

WDPD contracted with NIXLE to provide emergency and community alerts via text and email. WDPD has created different text groups for special events, city employees and the general public. This alert system has been very beneficial and I believe WDPD will increase NIXLE messages annually.

The City progressed with the implementation of more parking options. Lot # 5 was converted to “Pay by Pay Station” parking and the result was a 100% increase in parking revenue (for lot#5). Both pay stations and mechanical parking meters were integrated into the Smart Park system. This system utilizes Passport Parking to provide a service which allows consumers to pay for parking using their smart phones.

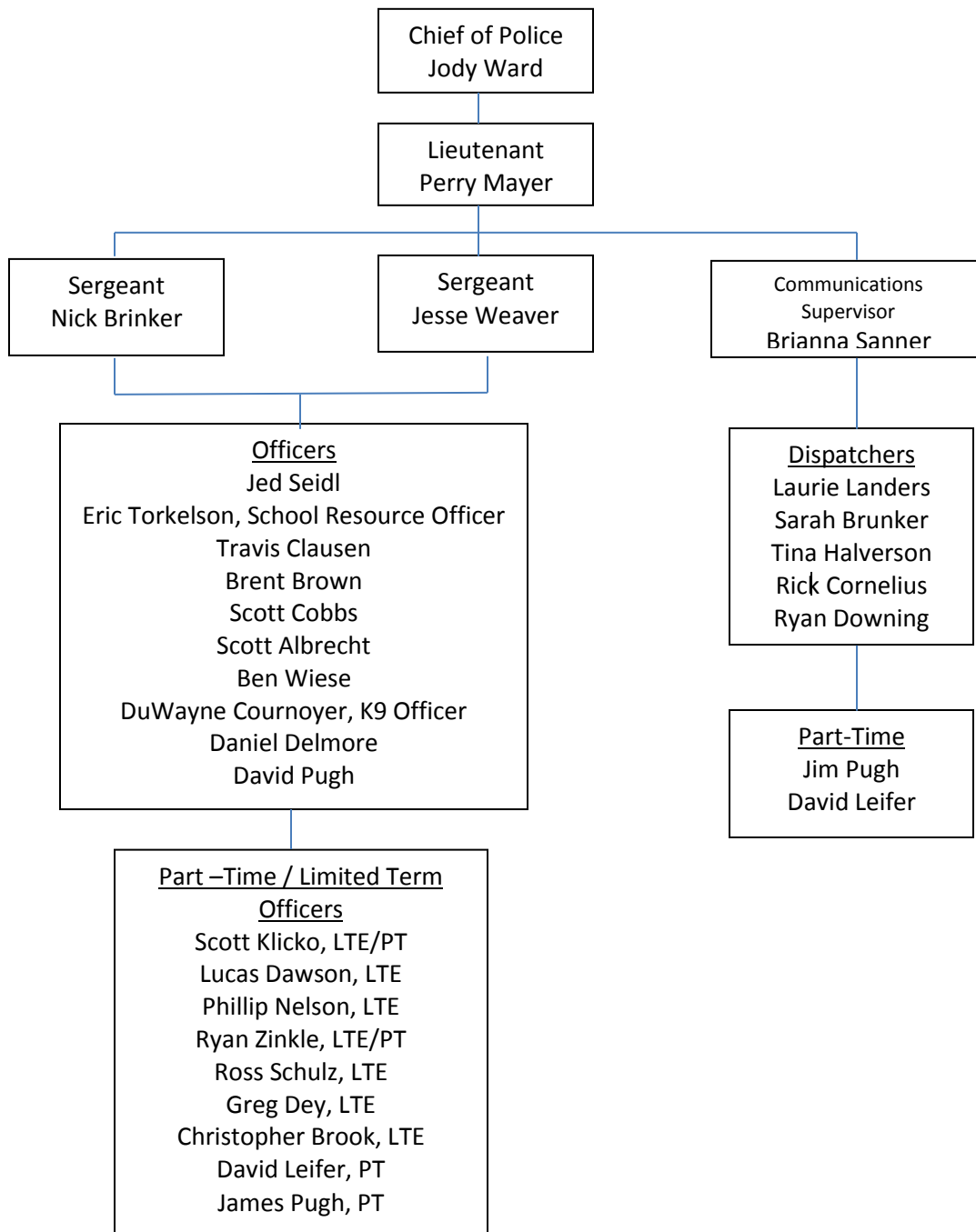

## Police Administrator Summary

Submitted by Lieutenant Mayer

The 2013 year began in similar fashion as the past few, with the hiring process for our annual LTE's moving quickly. In just a couple short months the candidates have to pass an application process, written test, assessment day including interviews, scenarios and report writing, and then an administrative interview. Final selections were made and conditional offers given pending medical, physical and psychological examinations, as well as an extensive background investigation. After clearing those processes, they start field training, a seven week course on becoming a Wisconsin Dells Police Officer.

Assessment Day this year had the extra strain of a man-hunt situation that evolved in Lake Delton that ended with the successful capture of four violent burglars from the Rock County area. WDPD responded with eight officers and our K9 before it ended and no one was injured.

Special Events continue to be in high demand each year. Recurring events are usually easier to plan because you can build on previous years; however, new events are coming in as some past events come to an end. With the longevity of our employees, comes more earned time off making many of these events difficult to cover. I also spend a fair amount of time fulfilling Open/Public Records Requests as this process has become exponentially more popular over the past couple of years.

In 2013 there were 270 requests for Time-Off with 16 of them being denied. The significant increase in denied requests was due to less flexibility in the schedule as I did not have the ability to cover as many of the shifts this year. We also continue to send as many officers to as much training as possible. Our focus areas have been Active Shooter/Danger, Officer Involved Shootings, and Child Crimes.

With our city lying in four counties and our school district adding a fifth county, we make every possible effort to keep in touch with the officials in those counties. Chief Ward attends the Columbia County Chief's meetings, while I attend the Sauk and Juneau County Chief's meetings. We have also met with Adams County law enforcement administrators periodically.

Planning consumes the majority of my time. Whether it's scheduling duties, a special event, training, or hiring, as I look back I see that planning took the majority of my time. That includes assisting in the planning for the remodel that started in 2014.

2013 also brought us *McNeely-v-Missouri* which created a significant change in how we handle OWI arrests with persons who refuse to submit to evidentiary testing for alcohol in their system. We are now required to get a search warrant for this process which includes at minimum a recorded phone call and several emails to a judge, and in some cases we must dictate the phone call. We also have to make a special trip to the court on the next business day to 'return the warrant'. Procedures vary slightly in each county.

The city adopted an Employee Handbook which governs all police personnel except where the officers union contract is in effect. Along with that came a city-wide time clock for all employees which had not previously been used by police personnel.

## Communications Administrator Summary

Year 2013 brought knowledge, change and personal growth throughout the Wisconsin Dells Police Department Dispatch Center.

The Federal Driver Protection Privacy Act took center focus in the realm of open records in 2013 due to several law suits in the appeals courts regarding the interpretation of same. I worked very closely with our city attorney John Gerlach on this changing and developing issue throughout this year and well into the new year of 2014. Our amount of accident report requests did decrease due to the uncertainty of the appropriate interpretation of this act. At the direction of Atty. Gerlach we started to refer more requesters to the WI Dept. of Transportation for acquisition of these reports instead of releasing them ourselves. However, outside of accident reports, our open records requests dramatically increased by 53% this year and encompassed much of my time. The size of these requests varied significantly as well as the content of the requests made.

As supervisor, I am proud of my dispatchers and the job they do. In order to maintain our skills and learn new ones, the dispatchers partook in several training opportunities throughout 2013. All of the full time dispatchers attended an Advanced Active Shooter training specifically geared towards our important role in communications during such events. One of our dispatchers also participated in a scenario style active shooter training. Some of the other trainings attended in 2013 by dispatchers and/or myself include: Validations Officer Post Traumatic Stress Disorder (PTSD), On-Star, Suspicious Activity Reporting, Wisconsin Crime Alerts, and Dealing with

Difficult People, to name a few. This year we successfully had our first dispatcher out of six full time dispatchers, including myself, acquire their Emergency Telecommunicator Certification from the International Academies of Emergency Dispatch. This was a start and I expect to have all our dispatchers certified in the future, although this is not a requirement by our state.

Scheduling became a large focus of my time in 2013 as our scheduling structure shifted in accordance with FLSA guidelines. Along with the scheduling change was the city wide implementation of a time clock. I worked very closely with the City Treasurer on the implementation, training and management of this system Police Department wide. These changes spurred me to continue the development and expand my own knowledge of FLSA law and human resources, which has ushered me into the new year of 2014 in conjunction with the change in employee representation. This year marked the last year of the union contract between the City of Wisconsin Dells and the dispatcher's union. I worked hard to assist the dispatchers and our dispatch center in general with a smooth transition into the following year and the implementation of the Wisconsin Dells Employee handbook.

I look forward to continued change and growth within our dispatch center in 2014.

## Uniform Crime Statistics

Submitted by Communications Supervisor Sanner

As mandated by the Wisconsin Legislature [§16.964(1)(g)], the Wisconsin Office of Justice Assistance (OJA) is responsible for reporting information concerning the number and nature of criminal offenses known to have been committed in the state. This includes collecting crime and arrest data from 399 separate law enforcement agencies for the FBI’s Uniform Crime Reporting Program (a nationwide cooperative statistical effort of more than 17,000 law enforcement agencies voluntarily reporting data on crime). The primary objective of UCR is to generate reliable information for use in law enforcement administration, operation, and management. Today, the American public looks to the Uniform Crime Reports for information on fluctuations in the level of crime, and criminologists, sociologist, legislators, municipal planners, the media, and other students of criminal justice use the statistics for varied research and planning purposes.

This report, prepared by the OJA Statistical Analysis Center (SAC), is a collection of crime data reported to Wisconsin law enforcement agencies in 2012. It contains detailed information on crime volume, rates, and trends on eight major criminal offenses as designated by the FBI: Murder, Forcible Rape, Robbery, Aggravated Assault, Burglary, Larceny-Theft, Motor Vehicle Theft, and Arson.

## Drug Investigations

The Wisconsin Dells Police Department has taken a strong stance against illegal drugs in our community. Without a question, drugs have a tremendous negative impact on communities, as well as a very high social and financial cost to all of us. According to reports, more than half of all people arrested in the U.S. test positive for illegal drugs. It is also known that drug addiction often leads to increased property crimes and robberies. More than 25% of current inmates in the U.S. committed their offense, while under the influence of drugs.

The Wisconsin Dells Police Department made a total of 142 drug related arrests in 2013. Possession of marijuana and Possession of Drug Paraphernalia were again the two highest drug arrest categories for the reporting period. This is consistent with national drug trends.

Recently, designer drugs have become a dangerous epidemic in our communities. Over the past year, hospitals throughout the country have seen an increase in emergency room visits as a result of people using synthetic marijuana and cocaine products. The Wisconsin Dells Police Department recognized this trend and started an initiative in 2013 to rid the community of these harmful drugs.

The Wisconsin Dells Police Department worked under the advisement of the Wisconsin Department of Justice and with the cooperation of the Columbia County District Attorney's Office to shut down a major supplier of these designer drugs. A lengthy investigation was conducted and through it a search warrant was secured and executed on a business operating in downtown Wisconsin Dells. As a result, over six kilos of Synthetic Marijuana were seized with a street value of \$57,000.00. Through the investigation, information was obtained on the only other known large scale source in the area, which was in Sauk County. The Wisconsin Dells Police Department did work with detectives from the Sauk County Sheriff's Department to secure a search warrant on that business and ultimately shut them down. Also, this spring a drug investigation was conducted in the City of Wisconsin Dells. Months of investigation led to enough information to obtain search warrants for the residence and vehicles belonging to the suspect. Recovered in the search warrants were 13.4 grams of Marijuana and 87 grams (3 oz) of cocaine. This drug investigation was a major achievement for the police department as it put a stop to the distribution of these drugs in our community. The overall investigation into designer drugs set a tone in the community that these substances will not be tolerated by local law enforcement.

The Wisconsin Dells Police Department worked with the city attorney and legislative committee to pass a city ordinance banning the possession and delivery of synthetic marijuana and cocaine like substances. Further, Senate Bill 57 is pending in the Wisconsin legislature, which would make the distribution of designer drugs a felony, punishable by a fine up to \$10,000, imprisonment of up to 42 months, or both. The Wisconsin Dells Police Department continues a strong commitment to defeat illegal drug use and sales, in the community, to reduce property crimes and create a healthier and stronger environment.

In 2012, I was fortunate and very pleased to have been assigned as Wisconsin Dells PD's K9 Handler. K9 Eddie has been with the Wisconsin Dells Police since 2010. K9 Eddie is a 6 1/2 year old pure bred German Sheppard. He is trained and certified to locate and detect the odor of narcotics. Those narcotics are cocaine, heroin, marijuana, and methamphetamine. K9 Eddie is also considered a "Dual Purpose K9" meaning he is also certified in criminal apprehension, area/building searches, tracking, and article searches (evidence recovery).

K9 Eddie is nationally certified through the North American Police Working Dog Association (NAPWDA) and his certification is in good standing. K9 Eddie and I maintain and exceed 16 hours of specialized training a month.

Becoming a K9 Handler has been rewarding and learning experience. It takes dedication not only while on duty, but off. K9 Eddie is not only a great police dog he is also a special part of my family. He does live with me and is just like any other pet when he is not working. I take great pride in K9 Eddie's abilities to perform his duties. K9 Eddie's statistics for the past few years will prove he is reliable and will continue to provide results.

In 2013, The Wisconsin Dells Police Department continued to be one of the best trained agencies in the State of Wisconsin. WDPD Officers compiled a total of **1847.5 hours of training** for the year which equals to be approximately **115 hours of training per officer**. This exceeds the Department of Justice standards of a minimum of 24 hours of continuing education. These trainings include classroom, web based training, and also hands on training. Some of the specialized trainings that officers attended include: Drug Investigations, crime scene and evidence photography, crisis management, fire/arson investigation, human trafficking investigations, and Field Training Officer to list a few. Every year officers are also required to attend a 16 hour county wide in-service training. The Wisconsin Dells Police Department attempts to keep most training in-house to avoid costly over-time. Below is a list of Officers who are certified to teach specific unified tactics.

## 2013 Columbia County Emergency Response Team Participation

In March of 2013, the Wisconsin Dells Police Department added two officers to the Columbia County Emergency Response Team (ERT), Sgt. Nicholas Brinker and Sgt. Ben Wiese. Sgt. Brinker and Sgt. Wiese are the first law enforcement officers from outside the Columbia County Sheriff's Department to be assigned to the team. The Columbia County ERT is trained in hostage rescue, barricaded subjects, sniper situations, high risk apprehension, high risk warrant service, and personal protection. The ERT trains twice a month, with the training material varying from training to training. In 2013, Sgt. Wiese and Sgt. Brinker attended over 120 hours of training with the ERT in addition to their other law enforcement training commitments. Sgt. Wiese and Sgt. Brinker also completed an additional 80 hour special weapons and tactics course in September of 2013. In 2013 alone, Sgt. Wiese and Sgt. Brinker responded to all three calls for service in which the ERT was requested. These calls included armed suicidal subjects and barricaded armed subjects

## Police Explorers

2013 marked the 21st year in service for the Wisconsin Dells Police Explorers (W.D.P.E.) program which was started in February of 1992 by Officer Brian Landers. The W.D.P.E. program is a non-profit organization that has provided area youth and young adults the opportunity to explore the career of law enforcement and actively participate in community events.

The police explorer program provides educational classroom and hands-on career training on the purposes, mission, and objectives of law enforcement. Police explorers also have the opportunity to participate in a ride-along program, organize and participate in fundraising events, provide basic security and traffic direction at area events and compete in local, state and national competitions.

The W.D.P.E. program has been credited for improving self-confidence, promoting strong team building and leadership skills, providing social networking with peers and mentors within the law enforcement community and providing college and career readiness.

In 2013, the Wisconsin Dells Police Explorers had eight youth members and six adult participants. Explorers met 31 times and were involved in 4 school recruitment days. Explorers took part in 488 community service hours.

During the 2013 year, W.D.P.E. members assisted with the Kops For Kids campaign, Automotion Weekend, July 4<sup>th</sup> Fireworks, Wo-Zha-Wa Festival, Autumn Harvest Fest, a triathlon and other miscellaneous events they assisted the Wisconsin Dells Police Department with. Meetings were held on a bi-weekly basis and usually were located at the Wisconsin Dells Community Center/Library.

Former members of the W.D.P.E. program as well as citizens of the community have expressed their support and gratitude for the program. The program has had a positive impact on the community and many past members have gone on to have successful careers in law enforcement.
