Video Guidelines

- Videos should be thirty seconds or less, of your own work, and no animals harmed in the making.
- Entries must include the completed entry form. For individuals under the age of 18, please have a parent or guardian sign for permission.
- Submission forms should be included with entries by emailing OARawards@ohioalleycat.org.
- Videos can be provided in one of two formats:
 1. A link of the video for judging from your own YouTube or Vimeo page, video must remain viewable through February 21, 2016.
 2. Provided in a .wmv or .mov file format. Upon request, OAR can provide a link to our DropBox if the file is too large to email.
 3. Mailing a DVD with .wmv or .mov file along with a completed entry form to “OAR –A'cat'emy Awards Video Contest,” 5619 Orlando Place, Cincinnati, OH, 45227

One winner per category will be selected. Contest runs from November 20, 2015 and ends February 10, 2016. Winners will be notified on or around February 17, 2016.
