

END-USER LICENSE AGREEMENT FOR CURSE.

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL: ALTERED REALITY ENTERTAINMENT LLC End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and ALTERED REALITY ENTERTAINMENT LLC for the product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("CURSE"). By installing, copying, or otherwise using CURSE, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and ALTERED REALITY ENTERTAINMENT LLC, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. 1. GRANT OF LICENSE.

(a) Installation and Use.

(b) Backup Copies.

You may also make copies of CURSE as may be necessary for backup and archival purposes.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

(d) Rental.

You may not rent, lease, or lend CURSE.

(e) Support Services.
