The World Overview of Conservation Approaches and Technologies -WOCAT is a partnership with a common strategy and objectives for Sustainable Land Management. The WOCAT/FAO partnership has enabled the integration of WOCAT knowledge and experiences into the FAO-led Land Degradation Assessment in Drylands project (LADA) that is supported by GEF and UNEP as an important contribution to the UN Convention on Desertification (UNCCD). LADA is a global project, collaborating with Argentina, Cuba, China, Tunisia, Senegal and South Africa and other technical partners, in the development of standard methods and tools for assessing and monitoring Land Degradation (and improvement). The assessment of LD/SLM is an important basis for planning and decision making in the field of land management and territorial development from national to local levels. The tools and methods are applicable not only in drylands but in the range of ecosystems worldwide.

10h00 – 13h00 Dryland Protected Areas: Ecosystem-based approaches to Climate Change

Food security, water stress, land degradation and biodiversity loss will become some of the greatest environmental issues in the next decades, exacerbated by climate change and rising pressure on land and natural resources. Protected areas cover only 12.9% of terrestrial areas but many occur in dry land and desert areas, maintaining biodiversity but also providing goods and services which provide social and economic benefits, especially to poor and vulnerable communities. This session will focus on the key roles that protected areas in dry land ecosystems can play in promoting more sustainable land management and as "natural solutions" helping people cope with climate change. Presentations will include an overview of protected areas as part of land management strategies in dry land landscapes, as well as country case studies that illustrate the role of protected areas in combating desertification, maintaining essential water services and contributing to food security, disaster reduction and carbon sequestration.

14h00 – 18h00 Integrated Economic Assessment of Land Resources and Ecosystem Services

The scientific community is particularly engaged in the development of integrated approaches to assess the impact of interventions both at the micro and macro level. Inherent to this work is the development of indicators, methodologies and techniques to evaluate the costs and benefits of investing in sustainable land management (SLM). This is the bedrock on which to generate evidence-based arguments to demonstrate the contribution of responsibly managed ecosystems to global prosperity, sustainable development and poverty reduction, and develop arguments to inform and sensitize decision makers at all levels. The session will show how to build an understanding of the economic value of land resources and the economic rationale for measures to combat land degradation and will discuss how to link this understanding to key policies for sustainable development. Case studies from different parts of the world and the experience of policy makers will be brought together to show how and why this should be a central pillar of any approach to sustainable land management and the management of fragile ecosystems in different environments.

10h00 – 12h00 The PRC-GEF Partnership on Land Degradation in Dryland Ecosystems: Experiences, Lessons and Opportunities for Innovation

The People's Republic of China (PRC) suffers from some of the world's worst land degradation problems, with more than 40% of its land area adversely affected and millions of livelihoods threatened. To respond to this challenge, the PRC-GEF Land Degradation Partnership was established in 2002 with the assistance of ADB, GEF and other partners. Interventions include improving the legal and regulatory frameworks for combating land degradation, formulating Integrated Ecosystem Management Strategies, strengthening institutional capacity for implementing IEM, and working with local communities to pilot on-the-ground implementation of sustainable land and water management to improve livelihoods.

Experiences from the program will be shared, along with opportunities to further scale up SLM, including through the development of innovative market-based mechanisms, and the application of best practices using the WOCAT methodology. The session will include short presentations from selected projects, and a discussion of emerging lessons and opportunities.

30 The UNCCD Advocacy Policy Framework on Gender Facilitator: Sergio Zelaya, UNCCD

> UNCCD has mainstreamed gender, since its inception, by recognizing the role of women in ensuring rural livelihoods and by explicitly encouraging the equal participation of women and men in capacity building. Under the guidance of the decisions of CCD COP-9, and in line with the CCD's 10-year strategy, the Gender Policy Framework defines the commitment made through the Convention process to ensure the mainstreaming of gender equality through a holistic and comprehensive approach. Furthermore, the Advocacy Policy Framework on Gender demonstrates the benefits of mainstreaming gender in desertification and sustainable land management actions at national and local levels. It is the intention that the Gender Policy Framework will become a guiding instrument for the implementation of the UNCCD and its Strategy. Through the full participation of local people, particularly at the local level - and especially women - that the efforts to combat desertification can be most effective and efficient. At UNCCD COP-10, Parties have the opportunity to adopt the Framework that can simultaneously increase the effectiveness of combating desertification and achieve goals towards gender equality and empowerment of women.

At the tenth Conference of the Parties (COP 10) held in Nagoya Japan in 2010, through its decision X/19, the COP emphasized the importance of gender mainstreaming in all programmes of work under the Convention in order to achieve the objectives of the Convention and its Strategic Plan for the period 2011-2020 and the Aichi Biodiversity Targets. As a cross-cutting issue, gender does not have a "target of its own", rather it is an important part of the way in which activities to achieve ALL of the targets should be undertaken. As part of the Japan Biodiversity Fund support for the implementation of the Strategic Plan and that of the Aichi Targets, the CBD Secretariat is convening a series of and



sub-regional workshops on the revision of the NBSAPs. Gender mainstreaming is one of the themes covered at the workshops and, based on evaluation results, is consistently rated as an important and necessary theme. The CBD Secretariat also makes an effort to ensure that women are active in the discussions that lead to these decisions, and has funded over 1,258 women to attend meetings under the Convention.

In 2010, at the UN Framework Convention on Climate Change's 16th Conference of Parties held in Cancun, Mexico, Parties made several decisions that reflect the importance of gender mainstreaming in mitigating and adapting to climate change. In decision 1/CP.16 gender considerations and women's participation in climate change are in nearly all aspects of the decision including in the preamble, the shared vision on long-term cooperative action, mitigation, adaptation, technology and capacity building. In addition, decisions in the subsidiary bodies have given new mandates that increase support to building Parties' capacity on women's participation and gender issues.

> The promotion of gender equality is a matter of fundamental human rights and social justice, as well as a pre-condition for sustainable development. Empowerment of women and gender equality has been recognized as a real driver of development, significantly enhancing the effectiveness of programs, project, and initiatives. IUCN initiated a process of supporting the mainstreaming of gender in the Rio Conventions, working closely with the three Secretaries and facilitating the development of a common vision and shared roadmap.

Access to knowledge, however, depends on appropriate institutional frameworks at multiple scales, including practical tools that accommodate the needs of all land users. Application of SLM also depends on appropriate policies such as those related to land tenure, rights, and governance. The GEF-UNCCD publication sheds light on SLM experiences from around the world, including efforts by grassroots communities to overcome barriers and deliver measurable global environment and development benefits. The book is a joint effort of the GEF and UNCCD Secretariats, with high quality photographs contributed by the GoodPanet Foundation of World Famous Photogopher, Yann-Arthus Bertrand. It will be published with the generous support of the Korean Government through the Korean Forest Service.

Approximately 30% of greenhouse gas (GHG) emissions come from land use and land use change. Sustainable land management (SLM) interventions have the potential to not only reduce GHG emissions but also to sequester carbon and therefore provide global environmental benefits. There is a need for scientifically rigorous, cost-effective and standardized tools to quantify carbon benefits in GEF and other SLM projects. In this session, the tools developed by the UNEP/GEF Carbon Benefits Project for establishing carbon benefits of sustainable land management interventions in terms of protected or enhanced carbon stocks and reduced greenhouse-gas emissions will be presented. The online toolset, which is hosted by UNEP, is applicable to all projects involving interventions in natural resources management, such as forestry, agroforestry, agriculture and pasture management in all climate zones, soils types and land uses. Users can select from a suite of modeling and measurement tools and generate a standardized report of carbon benefits.

Land degradation is an ecological problem that manifests itself not only at national and local levels by affecting the economic and social wellbeing of people, but also at a global level by undermining the integrity, functions and services of various ecosystems. Biological diversity underpins the global economy and the wellbeing of society. The complex financial systems obscure the fact that all such human systems remain subsystems in the Earth's broader ecosystem. The poor, who depend disproportionately on biodiversity for their subsistence needs, suffer first and most severely from its degradation. Recognition of the link between ecosystem services and the fate of poor people implies that biodiversity should be a priority in national and international efforts to address poverty reduction. Just as the impact of biodiversity loss is disproportionately felt by poorer communities, there are also disparities along gender lines. The Millennium Development Goals emphasize clear linkages between gender equality, poverty alleviation, biodiversity conservation and sustainable development. Such insights need to be included into our and approach to reversing biodiversity loss, reducing poverty and improving human wellbeing and equity.
