Domestic Well Owner, Is Your Drinking Water Safe?

A good supply of fresh water is essential to human existence. We use fresh water not only for drinking, but for bathing, growing food, cleaning, watering animals and watering lawns. In Nebraska, about 95 percent of rural residents get their household water supply from private or domestic wells. If they are not properly protected, these wells are at risk of being contaminated from several sources. Potential sources of ground water contamination which may be present near your home include septic tanks, animal waste, pesticides, fertilizers, fuel storage tanks, household chemicals, used motor oil, and more.

The potential for contamination in our area is also increased because of the sandy soil. The only way you know if nitrates and or bacterial are present in your drinking water is by testing because both are colorless, odorless, and tasteless. A water test for nitrate is highly recommended for households with infants, pregnant women, nursing mothers, or elderly people, as these groups are most susceptible to nitrates. Coliform bacteria are microscopic, generally harmless organisms that live in the



intestinal tract of many warm blooded animals including humans and are excreted into the environment through feces. Although most coliform bacteria are not directly disease causing, some are often found with other, more dangerous strains of bacteria like E. coli, shigella and salmonella. Some strains of E. coli are known to cause vomiting, diarrhea, and other serious gastrointestinal problems.

We are starting year 6 in our cycle which means that we will be testing both registered and non-registered domestic wells in Sub District 1 which includes all of Grant County and the southwest third of Cherry County. We are glad to offer this important safety service to you AT NO CHARGE. Trees provide important benefits such as protecting homes and livestock from wind and snow, helping to reduce heating and cooling cost, preventing soil erosion, increase crop yields, and providing wildlife habitat. There are four different Small Acreage Packages that can be ordered through the Upper Loup NRD. These packages are \$52.75 each, and are not available for costshare. There is a limited amount of these packages left.

Each package will contain 10 of each species. The West package includes the following species: Colorado Blue Spruce, Rocky Mountain Juniper, Cottonwood, Sandcherry, and Gambel Oak. The East package includes: Southwestern White Pine, Colorado Blue Spruce, Swamp White Oak, Dogwood, and Serviceberry. The Wildlife package includes the following: American Plum, Dogwood, Woods Rose, Gambel Oak, and Sandcherry. The Flowering package includes: Nanking Cherry, Sandcherry, Serviceberry, Dogwood, and Caragana. To purchase one of these Small Acreage Tree packages, please call Shane at 308-645-2250.

Upper Loup NRD Offers Cost Share for Soil Testing and Leafy Spurge

Soil testing is an important diagnostic tool to evaluate nutrient imbalances and understand plant growth. Testing the soil provides a basis for intelligent application of fertilizer and lime. Testing also allows for growers and homeowners to maintain a soil pH in the optimum range (6.0-7.0), which keeps nutrients more available to the plant for growth. Your local County Extension offices can instruct you on how to take the soil samples yourself. There are businesses that you can contact that will obtain the sample for you, one such group is your local Farmer's Co-op. The ULNRD understands the importance of soil testing and has a cost-share program to help land owners defray part of the costs associated with testing.

The use of herbicides for leafy spurge control is just one part of long term management that should include good grazing strategies and can include grazing by sheep or goats or biological control by the release of insects. It's important to continue yearly management as skipping a year can allow leafy spurge to re-infest rapidly. Extension educators and county weed supervisors are very good resources for weed management.

The ULNRD provides cost share funds for BOTH fall and spring treatment to landowners in the NRD area. Funds are available to cover 45% of the cost of approved chemicals up to \$400 per landowner. The appropriate chemical herbicide can be applied by a landowner with private pesticide certification or by a certified commercial applicator. NRD's Featured on NETV Program in March

The NRDs were featured in an hour-long program on Nebraska Educational Television (NET), titled "Keeping Nebraska Local: A Unique Approach to Resource Management". Chemigation Training

Before an irrigator can begin chemigation, state law requires a permit to be obtained from the local NRD on an annual basis. Permit fees are due by June 1st and expire on midnight May 31st the following year. Permit fees through the ULNRD are as follows: Renewal Permit: \$30.00, New Permit: \$60.00, Special Permit: \$60.00 and Emergency Permit \$250.00. Inspections will continue to be made on a three year cycle; new and modified systems must still have an inspection prior to injecting fertilizer or pesticides. Renewal permits and fees are due in the office of the Upper Loup NRD no later than 4pm CT on June 1st.

If you plan to apply chemicals, you MUST ATTEND one of the courses and pass a written exam to be certified. Certification is good for four years. Area training dates and locations:

Boater Safety Education

Boating Safety Courses teach students how to safely operate a motorized boat while following all rules and regulations. You must be at least 14 years of age to operate a motorboat or personal watercraft in Nebraska.
