THE WISCONSIN PG – More than 10 Years Later

Progress in Recognizing the PG Designation Disappointing

It has been approximately 11 years since the Wisconsin Professional Geologist (PG) registration was enacted in November 1994. The hope was the registration would give geologists a more equal footing with the Professional Engineers, and that it would establish a legally defined standard of professional conduct and quality in the performance of work involving the geological sciences. Unfortunately, some of the most basic goals of the registration have yet to be realized. While most geologists working in the environmental and groundwater fields have obtained the PG registration when eligible, the success in establishing the registration as the standard for geological work in the State has been disappointing. 2006 WRWA Conference Summary

Making Waukesha County More Water-Wise

"WATER*WISE in Waukesha County – Conserving our Valuable Water Supply" was held Saturday, March 25, 2006 from 9:00am to 2:00pm at Carroll College in Waukesha. This program was co-sponsored by Carroll College Environmental Sciences Program, Carroll College Student Services, Clean Wisconsin, Friends of the Mukwonago River, Grassroots of Waukesha, Midwest Environmental Advocates, League of Women Voters, Sierra Club, Waukesha County Environmental Action League (WEAL), and Wisconsin League of Conservation Voters Institute (WLCVI). There were a couple last-minute agenda adjustments (sessions on "Preserving Recharge Areas" and "Land Use Policy" were replaced with "Vernon Marsh" and "Water Ethics"), and schedule timing miscalculations (breaks to move between sessions and question/answer periods were too short). However, this is a "first of its kind" program, and it otherwise went off without a hitch. Everyone of the approximately 150 people in attendance seemed to be satisfied.

Ice Age clues unearthed from construction hole

Long before the finishing touches are made to UW-Madison's **Microbial Sciences Building**, a small but significant bit of science has emerged from the hole where the \$120 million, 330,000 square-foot structure is emerging. Using relatively new dating techniques and ancient glacial till and lake sediments gathered from the enormous, 35-foot-deep pit where the building is now rising, Wisconsin geologists have obtained the first reliable dates for the last time a massive ice sheet enveloped what are now Madison and the UW-Madison campus.
