# **NGWA Initiatives for Developing Ground Water Careers**

The NGWA Professional Development and the Industry Practices staff are developing a brochure that will provide brief descriptions of different ground water-related careers (lab technician, hydrogeologist, water well contractor, pump installer). The brochure should be completed by April and will be available to NGWA members to use, such as for school career days.

The NGWA Public Awareness department will be advertising in the American School Counselor's Association magazine and sending the briefs on ground water professionals, hydrologists, and water well contractors to 3500 high school counselors nationwide. Additionally, NGWA Public Awareness will be issuing a news release nationwide through a distribution service promoting NGWA's Career Center. This effort may generate a larger pool of job applicants, which, in turn, would induce more employers to post jobs to the NGWA online Career Center. <<MORE>>

On November 13<sup>th</sup> members and guests of the northcentral area met to discuss "Monitoring Mysteries".

This meeting was organized by WGWA member Evie Fisher and was attended by two lab managers, a chemist, a landfill operator, two landfill consultants, a city employee, a representative from the paper industry, and the local NR 500 specialist from the WDNR.

Topics discussed covered monitoring schedules and parameters at landfills, the presence and suspected sources of spurious compounds, such as phthalates, the occurrence of BTEX in groundwater associated with biopiles, and the immediate need for improvements to the GEMS reporting system.

Although there were more questions than answers, all the attendees agreed this was an excellent discussion which may be worthy of a sequel.
