**Events:** Four (4) Events/Divisions: **Novice Team** and **Open Team**, Novice Singles, Open Singles, (CASH PRIZES IN ALL EVENTS)  
Event Times: (See Schedule to right), Friday 5PM-10PM, Saturday 9:30AM to 6PM

**Eligibility:** Open to all ages and skill levels. Good sportsmanship is expected.

**Singles Event:** There will be two divisions: **Open Singles** for all those with a USATT rating of 1,000+ (or converted Canadian Rating) and **Novice Singles** for those 999 and under. The minimum Novice Rating will be 500 (a 500 rating is for those who have just begun playing and have not placed in a tournament before). Proposed plan is top two (2) players in round robin pools of 3-4 players who advance to playoffs. Six or less players in an event will have only one pool of round robin to decide the result of the division. Playoffs or Finals may be moved to Saturday if needed.

**Team Event: TWO DIVISIONS: Novice Team** members all must be rated at 999 or under. **Open Team** members are rated 1000 or greater. Teams can have two or three players but choose two (2) players for each tie. Prior to the start of the tie, each team captain will designate who will be participate. Only one singles match in the tie will be with the same two opponents. A maximum of four (4) players can play per tie. If time allows, each tie will consist of two (2) singles matches, a doubles match, and two (2) additional singles matches. Depending on the number of teams entered & time limitations, the alternate method will be 2 singles matches and one doubles match per tie.

**Special Tournament Regulations:** These will be Point System Events. AKA: Handicap. All players will be given an AYC tournament rating by the Director. Input from Regional Directors in each region helps provide the best adjusted ratings for this event. For every 50 points difference in rating 1 point will subtracted from the higher-rated player prior to the match. All games will be scored to 11 points. If time allows, matches will be best 3 of 5 games. **Exceptions: in matches where 12 or more points are given, matches will be best 2 out of 3. Due to time limitations maximum handicap will be limited to -16 points. Players in Open Team rated below 1000 will be granted a minimum of 1000 rating value.**

**Seeding and Draw for events will be based on Individual or Team Rating Average. Traveling Clubs must submit list of individual entrant ratings, and and team configurations PRIOR TO 6/6/16. Team ratings will averaged based on top 2 team members.**

**Check in:** Check in to CONTROL DESK **EACH DAY** 15 minutes PRIOR to your first match. All USATT & ITTF rules apply. Decision of Tournament Director is final.

**Entry Deadline: Monday 6/6/16 by 11:59PM. Full entry form and FEES must be received by deadline to avoid late fees. (No Exceptions)** Entries received after this date/time will only be accepted based on available space. Late fees apply.
