**Restrictions:** All skills levels welcome. Max limit 24. Minimum 16 entries.

**Format:** Singles matches, Check-in & practice 9:30-10:10 AM. Two rounds:

**PRELIMINARY PLAYOFFS.** Results from preliminary round places you in A, B, C & D pools based on 1st, 2nd, 3rd and/or 4th position.

Preliminary round robin will have 4 5 or 6 pools. RR pools will have 3-4 players. Top seeded players distributed in preliminary pools with various skill level players. Format will allow entries 5 to 8 matches over the GIANT RR format event. You could play 15 to 40 games!!

**Rules:** Check in by 10:10AM at control desk. Matches will be best 3 of 5 games. Games to 11 points, All USATT & ITTF rules apply.

Good sportsmanship is expected. Decision of tournament director is final. Matches are self umpired w/ assistance from referee as needed.

**Entry Deadline: Tuesday 11/14/17 by 10PM.** Full entry form & FEES must be received by deadline to avoid late fees.

Entries received after this date/time will only be accepted based on available space **No refunds after 11/14/17 deadline.** Once 16 entrants have been received the WAIT LIST to make 20 or 24 PLAYERS allowing 4 added player groups. Goal is 24 player in 6 prelim pools of 4. Enter NOW... Today.
