The intent of this tournament is for fun, friendship, and an opportunity to participate competitively in Table Tennis. Players of all skill and age levels are welcome.

Regulation: This event will follow "The Laws of Table Tennis" Chapter 2 www.ittf.com unless modified herein or by the Tournament Directors.

Equipment: Stiga and/or Butterfly tables will be used. White 40+mm three star balls will be used.

Liability Waiver: All participants must sign the release form. All minors, under 18 years, must have parent/legal guardian sign the release form.

Participant check in: 15 minutes prior to the start of your event. Event time is forfeit time. All participants must have non-marking clean gym shoes.

Special Tournament Regulations: Players may wear shorts, slacks or athletic pants. Same color shirts are encouraged but not mandatory for the Team Event. No white shirts.

Ratings: Each player will be given a Tournament Rating by the Directors. This rating will be based on the home club's recommendation and previous tournament play. After the Singles Matches, if a player's rating is out of line with the other players, a representative from Yukon and Alaska will meet with the Referee and work out a reasonable solution.

Handicap: This is a point system event. For every 50 points difference in rating, 1 point will be subtracted from the higher rated player prior to the match. All games will be scored to 11 points with a win by 2 points. If time allows, matches will be best 3 of 5 games, except in matches where 12 or more points are given, which will be 2 out of 3 games. *The number of games per match will be determined after all the entries are received.*

Singles Event: There are two divisions: OPEN for those with a tournament rating of 1000+ and NOVICE for those with a rating of 999 and under. The minimum rating will be 500.

Team Event: Each team can have two or more players. All players will play in the highest member's division. Individuals with a 1000+ rating must play in the Open and Open Teams. The minimum rating in the Open is 1000. Each tie will consist of a doubles match and 2 singles matches. The singles matches will have top play players playing each other and the 2nd rated players playing each other.

Individuals who want to play in the team event and do not have a partner should contact a Tournament Director.

Tips: Good sportsmanship is expected. Bring a sports bag, towel, athletic clothes (no white shirts), and a water bottle.

Food: Snacks and water will be provided by DCTTC and must stay in the Ancillary Room or on the stage. Except for water bottles when playing.

Deadline: FEES & COMPLETED FORMS MUST BE RECEIVED BY **MIDNIGHT ON JUNE 1.** Late entries accepted if approved by the tournament directors.
