TERMS AND CONDITIONS of TAS Gallery member

- **Membership forms to be renewed at beginning of each financial year**
- **FOR PERIOD 1 JULY 2016 TO 30 JUNE 2017 - YOU WILL BE REQUIRED TO DO DUTY AS A GALLERY ATTENDANT FOR A TOTAL OF 6 HOURS PER MONTH. THIS CAN BE IN THE FORM OF 2 X 3 HOURS SHIFTS OR ALTERNATELY ONE FULL 6-HOUR DAY.**
- **Framed Artworks:** (paintings, photography) 1 space of approx. 1mtr square (can be made up of 1 large, or several medium to small, not exceeding 6 works in total).
Framed paintings are to be replaced with new work every two months. If work sells it can be replaced with a new piece in the same position, otherwise new works are to be left at the gallery for the Hanging attendant.
Framed works must be ready to hang – D rings near top of frame so that the work hangs flat against the wall
- **Unframed Art:** (paintings/photography) One space per artist per year.
Unframed pieces can be changed at the artist's discretion, but limited to only one piece.
Unframed work must be suitably mounted and wrapped for display
- **Decorative Arts & Crafts:** 1 space of 50cm x 50cm per year.
Decorative Arts and Crafts also need to be renewed every two months.
- **Card Rack:** One card rack slot per member for twelve months.
Each member can supply as many cards as will fit into a single slot, without overcrowding.
Cards must also be marked on the back with name, price.
- **10% commission is payable to TAS on all works sold in the gallery.**
- You are required to complete a Record Sheet (list of works) in the folder under your name at gallery.
- "FRAMED PAINTINGS", "DECORATIVE ARTS & CRAFT", "CARD RACK", "UNFRAMED RACK" under your name.
- A permanent label must be placed on the back of all works showing Name, Title, Medium and Price.
- Paintings and crafts remain the property of the artist until sold (including laybys which incur a 50% deposit)
- No alteration of price or copying of work without the artist's consent
- Any work left at the Gallery for more than 6 months may become the property of TAS
- Gallery attendants are not responsible for any loss or damage to works at the Gallery
- Works are not covered by TAS insurance
- **TAS reserves the right to refuse to hang or display a piece of work for any reason. Works are not to breach owner's copyright. The Management and Sub Committee reserve the right not to display works that may be considered as breaching the copyright law.**
- Gallery attendants must be familiar with the Gallery Guidelines Document
- TAS committee **may remove your artwork from the gallery** if you fail to do the allocated 6-hour monthly roster duty.
- **Photography/filming for publicity purposes by TAS is allowed (Newsletter, Website, Facebook, etc.)**
- Payment for goods sold is by Direct Credit to your nominated bank account each month.
- Payment account details to be given to TAS Treasurer and kept up to date.

Being a TAS member entitles you to the following:

- Entry to our annual Townsville Art Awards at Perc Tucker Regional Gallery (Separate Form and Fees apply)
- Opportunity to sell your works at Jezzine (providing you do your allocated 6-hour monthly roster duty)
- A monthly newsletter (hard copy available in Galleries or emailed to the given email address)
- Access to the Exhibition Space at Art at Jezzine. (Have your own exhibition - see Exhibition Coordinator for more information)
- A membership card allows for discounts from art suppliers and framers who support TAS
- Access to the Classroom facilities, in Hut 26 (see Classroom Coordinator for more information)
- Use of our library, attendance at Committee Meetings and an opportunity to attend Workshops at Member prices.

You will receive your welcome letter after the next monthly meeting with further instructions on training, roster duty and when to bring your artwork.
