**Acknowledgement of Risk, Release & Indemnity Agreement**

I \_\_\_\_\_ (Name of Guest) hereby acknowledge that I have been invited by the undersigned club member to enter on to and to engage in shooting at the Bridgeport Rod & Gun Club (hereinafter referred to as BRG and/or The Club). I acknowledge that there is risk of injury from these activities, including the potential for permanent disability and death, even with the use of protective equipment, supervision and compliance with club rules and do hereby KNOWINGLY AND FREELY ACCEPT ALL RISKS that may arise from said activities. I AGREE that I, my next of kin, heirs, guardians, representatives and assigns HEREBY RELEASE BRG, its officers, directors, attorneys, agents, employees, contractors, volunteers and guests from any and all claims, demands, damages, expenses, or liability of any kind whatsoever, that I, my next of kin, heirs, guardians, representatives or assigns may have for property damage, personal injury or death resulting from my entry on to BRG's property, using The Club's facilities or equipment, or engaging in or observing shooting and other activities at The Club, even if such claims, demands, damages, expenses, causes of action, attachments of property, or liability result partially or wholly from any act or acts, even any negligent act or omission to act. I agree to indemnify and hold harmless BRG, its officers, directors, attorneys, agents, employees, contractors, volunteers and guests from any and all liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with my presence at or use of BRG premises, facilities or equipment, or participation in activities associated with The Club including the discharge of firearms. I agree that I have been given instructions in the safe handling of firearms and that I have been instructed on the range rules and procedures and am confident that the instructions are adequate to provide for my safety. I attest that I am not currently prohibited from owning or handling firearms. I further attest that I have sufficient personal liability insurance to handle any claims that may be brought against me in the event of an accident or injury. I have carefully read this "Acknowledgement of Risk, Release & Indemnity Agreement" and fully know its contents. I acknowledge that no other inducement, assurance or guarantee has been made to me in consideration of my signing this Agreement, which I sign voluntarily and of my own free will.
