Dr. Jumoke Oduwole is a lecturer in the Faculty of Law of University of Lagos, Nigeria, where she has taught since 2004. Her current research interests include International Trade and Development and China in Africa, and she is a published author. Jumoke is an elected member of the University of Lagos Senate and sits on the Misconduct Committee of Faculty of Pharmacy, at the College of Medicine.

Dr. Oduwole was recently appointed as the 2013-2015 Prince Clause Chair holder, a visiting professorship of development and equity in honour of the late Prince Claus of The Netherlands by the Curatorium chaired by H.R.H. Queen Maxima of the Netherlands. She was selected a 2013 Associate by the African Leadership Institute for the prestigious and highly selective Archbishop Desmond Tutu Fellowship, one of 26 young leaders from across the African continent. She was one of the 25 fellows in the inaugural (2012/2013) "Leadership for Change in Africa" programme (West Africa), an initiative by the Private Investors for Africa (PIA), which aims to create a network of pan-African, high potential emerging leaders across all sectors, working in partnership as catalysts for change in Africa. She was also selected to attend the BMW Foundation Europe-Africa Young Leaders Forum in 2012, and is a member of the BMW Foundation Global Young Leaders Network. Oduwole is a Vice President on the Executive Board of Africa Association of International Law (AAIL), representing West Africa. She also seats on the executive committee of the African International Economic Law Network. She is a member of both the Nigerian and American Societies of International Law (NSIL and ASIL) as well as the Society of International Economic Law (SIEL). Jumoke is the Co-President of the Stanford Alumni Club of Nigeria and is a Member of the Executive Committee of the Oxford and Cambridge (Oxbridge) Club of Nigeria, where heads the club's CSR committee.

Jumoke is passionate about development issues in Africa and has worked on or volunteered on one-off policy projects in the areas of development and national planning, tax reform, corruption, public health, and urban housing in Nigeria. She is currently heading a technical sub-committee in charge of volunteers for the 2014 World Economic Forum on Africa. She is also on the research faculty of the Nigeria Economic Summit Group (NESG) in an advisory capacity, and has participated in a voluntary capacity in the work of a number of organizations including FATE Foundation and Changing Our World Foundation. Jumoke is a member of the Editorial Advisory Board of *CSR Files* TM the leading information and resource reference point on corporate sustainable development in Africa.

Dr. Oduwole has consistently mentored Nigerian youth in various capacities for over 15 years, and is regularly invited to speak at youth fora. She is the only female judge on "*The Next Titan*," a nation-wide reality television show geared at encouraging entrepreneurship among Nigerian youth as an answer to chronic youth unemployment. She is co-founder of "No Limits," a platform which focuses on inspiring and instilling leadership values in Nigerian youth. In addition, she currently sits on the Boards of Positive Action for Treatment Access (PATA), an HIV/AIDS advocacy NGO; and the "Know Your Constitution" Initiative, a civil liberties organisation pioneered by a United Nations Young Ambassador for Peace, one of her former students.

Prior to her career in the academia, Jumoke led a corporate banking unit of the telecommunications sector team in Guaranty Trust Bank Plc's Corporate Banking Group. She was an investment banker with FCMB Capital Markets, a division of First City Monument Bank Plc from 2000 to 2003 and worked on a number of Capital Raising, Mergers and Acquisition and Privatisation transactions for local and multinational clients. From November 2010 to October 2011, after successfully coordinating the maiden edition of The Kuramo Conference 2010, Jumoke was appointed as the founding Director of The Kuramo Foundation Ltd Gte, a law and development non-profit closely affiliated with the Lagos State Government, which focuses on using law as a tool for social change.

Dr. Oduwole graduated from University of Lagos with a second-class upper Bachelors degree in law in 1998 and was called to the Nigerian Bar in 1999. She obtained an LL.M. degree in Commercial law (second-class upper) from Cambridge University, England in 2000, where she was a DFID-Cambridge Commonwealth Trust Scholar. In 2007, Jumoke received a masters degree in International Legal Studies from Stanford University, USA and was a Graduate Fellow at the Stanford Center on International Conflict and Negotiation (SCICN) from 2007/2008.
