QAC INVOICING

BCICA contractor members are reminded of the Accounts Receivable Policy that states in part.:

- "Invoices issued by the BCICA are due and payable at the end of the month following the month of invoicing. (Net 30 days MF)".
- "BCICA shall charge a 1.5% monthly service charge on all past due amounts."
- "BCICA shall notify any member whose accounts are past due."
- "The BCICA Board of Directors shall receive a report on a member whose account is 60 days past due."

Members are asked to remind staff responsible for accounting to pay BCICA invoices promptly.

ADDITIONAL FEES ASSOCIATED WITH A QAC

BCICA Members are also reminded to include travel expenses such as mileage (currently @ \$0.54 / km), ferries, additional meals or LOA if necessary, for QAC inspection. All designated inspectors are currently based in the Lower Mainland and therefore they must travel to the Interior or Vancouver Island to inspect QAC work. The inspectors include these extra costs when they invoice BCICA for inspection of QAC work. BCICA will invoice BCICA Members for these additional expenses once received from the inspector. It has been suggested that BCICA Members use Vancouver Central as the starting point for the calculation of mileage when an inspector visits jobs out side the Lower Mainland.
