**Minutes of Last Meeting**

The Board held a brief discussion on a nuisance property on Allegheny Avenue. Ms. Lemin informed the Board that a hearing occurred in the Franklin County Environmental Court on July 14, 2015. A permanent injunction was obtained with a compliance date of August 31, 2015. The Board asked to be updated of any action upon the compliance date.

Colonel Stone reminded the Board that if there is not a quorum for a regularly scheduled Board of Health meeting then Franklin County Public Health shall call another meeting within two weeks.

Colonel Stone informed the Board members that he has participated in the Franklin County Public Health Connect Calls stating that the mosquito program update on the last call was very informative. He encouraged the other Board members to join the monthly calls held on the third Thursday of each month at 11:00 a.m.

**Environmental Health:**

Mrs. Lemin reviewed the written report provided to the Board (see attached). She reviewed the Mosquito Tool Kit and rain barrel flyer(see attached).

**Prevention & Wellness:**

Mrs. Wright reviewed the written report provided to the Board (see attached). She also distributed the "Back To School" Immunization Clinic Schedule flyer to the Board (see attached). Dr. Lemeshow inquired about Lyme Disease and Mrs. Wright stated the importance of health care providers being aware of the symptoms of Lyme Disease, proper diagnosis and treatment.

**Health Commissioner:**

Ms. Tilgner acknowledged the passage of the "Tobacco to 21" law by Bexley City Council on June 23, 2015. She thanked the City of Bexley for leading this movement. Ms. Tilgner informed the Board that the 2016 Health Services contract will be sent to the City of Bexley in September.
