






## FROM THE PRESIDENT



We already have nearly 10 years in the Casita, now what? The work of the House of Spain is a process of surprises and increasing responsibilities, same as maintaining a business, or our own life. As individuals, as we grow and mature we do not think the things we do day to day and we enjoyed doing this or that and learning from life as life goes on. As children we play this game or that game, we get to know other boys and girls, we grow, we study, work, buy a car, fall in love, get married, have children or adopt, we continue in our work, we buy a house, and we have more and more responsibilities. Our children get older and have their own children, our grandchildren. Wife, children, house, cars, insurance, loans, etc. we have lots of responsibilities that have been adding to our life slowly and suddenly we realize all this. One day we look back and wonder, how did I get

here?

The same thing has happened with our organization, *House of Spain*, Casa de España in San Diego. 30-years ago, we would get together in the parks, the beach, in private houses, we rented a house in San Diego in the eighties, we could not afford the rental payments and closed. A few years later we rented an office in "*Mission Valley*" and the same thing happened. Little by little we kept meeting in different places and participating with the community on different events. We became members of the *House of Pacific Relations* in Balboa Park. We became a *Non-Profit Organization 501-C-3*. *Built the casita* in Balboa Park with great enthusiasm, we all supported the project. We gave money, worked; we cooked and sold thousands of paellas ... to maintain de casita. Now, the same as a family that is forming or changing, we are faced with additional responsibilities, and one wonders, how did we get here?

I am telling you this because last month we went to the "*San Diego Tax Seminar for Non-Profit and Exempt Organizations*", a whole day seminar to learn our obligations as an organization. What we can and cannot do. What kind of reports we have to submit to different agencies at the city, state, and federal levels. Here are some of these agencies:

*California State Board of Equalization: Employment Development Organization: Taxpayer's Rights Advocate: Sales and Use Taxes: California Attorney General: Property Tax Exemptions: California Franchise Tax Board: Regulation of Charities: Federal Tax Issues for Exempt Organizations: etc.*

This is particularly important to consider, because it means that every step we take and each new effort that we do to organize ourselves better, have an administrative impact, that sincerely before we didn't have. The regulations and paperwork we have to do to keep our organization in order in the day to day business is increasing. We have to organize ourselves better and get professional help, unless we want to do that work ourselves. Still the issue of coordination is extremely important and time consuming. All of this costs money and effort in addition to paperwork, because everything has to be documented. For this reason, it is extremely important that we all commit ourselves to help the organization or the organization has to spend funds to employ competent people that can keep the organization afloat and prosper. The BOD has to remain voluntary according to the bylaws, but the organization can pay competent persons to be able to maintain our present level or grow, as long as we adhere to the laws of the different agencies of the government. This increases the work and the time that the BOD has to put in our organization, but as all of us who have been in the BOD before know, the majority get burned out and then don't want to know anything about the our organization. The challenge, is a SOS, if we continue as we are, our organization will wither away for lack of interested members, if we want to persist and I do, we need to change and with that change, to attract more members that can take our business forward. We are in a new century, our challenges are new, but not impossible.

The organization needs your ideas and help!


Estimada Mesa Directiva y su Presidente Jesus Benayas:

## POPULAR FESTIVALS OF THE MONTH OF AUGUST

August, month of heat and vacations. In Spain, as in other European countries, many companies and businesses close their doors and give opportunity to their employees to take a well-deserved rest. All leave their homes and cities and head to faraway places to rest. Those who live among the mountains dream of beaches and those by the beach want to go to discover the mountains and enjoy the wonderful views and the freshness that it offers.

For many, there is always the nostalgia of the people and the families they have left behind to go find better luck in the big cities. The summer vacations are an opportunity to return to visit family and friends and remember the good times of childhood.

There are many towns that coincide to celebrate their feasts during the month of August. Some, who have their Patron Saint festival during the winter, have also decided to hold a "summer feast" to attract more visitors and tourists.

In August there are two major festivals that give opportunity to the towns to celebrate their patron saints and protectors. On August 15, the Catholic Church celebrates the Assumption of the Virgin Mary. On the 16<sup>th</sup>, is the festivity of San Roque. In ancient times this saint was very popular. San Roque is considered a protector against the plague and all types of epidemics, his intervention was requested by the inhabitants of many towns and, to the disappearance of these, they recognized the intervention of the saint, so he was named patron saint of the locality.

It would be impossible to list the towns and cities that celebrate their festivals in the month of August. (This editor has found more than 200!). Here are some examples:

**Calatayud (Zaragoza):** San Roque is the feast that gives rise to the most spectacular celebration of the city. The day before the "chupinazo" already you can feel the festive atmosphere with the wine of honor, the day on which occurs the presentation of the peñas, regaling the attendees with wine and appetizers, that same night all the peñas organize performances and concerts.

**Portugalete (Vizcaya):** Festivals of San Roque, wake up all the "jarrilleros" in order to invite them to the feast. After two hours walking around the streets of the town, one arrives at Plaza de la Ranchería where people taste the traditional garlic soup. During the day there is running of the bulls, activities in the Plaza de Toros, dances, dancing and at night fireworks on the beautiful setting of the estuary.

**Sanlúcar de Barrameda (Cádiz)** The horse races on the beach are one of the most significant events of the field of sports. The racing takes place during low tide, always in the afternoon.

**Ribadesella (Asturias):** The International Descent of the Sella River is held on the first Saturday of August between Arriondas and Ribadesella with a distance of 20 km along the Sella River. The trial is organized by the Spanish Federation of Canoeing.

**Villadiego (Burgos)** from 14<sup>th</sup> to 16<sup>th</sup> . Festivities of the Villa "I took those of Villadiego" with bulls, fireworks, dancing, etc.

**Ayora (Valencia):** Festivities in honor of the Assumption of the Virgin Mary. They include a flamenco party, the traditional auction and sale of the Plaza; confinement of the bull and the toro "embolado".

The Board will present the following revisions for a vote by all members at the November General Assembly:


## ARTICLE 4 OFFICERS

### SECTION 2. QUALIFICATION, ELECTION, AND TERM OF OFFICE

Candidates who are members in good standing and are fluent in the Spanish language and are familiar with the history and culture of Spain shall be eligible to hold office. ~~Furthermore, to hold the offices of President and Vice-President, the candidates must be native Spaniards, children of a native Spaniard, or citizens of Spain (subject to verification).~~ In addition, the candidates for President **and Vice-President** must have served on the Board of Directors for at least ~~six (6) months~~ **1 year**.

All officers mentioned above shall be elected at the annual meeting of membership. Furthermore, three (3) members in good standing shall be elected to serve on the Board of Directors. **No two members of the same family shall serve on the Board of Directors.**
