S/T Missionary Trips - Arise Africa frequently takes Americans on mission trips where they participate by teaching kids Bible camps, organizing the orphanages and working with the many community partners in Zambia for the benefit of orphans and vulnerable children.

Orphanage - Arise Africa finished building a Zambian orphanage in August 2012 and moved kids into the home in December 2012. 9 children live in our full custody and we have capacity to add up to 15 total children.

Child Sponsorship - Arise Africa has a small and very impactfull child sponsorship program. We have discipleship leaders who work with our kids on a daily basis and provide love and support to children who do not get it from home. We cover school fees, healthcare, clothes, and one meal each school day all while discipling the children. There were 120-150 children in the program during 2013.
