Driving Directions

Core Chiropractic & Wellness is located in the Lake City Professional Center 2611 NE 125th St., on the second floor in Suite 240. There is ample FREE parking.

From I-5Northbound on I-5

Option 1: Take the NE 130th St Exit. 174. Once you exit, merge in to the right lane and turn right on to 130th St. 130th will turn in to 125th St. Stay on 125th St. Cross 15th and head down hill. The Lake City Professional Center (a red brick 2-story building) will be at the bottom of the hill on your right.

Option 2: Take the Lake City Way Exit 171. Stay on Lake City Way approximately 2.75 miles to 30th Ave NE (a left turn before 125th St) turn left at 30th Ave NE. Next light turn left at 125th St. and the Lake City Professional Center (a red brick 2-story building) will be ahead on the left.

Southbound on I-5

Take the 145th St Exit 175. Once you exit stay in the left lane and turn left on to 145th St. Stay on 145th St. until you reach 15th Ave NE. Turn right on to 15th Ave NE. Stay on 15th until you reach 125th St. Turn left on to 125thSt. Head down the hill. The Lake City Professional Center (a red brick 2-story building) will be at the bottom of the hill on your right.
