I feel we have management and accountability problems with our civil servants, most of the problems occur between the planning stage and the execution stage. Once that is stabilized we can put more resources into cottage roads and services.

From my research short-term rentals are a widespread problem affecting people's quality of life. There are a lot of people working on solutions in different municipalities and we need to share ideas on how to solve it. The waterfront property taxes are disproportionate to the services that are being provided. I understand this because my business at Kawatha Garage is taxed at \$4500 a year and I get garbage pickup but because of my volume I have to pay for a bin. We can't do anything else with this land but to develop it for living accommodations so we need to ease up on the development regulations.

Thus far as Ward 1 Councillor I've served on the Culture & Heritage task force, Municipal Heritage, Property Standards, Order to Restrain, Waste Strategy and Planning Committees, the Dalton, Carden and Norland Management Boards. I've joined the Miller Public Engagement Committee, Kirkfield and District Historical Society, Victoria County Historical Society and Norland Summer Festival Committee.

In the short term it's my intention to follow through on the development of a Grant Program for the purposes of supporting the provision of Medical Services to
