As you know this last term the mayor placed great emphasis on an outdated core plan. The wheels were put into place prior to your return from a winter away several years ago. I know that many of you were very surprised. As residents we did manage to get council to put a hold on the closures of community centres and arenas. The fire halls issue was partially implemented after two additional consultants' reports.

Because of my word restraints I will briefly tell you that I have serious concerns regarding our roads and seasonal road historical agreements that have previously been in place as well. The zoning, building and planning departments need the

involvement of some knowledgeable, impartial individuals to possibly rewrite policy as to the way business will be conducted moving forward.

The council looked at these problems many times in the past and very little has been accomplished. The cost overruns, budgets, fire and police departments and the airport all need to be looked at. The transparency of the financial issues deserves honest forthright answers when inquires are made.

Our waterways should always be an area of great interest as the Trent Severn Waterway is the jewel of the Kawarthas and its purities should be preserved for future generations.

Representing tax payers in Ward #2 on a professional level, something that has not been done to this date would enable me to push the agenda.

More clarity and less government is a good thing. Regulation around waterfront properties should be the same for all lakes. Unless like you have a lake policy area by-law. I would like to freeze taxes for two years and then only increase them to the level of inflation if necessary. Permit issuing processes should be reduced.

As a current councillor who's ward covers half of Sturgeon Lake and part of Pigeon, I work closely with the cottage associations. Some of the issues we have been working that may be similar are the following.

Limited Service Agreements. We have been working with public works to ensure we are not losing any of our current servicing models as these legal agreements become policy. So far so good, we have maintained and even improved some services. I will continue to advocate for all constituents in the new ward structure, including grandfathering of services on private roads and allowing more L.S.As.

Short Term rentals have also been a hot topic, both for and against. The best way for us to deal with this now and how council has directed, is for any issues be reported to the appropriate agency i.e. bylaw, police, fire etc.. The city will be tracking data over this next year and a report will come back to council to make appropriate changes.

Development regulations are a tricky one because some are provincial policy which must be followed.

Some regulations are the municipality and Kawartha

Conservation, on both of these I have worked with the planning

department and Kawartha Conservation to get the best outcome for the property owner. I have had continued success with both departments. I sit on Committee of Adjustment and see many applications come through that the city has had to deny due to policy but our committee has approved as we are autonomous from the city.

As for water levels, we all know that is the Trent Severn Waterway who controls the levels. The water levels have caused issues in the spring for many lakefront property owners I will continue to advocate with the mayor and council to make sure that there is better control on this.

This current Council has approved the upgrades to the Fenelon Dump and increased the budget for gravel roads by 40% both are great improvements for the new ward 2.

With the reduction of council by 50% we will need Councillors who have the knowledge to do the job and can hit the ground running, not spending a year or two learning the ropes and figuring out who they need to speak with to get the job done. I have forged those relationships prior to being a councillor, with developments I have worked on in COKL and strengthened them over the past 4 years as a Municipal Councillor.

I know the directors, managers and supervisor to call to get things moving, this is key to great representation for my constituents.

Thank you for your email and I appreciate your, and the Balsam Lake Association's, interest in the municipal election. The following is my personal background, the reasons that I feel it is important to be running in the election, and my views on the particular topics you requested.

For the past 44 years I have been in the auto repair trade. I have owned and operated John Sniders Auto Sales and Service in Bobcaygeon for the past 19 years. Prior to that, I worked in, and managed, another repair facility in Bobcaygeon. My wife and I were born and raised in Scarborough, however chose to move to Bobcaygeon 31 years ago to live, work and raise our family.

The experience I will bring to the Councilor position includes understanding business operations, dealing with employees, technical problem solving, customer relationships, and common sense and accountability. All of these attributes will help me in the position of Ward Councilor.

I believe the three most pressing challenges facing the City in the next four years are: control of runaway debt; property taxes out of control and need to be reined in; infrastructure — we are a City of pot holes. In order to bring meaningful jobs to CKL we need to reduce development fees in order to entice commercial and entrepreneurial development. We also require a citizens advocate department within City Hall to speed up plans of development.

I believe we need change, that includes restructuring how the City runs. We need to give the citizens a chance to speak up

and be heard as to how things are done and money is spent. In order to give the citizens that opportunity to speak up, I would like to offer referendums, along with holding regular townhall meetings, and being approachable for the Ward 2 citizens.

In regard to Limited Service Agreements, I believe that all roads, whether public or private, should be maintained and plowed as everyone using the roads are taxpayers.

Problems associated with short-term rentals should be handled by the City's By-Law Enforcement Department. That department needs to be expanded to include 24/7 coverage, including short response times. Further, enforcement should be placed upon the property owners to control their tenants.
