DI mechanical couplings – End Thrust Restraint (Gripper Type)	QUU has approved the use of Synoflex fittings for pressure sewerage and water supply systems, but not for PVC or GRP pipe materials. Changed the QUU condition as "Use of Synoflex is not accepted on PVC and GRP pipe materials."
Resilient seated gate valves	QUU rejected the use of AVK 570 series valves for water supply and pressure sewerage systems. Changed the QUU statement to " <i>Use of Series 570 is NOT ACCEPTED BY SP.</i> " UW fully accepted Daemco valves with no conditions.

Dutterny valves	Added Challenger to the suppliers list. "Use is subject to acceptance of SP" applies to each SP.
PE mechanical compression fittings for reduced size water mains	Changed the size of DN50 back to DN63 to be consistent with the Water Supply Code requirements. Renamed the product title. Moved the whole rows to the Water Services category. However still kept the size of DN63 only to support the reduced water mains specified in the Water Supply Code. The suppliers who do not supply the size of DN63 have been removed from the suppliers list.
