The annual permit fee is \$20 for one dog, \$15 for each additional dog (fill out additional membership forms), valid for one year from the date of purchase. For out-of-town or infrequent visitors to the dog park, there is a \$3 daily fee per dog which is collected in a locked box inside the gated entrance.

I understand that no agent of the Washington Dog Park Association or employee of the City of Washington will supervise the dog park at any time. I further understand and agree that the City of Washington is not liable for any loss, damage, or injury of any kind sustained by any human or dog while using the dog park. I thereby expressly assume all risks associated with using the dog park, as well as any fixtures or equipment located therein.

By signing the Release of Liability and using Sunset Dog Park, I hereby fully and forever release and discharge the City of Washington, their employees and agents from any and all claims, demands, damages, or causes of action present or future, whether the same be known and unknown, anticipated, or unanticipated, resulting from or arising out of my intended use of Sunset Dog Park premises, facilities, or equipment.
