Rules & Regulations

The Chamber of Commerce has developed these rules and regulations to provide an enjoyable experience for all participants, spectators, and event staff. Failure to follow these rules may result in immediate removal from the flea market. We appreciate your cooperation in continuing to make this a fun and pleasant community event.

All booth spaces will be along the side walk, in front of participating store fronts. All booths will be assigned by the Chamber of Commerce, please let us know if you have a preference. You will be contacted with your assigned area by May 19th.

Exhibitors must supply their own racks, tables, chairs, and necessary displays. Booth set up will begin at 8am.

Booths are to be set up and vehicles moved to reserved parking by 8:45am.

Booths to remain in operation from **9am to 3pm**. Exhibits may not be removed until after show hours.

Exhibitors are encouraged to stay until 5pm as spectators linger after the parade.

Collection and reporting of sales tax is the responsibility of each exhibitor. Sales tax in Washington is **7%**.

Due to limited parking, there will be a designated area assigned for your vehicles.

The Chamber of Commerce reserves the right to deny any application.

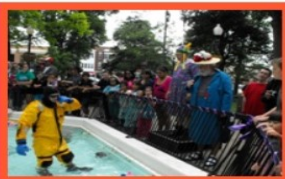
