# Seed-to-Sale

In 2016, the Harlan County Boys & Girls Club was a site for the "Seed to Sale" program. Children at the Club prepared raised beds, planted seeds, watered and weeded the plants, and harvested the fruits of their labors. Herbs, including peppermint, basil, and oregano were grown as well as tomatoes, cucumbers, squash, watermelon, cantaloupe, bell peppers, banana peppers and onions were grown. After harvesting, these herbs and vegetables were either prepared at the Club or sent home with the children.

#### Member Spotlight- Christopher Brown

Chris Brown is a sophomore at Harlan County High School and lives in Loyall with his mother and 3 younger brothers. He participated in the Club's sports leagues as a child and returned to the Club last year because he wanted to give back to others.

He states, "The Club has given me so many amazing experiences. I have been impacted so much by our kids and I hope I have impacted their lives as well. I love the staff at the Club....the em-

ployees are the most wonderful people I've ever met. They are so good to me and I couldn't ask for better people to look up to. I love being here. It's like my second home. I'm excited about the addition of a gym, but honestly the Club is perfect as it is. I love the Club and I'm so thankful to have it in my life!"





#### Volunteer Spotlight- Madyson Bennett

Madyson Bennett is a senior at Harlan County High School and began volunteering at the Club this year. She states that the Club has given her myriad of fulfilling experiences and introduced her to a host of remarkable people.

"I'm not going to lie. When I initially began volunteering at the Boys & Girls Club, I thought the extent of my responsibility would be to perform general housekeeping dutiespreparing and serving dinner, cleaning the facilities, etc. I quickly became aware of this stark misunderstanding as the fruits of my service began to extend into every other as-

pect of my life.

I have gained a deeper understanding of my abilities and began to realize the type of impact I have the potential to make- the type of impact I want to make. The kids look to me as a source of inspiration and motivation, and my influence, I've learned, doesn't end when we lock up at 6pm. Members carry the lessons I teach home, sharing their experiences with family and friends and further actualizing my hope of promoting mindfulness and fostering unity within my community.

While I like to think that throughout the duration of my service, I've been able to positively affect members' lives, I'm in no position to deny the profound influence they've had on me as well. Allowing the Boys & Girls Club to play such a major role in my life has truly made me a better person."

# Coming in 2017...a Gymnasium!

When the new Cawood Ledford Club opened its doors in 2007, it was close to perfect. It had a game room, an education lab, a fitness room, an arts and crafts room, office space, and a kitchen. However, there was one room noticeably missing....one that most other Boys & Girls Clubs have....a gym.

The Club's property was simply too small. It could house a beautiful 4,400 square foot facility with a small parking lot, but that was it. There were two rental properties behind the Club that would be perfect for a gymnasium. The board and staff alike crossed their fingers for years, waiting and hoping for these properties to become available for purchase.

One house became available in 2010 and Club leaders jumped at the chance to purchase it. The house was demolished, the land cleared, and then the waiting game started all over again. At the Club, cold, rainy days rule out the chance to play outside. On those days, 80-90 kids who would rather be hula-hooping, jump-roping, or playing a pick-up game of basketball, have to squeeze in the game room or computer lab. They not only wanted a gym...they NEEDED it.

Only one small house stood in the way of the dreams of so many. After six years, leaders were becoming discouraged. Just as hope was fading, the second property finally became available for purchase. Club officials swooped in at the opportunity. The land was immediately purchased and the lot cleared. Now the organizations board members are laying the groundwork to start a Phase 2 capital campaign to secure the funds to finally complete the Harlan County Boys & Girls Club. Stay tuned!
