ACCIDENT WAIVER AND RELEASE OF LIABILITY AGREEMENT

This form must be read carefully, filled out completely and clearly, and signed by the participant. Each rider must submit a waiver form.

In consideration of the acceptance of my entry in the **Dirty Spokes 3/6 Hour Mountain Bike Race** (Hereinafter referred to as "Race" or "The Race"), I, the undersigned participant, do hereby make the following agreement with the following entities or persons related to, or involved with, The Race: Dirty Spokes Productions, LLC; local, state and federal agencies and departments (e.g. firemen, police, paramedics, EMTs, boards of commissioners); Race holder; Race directors; Race promoters; Race sponsors; Race Vendors; Race volunteers; Race property/venue owners; and the respective directors, officers, employees, representatives and agents of each (hereinafter collectively referred to as "Releasees").

The Race will be a rigorous test of my physical and mental limits and carries with it the Potential for death, Permanent disability serious injury and property damage or loss. The risks include, but are not limited to: those caused by terrain; poor visibility due to darkness or fog; facilities; temperature; weather; condition of athletes; equipment failure or breakage; vehicular, animal or pedestrian collisions; poor hydration and/or food intake; and the actions of other people including but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors and/ or producers of the event

I Certify that I have been examined by a medical professional that has verified my fitness to safely participate in extremely strenuous events such as this Race.

I acknowledge that cycling is an inherently dangerous sport and I agree to assume all of the risks, known and unknown, of participating and/or volunteering in The Race including those risks stemming from the negligence of the Releasees. The risks include but are not limited to: dangerous or defective property owned, maintained, or controlled by the Releasees; dangers of collisions with fixed objects, people, bicycles; trail conditions and features such as hidden or obscured obstacles and jumps; the negligence of other racers; other natural dangers such as inclement weather vines or branches that could hit or grab a rider, falling limbs or trees, rocks, and wildlife. Despite these dangers I take the following action for myself, my executors, administrators, heirs, next of kin, successors in interest, and assigns: I waive, release, discharge, hold harmless, and promise not to sue The Releasees for any and all injuries, damages, expenses, and/or losses which may accrue, directly or indirectly from my participation in The Race, including those stemming from the negligence of the releases. I will indemnify the releases for any and all costs associated with enforcing my herein contained contractual agreement to waive, release, hold harmless and not sue the releases, even where the Releasees have been negligent.

I certify that I am physically fit, have trained sufficiently for participating in this event and have not been advised otherwise by a qualified medical person. I acknowledge that this Accident Waiver and Release of Liability form will be used by the event holders, sponsors and organizers, and that it will govern my actions and responsibilities at said event. In consideration of my application and permitting me to participate in The Race, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me including attorney's fees, expert fees, litigation costs, and my traveling to and from The Race. **THE FOLLOWING ENTITIES OR PERSONS** Dirty Spokes Productions, LLC. and any involved municipalities, their directors, officers, employees, volunteers, representatives and agents, the event holders, event directors, event sponsors, vendors, event volunteers, property owners; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in the Race, whether caused by the negligence of Releasees or otherwise.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident and/ or illness during this event which renders me unconscious or otherwise unable to convey my wishes regarding treatment.

I understand that at this event or related activities, I may be photographed and/ or videotaped. I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the event holders, producers, organizers and/ or assigns.

I agree that this "Accident Waiver and Release of Liability Agreement" shall be construed broadly to provide a release and waiver of liability of the Releasees to the maximum permissible under applicable law, and that each provision is severable, so that if any provision is deemed to be unenforceable, then the remaining enforceable provisions will remain intact. In the event any aspect of this release is deemed to be unenforceable, I hereby agree that the release shall be construed as broadly as possible without impacting the remaining aspects of this release.
