## **RULES READ CAREFULLY**

This show is covered by the rules and specifications of the current USEF rule book and will be conducted in accordance therewith.

Management will not be liable or responsible for any loss, accident, or damage that may occur during the duration of the show by any exhibitor, horse, or traffic infraction.

Entries MUST include photocopies of all membership for horse, rider, owner and trainer entered in rated competitions for the following organizations: USEF, USDF CDS. Check rating of competition entered. Memberships can be made online to all organizations. The back of the entry form MUST be signed in all spaces. Entries missing fees, signatures, copies of membership cards or any information will be accessed a fee of \$35.00 the day of the show. NO EXCEPTIONS!

Refunds are only issued prior to the closing date. **After closing, refunds issued less office fee if there are rides on wait list for that class.** Returned checks will be accessed a \$25.00 fee. **All entries must be received on or before the closing date.** Entries may be mailed, or left at Sycamore Trails Office by 5pm day of closing. Entries left after are late. Late entries will be charged a \$25.00 fee. NOEXCEPTIONS!

Should inclement weather cause cancellation, show fees will be refunded less a \$25.00 office fee.

Life, senior active and junior active members shall be eligible to participate in all regular competitions at the preliminary level or above and combined driving competitions at the advanced level, dressage, reining, and vaulting competitions and endurance rides provided the respective breed/discipline category fee has been paid. A non member may participate as a handler, rider, driver, owner, lessee, agent, coach, or trainer at regular competitions, eventing competitions, dressage competitions, reining competitions and combined driving competitions upon payment of a \$30. Non member registration fee. Participants in the following classes are exempt from the requirements of this rule: 1) leadline, 2) exhibitions, 3) games and races, 4) classes for 4-H members, 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program), 6)USDF introductory level test, pas de deux, and quadrille classes, 7) NRHA endorsed reigning competitions 8) opportunity classes, 9) citizens of other nations who have proof in English of current membership in good standing of their own National Federation, 10)USEA beginner novice division and 11) assistant handlers in dressage sport horse breeding classes.

Minors who do not have a valid drivers license which allows them to operate a motorized vehicle in the state which they reside will not be permitted to operate a motorized vehicle of any kind including but not limited to golf carts, motorcycles, scooters or farm utility vehicles on the competition grounds. Minors who have a valid temporary license may operate the above mentioned vehicles as long as they are accompanied by an adult with a valid drivers license. Violations of this rule will be cause for sanctions parent or responsible party of the child committing the offense. Penalties may include the exclusion of the child/parent/guardian/trainer from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with rule 6. Wheelchairs and other motility assistance devices for individuals with disabilities are exempt from this rule.

Regulation safety helmets are to be worn by all mounted competitors while on the show grounds, unless exempt during FEI specified classes only.

Helmets are to be worn at all times while competitors are on the show grounds.

You must warm up in the official warm up arena where the Steward is posted.

Dogs must be on a leash at all times. Lunging is available in the designated area only, not in warm-up ring.

Sycamore Trails does not permit Stallions on the facility grounds.

Prizes awarded in divisions with 3 or more riders, ribbons through 5<sup>th</sup> place.

A limited number of 12 x 12 permanent stabling with half doors are available through Sycamore Trails. Call (949)661-1755 for availability and rates.

I have read the United States Equestrian Federation, Inc. (the "Federation") Entry Agreement (GR906.4) as printed in the Prize List for this Competition and agree to all of its provisions. I understand and agree that by entering this Competition, I am subject to Federation Rules, the Prize List, and local rules of the competition. I agree to waive the right to the use of my photos at the competition, and agree that any actions against the Federation must be brought in New York State.

Release, Assumption of Risk, Waiver and Indemnification

This document waives important legal rights. Read it carefully before signing.

I AGREE in consideration for my participation in this Competition to the following:

I AGREE that the "Federation" and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

I AGREE to hold harmless and release the Federation and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Federation or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition.

I have read the Federation Rules about protective equipment, including GR801 and, if applicable, EV114 and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.

I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USEF accident/injury report form.
