#### **EXECUTIVE DIRECTOR/ADMINISTRATOR:**

#### **CLAIMS REVIEW COMMITTEE:**

The Claims Review Committee met on April 15, 2015. Report will be discussed in closed session.

**FINANCIALS** – Mr. Sacco referred to the Financial Fast Track for the month of February contained within the Agenda packet. He informed the Committee that Fund Year 2015 is currently running a deficit. He indicated that the deficit is a result of the number claims caused by the recent winter. Mr. Sacco added that the Fund office is monitoring the deficit and noted that there are plenty of funds from other Fund Years to extinguish it.

**SEWER BACKUP CLAIMS** – Mr. Sacco referred to the listing of sewer backup claims for the period of January 1, 2015 through March 31, 2015. He then asked for a motion to adopt Resolution # 17 -15 authorizing the assessments related to these claims.
