• Improve recycling by eliminating barriers to participation, offering containers at public facilities, improving residential containers and tracking progress while adjusting incentives

ADDRESS QUALITY OF LIFE CONCERNS

Some of the same issues that cause negative environmental impacts in Newton, such as poorly-maintained streets and overflowing garbage cans in our parks, also negatively affect our quality of life. It is our vision to address these concerns and preserve Newton's village character.

- Reduce traffic congestion through smart intersections, enhanced public transit through Needham Street light rail and Mass Pike commuter rail and improved pedestrian and bicycle access
- Keep our parks clean through improved waste container management, locally-accountable open space management, community partnerships and strict littering enforcement

• Maintain our infrastructure and streets through preventative maintenance, good planning and public input

• Protect public safety through community policing, improved emergency response times and a modernized dispatch center
