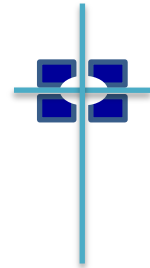


ST. WILLIAM SCHOOL
TUITION AND FEE SCHEDULE
2017-2018 SCHOOL YEAR



I. APPLICATION FEE (Non-Refundable)

A \$60.00 application fee is required for each current and new family. A birth certificate and baptismal certificate (Catholic students only) are also required for new applicants in preschool through grade 8.

II. TUITION

	Yearly	12 months
Single student (K – 8)	\$5,119.00	\$427/month
Two students (K – 8)	\$8,660.00	\$722/month
Three or more students (K – 8)	\$10,967.00	\$914/month
Full Day Preschool (3 and 4 yrs. old) M-F	\$5,119.00	\$427/month
Half-day Preschool (3 and 4 yrs. old) M-F	\$2,630.00	\$220/month

III. CURRICULUM FEE (Refundable ONLY prior to the first day of school)

In addition to the above tuition, there is an annual \$225.00 per child curriculum fee (includes technology) for all students in grades K-8. This payment is due with your July 2017 tuition payment to FACTS Tuition.

Pre-school annual supply fee: (This fee is due the first week of school)
 \$125.00 for full day preschool
 \$75.00 for half-day preschool

IV. MANDATORY FUNDRAISING FEE

This annual per family fee is based on the grade level of the oldest/only child.

Full Day Preschool, Kindergarten-8 Grades	\$350.00
Part Time Pre-school	\$175.00

The school will sponsor a sufficient number of major fundraising activities to enable families to meet this obligation. The mandatory fundraising fee must be paid by May 1, 2018. Any remaining amount due will be added to tuition after May 1, 2018. Families also have the option of adding this fee onto their monthly tuition payments or paying it in full.

V. MANDATORY SERVICE HOURS

Each school family is required to volunteer in any capacity for the school for 15 hours during the school year. Any family that does not reach the mandatory 15 hours of service will be required to pay \$25/hr. for the remaining hours by June 1st. (Maximum payment of \$375 may be added to monthly tuition in lieu of service)

APPLICATION PROCEDURES:

Open Application for returning students in preschool through 8th grade begins on February 3, 2017.
Applications for new students in preschool through 8th grade begins on February 10, 2017.

TUITION PAYMENT PROCEDURES:

One tuition payment plan will be available for the 2017-2018 school year through FACTS Tuition payment service:

12 Month Plan June 2017 – May 2018

After completing the online application process, you will receive a Tuition Contract from FACTS in your email, which will list all tuition and fees for the upcoming year.

ALL TUITION PAYMENTS ARE DUE ON THE 1st, 5th or 15th OF THE MONTH (Based on which date you selected in FACTS Tuition Service).

A FEE OF \$30.00 WILL BE CHARGED BY FACTS TUITION IF PAYMENT IS LATE

All tuition payments must be made to FACTS Tuition. Families can pay by check, credit card, or automatic deduction from your checking account. Save your receipts in case you are eligible to take advantage of the State of Illinois education tax credit.

V. PAST DUE ACCOUNTS:

Any account which is not paid in full on or before your chosen due date (the 1st, 5th or 15th of the month) is past due. The account will be subject to the following actions:

1. A late fee of \$30.00 will be charged.
2. If you are \$500 or more delinquent, your child(ren) will be suspended from school until payment is received to bring you below the \$500 delinquency.
3. Children in preschool, kindergarten, or 8th grade will not be allowed to graduate.

All tuition must be paid in full by your due date in May of 2018.

VI. FINANCIAL ASSISTANCE:

The Catholic School System, as well as St. William, strives to offer education to as many as possible. For families who are struggling financially, assistance is available.

St. William Scholarships for active St. William Parishioners will be available on a limited basis. Applicants must fill out a Financial Aid application through FACTS Tuition and a school supplementary financial aid form to prove hardship. Assistance will be available based on need. Appointments must be scheduled with the principal.

St. John Bosco Parish Scholarships for active St. John Bosco Parishioners will also be available on a limited basis. Applicants must fill out a Financial Aid application through FACTS Tuition and a school supplementary financial aid form to prove hardship. Assistance will be available based on need. Appointments must be scheduled with the principal.

Big Shoulders Funds of Chicago (BSF) applications are available for currently enrolled St. William School families in need. The BSF applications and income verification must be turned in by the end of September 2017, to be considered for financial aid. These scholarships are awarded through Big Shoulders Fund of Chicago, and are subject to approval and other stipulations. Applying for a BSF Scholarship does not guarantee acceptance. The scholarships will be taken off the full tuition due for the school year, after Christmas, when received from BSF.

Caritas Scholarships through the Office of Catholic Schools (OCS) are available only for current Caritas families enrolled at St. William School. Application and income verification must be entered through FACTS Tuition online. These are needs-based scholarships and OCS will determine eligibility and amounts awarded.
