FREE Tax Preparation is available through the Volunteer Income Tax Assistance Program!

Free tax assistance to people who make \$54,000 or less and help for those who wish to prepare their own taxes with limited assistance. IRS-certified volunteers provide free basic income tax return preparation with electronic filing to qualified individuals in local communities. You may qualify for special tax credits such as Earned Income Tax Credit, Child Tax Credit, and Credit for the Elderly or the Disabled.
