(OUR FACILITY)

The offices and storage facilities of Texas Hide & Seek are conveniently located near IH-635 and Jupiter Road in Garland. Our normal office hours are from 9:00 am until 6:00 pm. After hours arrangements can be made to fulfill customer or client requests when circumstances merit them.

Your collateral will be safely stored in either of our storage facilities. The outside option is protected by a 6 foot fence, complete with 3 strands of barbed wire on top. It is well lit and is under 24 hour digital surveillance. Also available is an indoor, climate controlled, area of over 3000 square feet. We are fully insured by Garage-keepers Insurance.

Our recovery vehicles are equipped with state of the art computer and digital audio/visual systems. The laptops are connected to RDN and the internet at all times to allow the recovery agent communication at all times when they are in the field.

(RECOVERY DATABASE NETWORK)



At Texas Hide & Seek Inc. we pride ourselves in keeping up with the latest developments in technology. We are a proud partner with Recovery Database Network (RDN) and use it to manage many aspects of our business. RDN is a server based network that may be accessed anywhere there is access to an internet connection.

If you are not already an RDN user, you will be assigned a log in that will allow you 24 hour access to the progress of our efforts on your behalf. We will post timely progress notes and other pertinent information to the RDN system as it becomes available.

The digital audio visual system records both the recovery of your collateral on camera as well as all audio conversations that might occur between the recovery agent and your customer. This record of everything that happened during the repossession is stored for a period of one year at our facility.
