Beth Applegate as Assistant Director of the Practicum Experience

We are proud to announce the appointment of Beth Applegate to the newly created role of Assistant Practicum Director to work with Practicum Director Dave Jamieson. Her role centers on continuing to develop and support the Practicum experience, with particular attention to streamlining and refining the Practicum as a key component of the 2nd year MSOD curriculum, and expanding the team of qualified Practicum Advisors.

An AUNTL graduate of Class 44, Beth is the principal of Applegate Consulting Group (ACG). Her OD practice assists national and international nonprofit organizations, government agencies and socially responsible for-profit corporations with developing human and organizational capacity and building a more just and equitable society. Most recently, ACG has been facilitating an organizational assessment and transition process with the Board and Staff of Realizing Rights: The Ethical Globalization Initiative. Realizing Rights is led by Mary Robinson, the first woman President of Ireland and more recently the former United Nations High Commissioner for Human Rights. Additionally, ACG has been with the Center for Women's Global Leadership at Rutgers University, assisting them with leadership transition, capacity building, and institutional stability through an initiative funded by the Ford Foundation.

3. Developing partnering relationship with the AU/NTL Association in obtaining Practicum sites and other enhancements of the Practicum experience.
4. Identifying ways to better integrate Practicum with learning and work of other courses in the MSOD curriculum.
5. Identifying/developing new structures & processes for strengthening the Practicum experience
6. Helping reduce the common problems students have with practicum experience and supporting their further competence development
7. Serving as an internal or external representative for the Practicum, in the absence of the Director, as needed.
