INCLEMENT WEATHER AND FOOD REGULATION POLICY - Due to the magnitude of the Festival, it is impossible to schedule a rain date or indoor alternative site. Therefore, the Festival will run on the scheduled dates regardless of weather. Four sided tents are required per HEALTH DEPARTMENT regulations. It is the vendor's responsibility to ensure compliance with CHEROKEE COUNTY HEALTH DEPARTMENT. Please visit their website or call to ensure your compliance. ALL Food vendors will be subject to a Health Department Inspection Saturday morning. Your tent will be located on pavement and must be weighted down securely. No stakes or post will be allowed in pavement. The tents or trailers must fit within 15'x15' section. If your set-up encroaches on the next space, you will be required to pay the additional fees prior to opening for business. No tarps or plastic will be allowed. Please bring your own extension cords for outdoor use.

Registration fees are non-refundable.
