FORENSIC MEDICAL EVALUATION GROUP

The Boston University Forensic Medical Evaluation Group (FMEG) is a service for asylum seekers and others requiring documentation of prior ill treatment. This innovative program is part of the Department of Medicine, the School of Public Health and **GLP**. It was cofounded in 2012 and is co-directed by Sondra Crosby and Elizabeth Rourke. FMEG offers evaluation and documentation of physical and psychological evidence of torture and abuse in a supportive and collaborative environment while working closely with attorneys. In addition to performing medical evaluations, FMEG is actively involved in academic work, including scholarly publications and advancing the field of torture documentation. FMEG teaches students (medical, law, and public health), medical residents, physicians, lawyers, and judges.

In the past year, Dr. Crosby has taught medical forensics and has implemented the Istanbul Protocol for physicians in Kyrgyzstan, Kazakhstan, and Tajikistan. Dr. Crosby has also traveled to Reyhanli, Turkey to conduct training on effective medical documentation of alleged torture and to mentor Syrian physicians. In Istanbul, Turkey, Dr. Crosby trained physicians from the Middle East and North Africa (MENA) region on medical documentation of torture.

MEETING ON MEDICAL ETHICS AND HUNGER STRIKES IN U.S. AND MILITARY PRISONS

On April 8, 2013, medical and legal experts attended a meeting on "Medical Ethics and Practice Challenges of Hunger Strikes in U.S. and Military Prisons" at the Institute of Medicine in Washington, D.C. The meeting was cosponsored by **GLP** and The National Academies' Committee on Human Rights. The experts discussed the ethical and legal challenges faced by medical and psychological professionals in providing care for prison hunger striker. Clinicians have a responsibility to care for their patients yet lack the authority to do so in the prison setting. While hunger strikes do not occur as frequently outside of the prison system, the group found an overall lack of clear regulatory policies to provide care for competent prison hunger strikers. The experts also focused on the relationship of the clinician and the patient hunger striker. In the eyes of the hunger striker the role of a clinician is often filled with uneasy trust, and a physician who authorizes force feeding becomes a guard like figure. Physicians need to establish trust with the hunger striker.

Discussions focused on the Guantanamo military prison and identified a path to improve care for prisoners. Key steps to move forward include collecting data on hunger strikers; review best practices for clinicians; increased professional support for clinicians in the correctional system; and developing an education strategy for training physicians who work in prisons.

HEALTH AND HUMAN RIGHTS IN A CHANGING WORLD



EVENTS

Pike Lecture

On October 15, 2012, Boston University Schools of Law and Public Health co-sponsored the 9th Annual Health Law Pike Lecture on "The Least Bad Death? Marcia Angell, a senior lecturer in the Department of Global Health and Social Medicine at Harvard Medical School and former editor-inchief of the *New England Journal of Medicine* urges Massachusetts voters to vote yes on question two in the November 2012 election. This ballot question sought to import the "Death with Dignity Act" to Massachusetts after successful voter initiatives in Oregon and Washington. Dr. Grodin provided commentary opposing passage of the measure. The ballot question was defeated by a margin of 51 to 49 percent.

Commercial Surrogacy in India

On April 22, 2013, GLP, Our Bodies Ourselves, and The Health and Human Rights Caucus sponsored screening and discussion of the film "Can We See the Baby Bump Please." Commissioned by the Sama Resource Group for Women and Health in New Delhi, the film explored current ethical challenges posed by commercial surrogacy in India. Sarojini N., the director and cofounder of Sama, discussed the organization's recent research on surrogacy practices, as well as strategies to address problems such as the exploitation of women hired to be gestational mothers. A women's health advocate and researcher for more than 18 years, Sarojini writes and speaks extensively on reproductive and medical technologies.

Genocide in Bosnia: Sarajevo in 1990s

On April 23, 2013, GLP co-sponsored "Genocide in Bosnia: Sarajevo in the 1990s", a screening of "In the Name of the Sun," followed by a panel discussion on *War, Health, & Human Rights.* Harun Mehmedinovic, a Bosnian born filmmaker, photographer, and founder of the "Bloodhoney Project," shared his story of living in war-torn Sarajevo during the genocide in Bosnia in the early 1990s. Dr. Grodin discussed his experiences caring for survivors of torture and their families.

INTERNATIONAL SEMINAR IN HEALTH LAW AND BIOETHICS

On July 25, 2013, George Annas and Wendy Mariner will participate in the 4th International Seminar in Health Law and Bioethics, "Health Law and Bioethics in an Aging Society" at the University of Reading (Reading, England). This seminar is organized and sponsored by, the National School of Public Health of the New University of Lisbon, the Department of Health Law, Bioethics & Human Rights of the Boston University School of Public Health, the University of Reading School of Law, and GLP. The seminar will examine legal and ethical problems in providing health care for an aging population.
