2013 Was a Great Year for:

Growing!

- With a rare snow storm on May 2nd the garden got off to a slow start. But with ample moisture it took off again this year. It was a very good year for tomatoes, peppers and tomatillos.
- All plots were leased by the second week of March, and, as in 2013, the wait list was more than 50 people long for 2014.
- Over 50% of the gardeners were returnees from the 2012 season and two gardeners upgraded to the larger plot size. Twelve of the returning gardeners were from the 2011 inaugural year.
- The garden was certified as a Monarch Waystation. Monarch Waystations provide milkweeds, nectar plants and shelter for monarch butterflies throughout their lifecycle. The garden has four varieties of milkweeds and a host of other butterfly-friendly plants to support the conservation effort. In return, Monarchs, which are pollinators, are a useful asset to the garden.

Supporting Our Community!

- ❖ 250 pounds of produce was donated to local area food pantries an increase of about 20 pounds over the previous year. The Grace Garden plot a project of the environmental ministry group within the Grace Covenant Presbyterian Church, provided 150 pounds of this total. All of the produce grown in the Grace Garden was donated to the Valley View United Methodist Church's "Hope Chest" food pantry, which is the closest pantry to underprivileged Overland Park residents
- The gardeners rallied to provide fresh veggies to a refugee family that was just getting established in the area.
- The garden sponsored a seminar on building healthy soil specific to the Kansas City area. Twelve gardeners enjoyed the presentation by Master Gardener Kathy Hoggard, who gave us the dirt on dirt! Kathy, a member of the Master Gardeners of Kansas City speaker's bureau, was gracious to share her knowledge with an organization outside her usual service area.


President's Note (continued)




