# A Message from the President

You may have noticed a new vitality in our club. I am pleased with what your leadership is planning, undertaking and completing. We recently had a successful event in Sun City at Magnolia Hall. Jack Rabbitt's presentation was outstanding. It provided our members a bonus program, and we attracted many nonmembers. The community benefitted, and we received a great deal of publicity. **We need volunteers!** To continue our excellent programs we need you! If you can give the club one day a month or one day a year, let us know. We'll find a place for you.

Recently, our logo was discussed. The use of the "Battle Flag" of Northern Virginia came under scrutiny as a result of the mass shooting in Charleston and the subsequent call for the removal of the flag from the Capitol building in Columbia. Our logo will display the first Confederate flag, "the Stars and Bars." The square "Battle Flag" has been co-opted by minority groups that we do not wish to be associated. As a club dedicated to understanding and studying the Civil War without prejudice, we will stand by our logo with "Old Glory" and the "Stars and Bars." We will also honor the "Battle Flag" for what it represents, the valor, suffering and death of an estimated 620,000 casualties — North and South. The article appeared in the weekend edition of the *Wall Street Journal*. Davis will speak to the LCWRT on Feb. 10, 2016 - "Reluctant Hero: Lee's Last Years.")

# Sun City Community Theatre - "Women and the War: 1861 – 1865"

Wars are most frequently viewed through the eyes of men. Often overlooked in the greatest of human dramas are the roles of the woman. Immediately following the Civil War and continuing to the present, day, many diaries, journals and memoirs of both Northern and Southern women have been published. Some were written with the goal of publication in mind while others were meant to serve as a record to be shared with family. Some writers had to be persuaded by family and friends to preserve their writings. All of the words in this dramatic one-act piece were derived from the diaries of 20 Northern and Southern women. They portray events of the Civil War and the impact of those events on the lives of these women. (Our thanks to Playwright, Bobby Funk, Consultant, Darcy Martin, and Director, Jan Fierick.)

# The Palmetto Quilt Guild

The Palmetto Quilt Guild has over 150 members. Some of the members have quilts made during the Civil War. Other have quilts using replica fabrics in patterns of that period. They like to share their passion for history by displaying their quilts, believing it brings history to life. Their representatives will talk about how the women quilted, and how quilts were used, and I share their Civil War stories.

Julie Rittmeyer has an antique "Crazy Quilt" bought at auction in N.Y. A miniature "Flying Geese Quilt," is a copy of one in the Margaret Strong Museum, Rochester, N.Y. that was possibly a signal quilt used in the Underground Railroad. The quilt was a signal to follow the direction of the flying geese as they migrated north in the spring. The quilt would have been used as a guide for water, food and places to rest

"Gullah/Geechee Slave Quilts" used designs brought from West Africa such as the "Box Pattern Quilt" used on horse armour. The "Red Bird Quilt" held religious significance, and the "Scissors Quilt" was used during childbirth to ease the pain of labour. The "Mourning Quilt" was used on beds for one or two years when a loved one was lost during the War. Quilts could offer some small comfort in the times of grief. The black and grey colors were displayed for one year with tan and browns used the second and third years. With so many men lost, nearly every family was in morning. There will be a legendary sampler "Dear Jane Quilt" comprising 169 five-inch square blocks, an "ERA Quilt," a "Christmas Quilt," and a patriotic "13 Star Flag Quilt" commemorating the original 13 Colonies. There are two rare quilts. Eileen Joyce, the great granddaughter of Private Michael Ryan, who was in the D-Day (Invasion of Normandy), will display a WWII memorial quilt with information regarding the life of Pvt. Ryan. Pam Rubinos has a quilt passed down from Jean Winchester Hart. Hart's grandfather, John Winchester, a U.S. Merchant Marine, quilted as a hobby.

# Courageous Women Passing as Men in the Civil War

"*I am as independent as a hog on the ice.*" - Pvt. Wakeman aka Sarah Rosetta by Caroline Wallace Kennedy

**Mollie Bean**\* from North Carolina masqueraded as a man joining the 47th North Carolina, a unit of the Confederate army. She was captured in uniform by Union forces outside Richmond, Va., on the night of Feb. 17, 1865. According to *North Carolina Troops 1861-1865 – a Roster, vol XI*, she may have fought at the Battle of Gettysburg. (\*Mollie Bean's true identity remains unknown.) The *Richmond Whig*, Feb. 20, 1865, published this report. "A young woman, dressed in military uniform, was arrested somewhere up the Danville Railroad and sent to this city, charged with being a suspicious character. On examination of the provost marshal's office it appeared that her name was Mollie Bean, and that she had been serving in the 47th North Carolina Regiment forever two years, during which time she had been twice wounded. She was sent to Castle Thunder (Richmond's wartime prison), that common receptacle of the guilty, the suspected, and the unfortunate. This poor creature is, from her record, manifestly crazy. It will not, we presume, be pretended that she had served so long in the army without her sex being discovered."

**Elizabeth "Lizzie" Compton,** a fourteen-year-old Canadian, served in the 11th Kentucky Cavalry in 1863, the 125th Michigan Cavalry, and six other regiments. She became known as "Jack" or "Johnny," and was wounded by shrapnel to her side while fighting in Greenbrier, Tenn. When doctors at a hospital in Lebanon, Ky. peeled away her blue uniform, she was discovered to be a woman and discharged from the service. She reenlisted in and was found in six more regiments, serving a total of 18 months in the Union army.

**Mary and Mollie Bell**, two young farm cousins who fought for the Confederacy as Pvts. Bob Martin and Tom Parker. They enlisted in a cavalry regiment under the command of Confederate Gen. Jubal Early. Serving for two years, they earned the respect of the other soldiers for their bravery. A regimental historian of the 36th Virginia reports that while on picket duty, "Martin" killed three Yankees and was promoted to Corporal. "Parker" had been promoted to Sergeant. At Belle Grove, The Battle of Cedar Creek, Oct. 19, 1864, their captain (in whom they had confided) was captured. When they told the lieutenant who took command, he turned them into Gen. Early. Early admitted there were at least six other women in his army. Early put them on a train to Richmond where they were incarcerated for three weeks in Castle Thunder Prison falsely accused of being prostitutes. In late Nov. 1864, they were released with no charges and sent home to Pulaski County, Va. in the same uniforms they wore when arrested. The *Richmond Daily Examiner* reported: ". . . sending home the petticoat soldiers."

**Sarah Bradbury** and **Ella Reno.** Bradbury enlisted in the 7th Illinois Cavalry as "Frank Morton." She served in several regiments, joining the 2nd Kentucky Cavalry as an orderly in Gen. Philip Sheridan's escort. She became acquainted with **Ella Reno**, who was serving as a teamster. The two got drunk on apple cider while on a foraging expedition in Kentucky and fell in the river. After their rescuers had discovered they were women, they were called before Sheridan. Writing in his memoirs, Sheridan mentioned them as "she dragoons." He wrote: "The East Tennessee woman (the teamster) was found in camp, somewhat the worst for the experiences of the day before, but awaiting her fate, contentedly smoking a cob pipe. The Cavalry soldier proved to be a rather prepossessing young woman. How the two got acquainted, I never learned, and though they had joined the army independently of each other, yet an intimacy had sprung up between them long before the mishaps of the foraging expedition."

# Women Were Urged to Dress Down for the Cause.

Despite an array of "Dresses to sit in, and stand in, and walk in / Dresses to dance in, and flirt in, and talk in" poor Miss Flora McFlimsey had "nothing to wear."

- "Nothing to Wear" 1857 satirical poem by William Allen Butler

On June 4, 1861, the *Staunton Spectator*, in Virginia's Shenandoah Valley, asked readers to forego frippery for the duration. The paper called on well-heeled locals who might be tempted by the fine silks shown in *Godey's Lady's Book* – the most widely read women's magazine of the day – to lead by example.

"Economy is a commendable virtue at any time, but it now becomes a patriotic duty. The people should now economize as much as possible, that they may have more means to contribute to the defense of the State, and to the comfort and necessities of our soldiers. The Revolution in which we are now engaged will demand heavy sacrifices, and we should prepare ourselves as well as possible to bear them. No money should now be expended for luxuries or mere display. We should now confine our purchases to the necessaries of life, and to such articles are of positive utility . . . The ladies should be willing to forego the pleasure of appearing in costly silks, and high-priced bonnets. The fashion should now be to wear cheap and durable apparel. . . . Who will set the example? What lady will lead in this laudable enterprise? The ladies of Staunton have as good a right to 'set the fashions' as the less worthy ladies of Paris have. - Patriotism now demands it." - cwk
