DENYING A trial date will be set for you by the court  
THE TICKET: when you call in. **You must appear at that trial date** and you will be given an opportunity to discuss your ticket.

ADMITTING TO You should pay the ticket before the court  
THE TICKET: appearance date on bottom of the ticket or a **LATE FEE of \$25.00** will be added. This can be paid by Cash, Money Order or by Credit/Debit card online (a service fee applies)

AMOUNT DUE: **Amount figured by adding a one-time fee of \$135.50 court cost to the fine(s).**

LATE FEES: \$25.00 will be added if not paid by Appearance date

PROOF OF Anyone that does not have a clear Driving Record  
INSURANCE: or has received 3 tickets within 1 year, will be notified by the BMV to complete a “Certificate of Compliance” for proof of insurance. This will be mailed to the address listed on your driver’s license. If not completed and returned, the BMV will suspend your license for a minimum of 90 days + reinstatement fee.

**YOUR FAILURE TO COMPLY WILL RESULT IN THE SUSPENSION OF YOUR DRIVER’S LICENSE UNTIL PAID IN FULL.**
