


## From the West

## MINUTES OF THE ANNUAL GENERAL MEETING HELD MAY 23 – 24, 2009

at Peter Gzowski College, Trent University, Peterborough, Ontario, Herinafter cited as AGM-09

## 1. Welcome

at 10:01am on May 23, 2009, Graham Wilkins, President, welcomed delegates to the Ontario Speed Skating Association's (OSSA) 2009 Annual General Meeting and called the meeting to order.

## 2. <u>Confirmation of Delegates</u>

Jackie Deschenes, Director of Administration, conducted a roll call of the clubs and voting delegates present. There were thirty-one (31) club delegates and three (3) voting directors. Eighteen (18) votes were needed to have a majority on any vote.

## 3. Agenda

Moved by Don Clark, seconded by Valya Roberts, that the agenda previously distributed and printed on page six of the reports package for the 2009 OSSA Annual General Meeting be approved. Motion

Carried.

## 4. Minutes – 2008 OSSA Annual General Meeting

**MOTION AGM-09-01:** Moved by Patti Pokol, seconded by Denis Bergeron that the minutes of the 2008 OSSA Annual General Meeting held on May 24 – 25, 2008 be accepted with corrections noted. Motion Carried.

The number of present delegates was revised to include thirty-two (32) club delegates and three (3) voting directors. Eighteen (18) votes were needed to have a majority on any subsequent votes.

## 5. Vice President Finance and Administration Report

Stephen Arnold presented members with the Vice President Finance and Administration Report as published on pages 20-23 of the reports package for the 2009 OSSA Annual General Meeting.

- Mr. Arnold reviewed our membership numbers and highlighted a Province wide average ratio of one
  associate member for every two competitive members which is a significant contrast to the Cambridge
  club ration of two associate members for every one competitive member. An extensive discussion
  regarding recruiting parents as active club members ensued:
  - Cambridge delegates shared that they made an effort to have each parent register as an
     Associate member to bolster the club's volunteer resources and to ensure that parents helping on or near the ice are covered for insurance reasons.
  - o Increased member numbers will improve funding levels at Provincial and National levels as well as give Ontario more influence at Speed Skating Canada (SSC) meetings.
  - It was noted that of the \$20 fee for an Associate member that is paid to OSSA \$5 goes to SSC and \$15 goes towards OSSA funded programs.
  - o In London parents do not get a vote at club meetings if they are not a paid member.

Mr. Arnold also reviewed the results of the 2008 – 2009 fiscal year audit.

**MOTION AGM-09-02:** Moved by Ray Kuntz, seconded by Valya Roberts, that the 2008 – 2009 OSSA audited financial statements for the year ended March 31, 2009 as prepared by Graham Mathew & Partners LLP, Chartered Accountants, be accepted.

## Discussion:

- It was commented that we have written down inventory before, is our inventory number now reflecting appropriate value? Yes.
- A delegate expressed some concerns regarding late registrants and would like to see OSSA work to catch errors sooner.
- The timing of the Sport for More grant and how it is to be spent was discussed
- It was noted that 17% of technical expenditures goes to elite skaters.
- Cheryl Wilson asked what made up the other technical expenses and it was explained that it includes technical committee meetings and entry fees.
- There was a discussion about receivables and ways to ensure that clubs pay debts on time.
   Motion Carried

**MOTION AGM-09-03:** Moved by Don Clarke, seconded by Doug Flynn that Graham Mathews & Partners LLP, Chartered Accountants, be appointed as the auditors for OSSA for the year 2009 – 2010. Motion Carried.

- Further Discussion derived from the financial report:
  - Kitchener—Waterloo delegates would like to know who should pay for Provincial Championship medals. Clarington commented that they ensure they put the cost of medals into the budget for the event. The board members present agreed that a policy should be created to cover this issue so that future hosts know what to expect for costs.

**MOTION AGM-09-04:** Moved by Patti Pokol, seconded by Jacky Shoebridge, that the proposed OSSA By-law amendment included as appendix A to the reports package for the 2009 OSSA Annual General Meeting be approved.

## Discussion:

 There is a concern regarding when this by-law amendment would be implemented as it would not be appropriate to elect board members for a two year term beginning in 2009 with no notice available to the membership.

Motion amended by Gerry Harrington, seconded by Ron Richards that the amendment take effect beginning with the 2010 AGM.

Amendment Carried.

Motion Carried.

**MOTION AGM-09-05:** Moved by Paul Landry, seconded by Valya Roberts, that the proposed OSSA By-law amendment included as appendix B to the reports package for the 2009 OSSA Annual General Meeting be approved.

Motion Carried.

**MOTION AGM-09-06:** Moved by Don Clarke, seconded by Beth Wismer, that the proposed OSSA By-law amendment included as appendix C to the reports package for the 2009 OSSA Annual General Meeting be approved.

## Discussion:

- The group feels that this should be very public and clear regarding the penalties.
- There is concern regarding follow through with the preventing of meet registrations, the Board members present agree that they will not hesitate to carry out that penalty if necessary.

Motion Carried.

**MOTION AGM-09-07:** Moved by Bill Allen, seconded by Marg Oliveira, that the proposed OSSA Information Manual amendment included as appendix D to the reports package for the 2009 OSSA Annual General Meeting be approved.

#### Discussion:

- There was a request that the invoicing and receipts for check in fees be more clear and consistent.
- Sanctioning has not been done properly, nor post meet reports sent. These rules must be more consistently enforced.
- Sandra Chenard suggests that OSSA reviews the SSC hosting manual for better guidelines.

Motion amended by Jacky Shoebridge, seconded by Valya Roberts that 'sanction fee' be removed from bullet c, but 'check in fees' be left in place.

Amendment Carried.

Motion Carried.

## 6. Development Report.

Jim Elliott provided an update from the SSC Club and Membership Development Committee. The update included information on the Long Term Participant and Athlete Development (LTPAD) model, The Buzz newsletter, the Inukshuk 2010 website section which will have information about the Olympics and Canada House as well as suggestions for dealing with membership inquiries generated by the Olympics, and the Festivals package that will be handed out at SSC's AGM. Mr. Elliott also discussed SSC's partnership with True Sport, what it means to SSC, Ontario and clubs. SSC would like to see 75% of clubs to declare themselves as True Sports by 2010. Development and Olympic skaters are on board. Increase awareness amongst Canadians of True Sport and speed skating.

Break for lunch.

## 7. Statistician's Report.

Klaas Hanje reported on the various records submitted for this year. There was a correction of a record for Kathy Elliott where the incorrect time had been provided. Klaas also noted that OSSA must archive all ten year age class records as now records are being kept for five year age classes which created many new records. Cindy VanLierop noted that she had a stack of new record applications with her to pass on. Statisticians report to be amended and presented to the membership by the technical committee in the fall.

## 8. Technical Report

David Stewart presented members with the Vice President Technical Programs Report as published in the supplementary hand out with the reports package for the 2009 OSSA Annual General Meeting. Mr. Stewart invited Laura Woodall to present a verbal report on the Coaching Development Committee. Ms. Woodall noted that a FUNdamentals leader NCCP context has been completed and is now ready for delivery. This would be a great course for all volunteers to take to understand it better and it should be held in the first 6 – 8 weeks of the season. Clubs should leave time in October and November for a FUNdamentals A & B course or Introduction to Competition A & B course. These courses must be held during the season, not before, as recommended from the SSC Coaching committee as it is important to apply the learning immediately. The online 'Making Ethical Decisions' evaluation requirement was pushed back due to the Coaches Association of Canada technical issues. Ms. Woodall also asked clubs to ensure that OSSA has contact information for all coaches.

**MOTION AGM-09-08:** Moved by Will Wallace, seconded by Gerry Harrington to accept the Technical report as presented.

Motion Carried.

The 2009 Annual General Meeting was adjourned at 1:50pm on Saturday May 23<sup>rd</sup>, 2009.

The 2009 Annual General Meeting was reconvened at 9:15am on Sunday May 24<sup>th</sup>, 2009.

The number of present delegates was revised to include thirty (30) club delegates and three (3) voting directors. Seventeen (17) votes were needed to have a majority on any subsequent votes.

## 5. <u>Vice President Finance and Administration Report – continued.</u>

Review of membership and competition fees annex distributed.

**MOTION AGM-09-09:** Moved by Gerry Harrington, seconded by Scott Spencer that the fees annex be accepted as distributed (see appendix F).

Discussion:

- We must ensure these fees enough to cover insurance increases.
- o Perhaps we can build up a better reserve with a \$5 per person fee.
- The group is concerned that the check in fee is too low.

Motion amended by Patti Pokol, seconded by Desmond Preudhomme that the maximum entry fee for a meet be increased to \$60. Amendment carried.

Motion amended by Don Clarke, seconded by Patti Pokol that the check-in fee be changed to \$4. Amendment carried.

Motion amended by Lianne Franklin, seconded by Marg Oliveira that the maximum entry fee for a one day meet be \$50. Amendment carried.

Motion carried.

## 9. President's report.

Graham Wilkins presented members with the President's Report as published in the reports package for the 2009 OSSA Annual General Meeting. Mr. Wilkins identified a need for more volunteers at the Provincial level and at the request of delegates present will ensure that a job description and information regarding the time commitment would be made available to the members.

**MOTION AGM-09-10:** Moved by Denis Bergeron, seconded by Cindy VanLierop that the club reports be accepted as presented.

## Discussion:

- There is clearly a need for all types of clinics across the Province.
- The new format used this season is good, makes the comments easier to read.

Motion Carried.

**MOTION AGM-09-11:** Moved by Will Wallace, seconded by Ray Kuntz to thank Lori Lytle and Jackie Deschenes for their work in the OSSA office.

Motion carried.

SEED Lite is an SSC grant awarded to clubs from a random draw held at the SSC AGM. Ontario has five entries and randomly drew Clarington, Kitchener-Waterloo, London, Portland and Sudbury as OSSA's entries for the 2009 grant.

**MOTION AGM-09-12:** Moved by Will Wallace, seconded by Ray Kuntz to accept the reports of the board of directors as presented.

## Discussion:

- Sandra Chenard commented that as a member that it's a disappointment that not only are two of our Vice Presidents absent, but they were not even able to provide written reports.
- Dave Clements would like to see minutes from the technical meetings made available.

Motion Carried.

Viewed Ontario Speed Skating Oval video. Members were interested in the cost of the video and the opportunity for OSSA to have one created. One is already in the works for OSSA, Markham mentioned that they have some video clips that may be of use. There was also a discussion about the rock face issue at the Oval in Lakefield and safety concerns at meets. There may be an opportunity borrow the Peterborough club's mats if needed.

## 10. New business:

• Doug Flynn presented a starters expenses proposal as per Appendix E.

**MOTION AGM-09-13:** Moved by Doug Flynn, seconded by Denis Bergeron that clubs pay starters \$50/meet. Discussion:

- Gloucester already covers starters expenses.
- Jacky Shoebridge indicated that all officials need more consideration for expenses, it should be a standard thing and a part of a meet host package that technical committee creates to let meet coordinators know that this is an expense that they should be considering.
- Where do we draw the line? Timers need big boots and mitts.
- Gerry Harrington feels that with a competitive market that meets need to make it attractive for volunteers and offer what they need to do the job so they will come do your meet.
- Cindy VanLierop stated that when she needs something she asks for and receives it.
- Peter Wright is concerned that we are micromanaging, let the volunteers step up and let clubs know what they need and what they don't and not mandate the expenses.
- The Technical committee acknowledges that they need to put out information/recommendations on these expenses and will ensure new clubs are aware of the different expenses that are out there as they may not realize what they are.
- Denis Bergeron believes that it's simple, if people are willing to do their time, don't take advantage of it. If you are willing to give your time then you should not be paying for expenses out of your pocket either, but definitely not making money.
- Peter Wright suggests that we be careful to maintain a balance between what's a volunteer and what's not, because as soon as you start to pay one volunteer you are disrespecting the others.

## Motion Withdrawn.

- Cindy VanLierop introduced a discussion regarding helmet covers:
  - This issue was submitted to Technical Committee, who asked her to bring it to this meeting.
  - Current covers are no longer viable.
  - Each club is responsible for buying a block of numbered helmet covers and then assign a helmet cover to each skater. It's the skater's responsibility to have it with them as part of their equipment.
     Keep the same number for their career.
  - There must be a small supply of extra helmet covers for the meet coordinator, there is a rental fee for the kid who needs it because they don't show up with theirs.
  - The purpose is for no one to have to lug around the helmet covers, eliminate the time for the meet coordinators to sort, organize and assign and then collect them back in, etc.
  - Sanction rules prevent having helmet covers for only numbers 1 6, each skater at a meet must have a unique number. Non-unique numbers cause many problems for judges, difficult for photo finish software.
  - O Why did we move away from this system?

- Covers ended up in poor repair.
- There was a concern that there was a bias against specific numbers.
- Cindy suggests that OSSA buys 999 covers and then sell them to the clubs, but it doesn't matter if they are sequential.
- o Helps club to have a set of covers for a mini-meet.
- Cost would be about \$9 each for 150 200 of them. OSSA will not make a profit on this.
- What do you do with retiring skaters? Get the helmet covers back.
- What if skaters switch clubs? The skater takes their number with them.
- OSSA must make sure we have relay helmet covers.

**MOTION AGM-09-14:** Motion by Cindy VanLierop, seconded by Beth Wismer, that OSSA purchase helmet covers to re-sell to the clubs at cost so they may be issued to skaters for their career as Ontario skaters. Motion carried.

- Will Wallace would like the Technical Committee to consider club relays at ability meets, Mr. Stewart notes
  that they are considering it and will provide guidance to the meet coordinator. Perhaps some meets will
  have a couple of club relays and a couple of straight relays. Mr. Wallace would like this to occur because
  at ability meets relays aren't happening.
- Clarington would like to see OSSA revamp AGM packages. Mr. Wilkins encouraged all clubs to provide any feedback they may have on the AGM to the office in the coming weeks.
- Gerry Harrington inquired about the Regional Training Center program. OSSA is involved, but the program is on hold until February. Currently there are no events planned this summer under the RTC banner. Mr. Wilkins mentioned that Ontario is keen to find a way to provide our athletes an alternative to going to Calgary or going to Quebec. The onus is on us to ensure that it's inclusive for all athletes. It is also important to ensure that any assets are tracked and ownership of them is clear.

**MOTION AGM-09-15:** Moved by Marg Oliveira, seconded by Dennis Duggan that OSSA adopts the principles of the True Sport Movement.

Motion Carried.

- Marg Oliveira believes that the electronic timing system owned by OSSA is an issue. Hugh Morrison may not be available in the future is there a legacy plan in place? We need to ensure that there are people to learn to set it up, use it and maintain it. The Board has been trying to get someone trained, but are having some challenges with that. Technical committee will work with Hugh Morrison to ensure that someone is trained. A couple of Belleville people may be trained next season.
- Peter Wright revisited the conversation about associate members to determine what the club's commitment level is with this initiative?
  - o Cambridge did not give parents a choice, nor did London.
  - Kitchener will be putting it at their next meeting, there is a clause that they must do bingos, now there will be a clause that they must be members too.

- Jacky Shoebridge says there's a problem with volunteers and not knowing who is registered and who's not.
- Clarington will be doing this.
- The group would like to ensure that this is being carried out for the right reasons, not to pad our numbers.
- Dave Ord believes that if you are not an associate member you should not have a vote and make parents aware of that.
- Valya Roberts asked that clubs share policies etc. so that no one has to re-invent them. OSSA will
  work to provide a template and will be applying for funding to help build capacity and put
  administrative items in place.
- When sharing coaches make sure people who should be registered are, check with your neighbours.

**MOTION AGM-09-16:** Moved by Peter Wright, seconded by Valya Roberts that all clubs ensure that all parents register as affiliate members. Motion defeated.

Doug Flynn suggested that clubs who are affiliated with their city, town or municipality review their third
party insurance coverage and liability as some insurance carriers are changing their clauses

## 11. 2009 – 2010 Board of Directors

All current members of the board allowed their names to stand for re-election. No nominations were received for any positions for the Board of Directors. Luanne Lee-McNabb, Chair of the Nominating Committee, explained the procedure that would be followed confirm the candidates for the 2009 – 2010 season via email. The Board of Directors was ratified by way of a separate online vote for each position. The number of club delegates eligible to vote to acclaim the Board of Directors was thirty-three (33). Nineteen (17) votes were needed for a majority.

**MOTION AGM-09-17:** Moved by Luanne Lee-McNabb, seconded by Chris Coons to accept Graham Wilkins – President, Stephen Arnold – Vice President Finance and Administration, David Stewart – Vice President Technical Programs, Damian Brown – Vice President Marketing, and Steven Beattie – Vice President Club and Membership Development as the Ontario Speed Skating Association's Board of Directors for the the 2009 – 2010 season.

Motion Carried.

## 12. Adjournment

**MOTION AGM-09-18:** Moved by Don Clarke, seconded by Cheryl Wilson to adjourn the meeting at 11:45am on Sunday May 24<sup>th</sup>, 2009.

## Appendix A – By-Law Amendment: Director Two-Year Terms

**Rationale**: The model for this change is Speed Skating Canada's By-law where an election of one half of the Board is held each year. The proposed amendment to OSSA's By-law provides a better guarantee of administrative continuity which is important for OSSA's long term health.

## **Article 9.03.1**

## **Existing Article**

The Voting Delegates at the Annual Meeting shall elect the Directors and officers of the Association for the ensuing year save and except or another individual who is ex officio a Director and save and except the Secretary of the Association.

## **Amended Article**

The Voting Delegates at the Annual Meeting shall elect the Directors and officers of the Association save and except an individual who is ex officio a Director and save and except the Secretary of the Association. Directors are elected for a two-year term. In odd years, the President, the Vice President Technical Programs Administration and the Vice President Marketing are elected. In even years, the Vice President Administration and Finance and the Vice President Development are elected.

## Appendix B – By-Law Amendment: Nominating Committee Responsibilities

**Rationale:** The proposed amendment clarifies the responsibilities of the Nominating Committee including a confirmation of the applicability of Article 7.09.2, i.e., "The results of the poll vote or ballot shall be recorded in the minutes of the Meeting of Members."

## Article 12.06

## **Existing Article**

The Nominating Committee shall:

- a. prepare a list of candidates for vacant offices;
- b. accept any written nominations for elected offices;
- c. make recommendations to the Board of individuals to fill vacancies in the offices, on the Board, or on any committee.
- d. The members of the Committee shall consist of three Ordinary members of the Association appointed by the Board subsequent to the Annual General Meeting (AGM) but in any event not later than the January 31st following the AGM.

## **Amended Article**

The Nominating Committee shall:

- a. Consist of three Ordinary members of the Association appointed by the Board subsequent to the Annual General Meeting (AGM) but in any event not later than the January 31st following the AGM,
- b. Prepare a list of candidates for vacant offices,
- c. Accept any written nominations for elected offices,
- d. Make recommendations to the Board of individuals to fill vacancies in the offices, on the Board, or on any committee,
- e. Conduct by ballot the Election of Directors, and,
- f. Record the results of the ballot in the minutes of the meeting.

## Appendix C – By-Law Amendment: Nonpayment of fees

**Rationale:** Non-payment and delays in the payment of fees has consequences for both individual members and clubs. The final notice to be issued by an officer of the Association ensures that the member or club involved is duly informed before membership benefits are revoked.

## Article 16.06

## **Existing Article**

If annual memberships, dues, other fees or special assessments are not paid by a Member within thirty (30) days of a notice of non-payment being given by the Secretary or Executive Director, the membership of such Member shall thereupon automatically cease but upon payment of all unpaid fees plus a penalty assessment (not to exceed 25% of the fees so payable as determined by the Board), any such Member shall be reinstated.

## **Amended Article**

If annual memberships, dues, other fees or special assessments are not paid by a Member or Affiliated Club within thirty (30) days of a notice of non-payment being given by the Secretary or Vice President of Administration and Finance, the Member or Affiliated Club shall be declared to be not in good standing and ineligible to receive membership benefits. However, upon payment of all unpaid fees plus a penalty assessment (not to exceed 25% of the fees so payable as determined by the Board), any such Member or Affiliated Club shall be reinstated.

# Appendix D – Information Manual Amendment: Definition of Season and Membership Fees Due Dates

**Rationale:** This amendment makes the definition of a season consistent with the change made last year in Speed Skating Canada's By-Law. The amendment also makes clear when the prescribed fees are due and the subsequent period of membership benefits.

## **Article A6: Membership Dues**

## **Existing Article**

A6.01 The annual membership dues shall cover the period from January 1 to December 31 of each year.

A6.02 Each affiliated club is responsible for the collection of membership dues from its members and for the transmission of the portion thereof applicable to the Association membership (and the portion thereof applicable to SSC membership, if the Association acts as intermediary) to the OSSA office or the Vice President Finance and Administration together with the prescribed forms.

A6.03 Each affiliated club shall pay the appropriate membership dues to the Association, in advance, on or before December first of each year. (i.e., 2006 fees are due on December 1, 2005.) Any person who joins thereafter shall pay such dues at the time of registration.

A6.04 No skater shall participate in an event sanctioned by the Association unless his/her dues have been paid and a membership number assigned to him or her.

## **Amended Article**

A6.01 A season begins April 1st of any given calendar year and shall last until March 31st of the following calendar year. Membership paid in one season expires on December 31st of the following season.

A6.02 Each affiliated club is responsible for the collection of the fees, dues and special assessments detailed in Annex A4 and for the transmission of these fees to the OSSA office or the Vice President Finance and Administration and for registration of members on the Speed Skating Canada (SSC) database.

A6.03 Each affiliated club shall pay to the Association the appropriate fees and special assessments detailed in Annex A4 as follows:

- a. Club fees (Affiliation and liability insurance) by December 1,
- b. Membership fees (individual and family fees) within 60 days of registration on the SSC database but no later than March 31, and,
- c. Competition fees (sanction and check-in fees) within 30 days of the last day of the competition.

A6.04 No skater shall participate in an event sanctioned by the Association unless his/her membership fees have been paid and the individual has been registered on the SSC database.

## Appendix E – Starter Expenses

#### **PURPOSE:**

To assist the official starter with their personal costs while working a competition

#### PROPOSAL:

It is proposed that each club hosting a competition will subsidize the costs to the starters for materials used to work a given competition. The host club should also make arrangements to cover the costs for accommodations for the starters, provided they require same, if not already being taken care of either by billeting or club policy to do so as with other officials.

#### **COST STATISTICS:**

The purchase of a 22 cal pistol is approx \$200.00 to \$300.00

With proper care would last many years. Each starter should have 2 guns

Gun cleaning solutions & tools - \$25.00 to \$30.00 - should last a couple of years

Other items required are earplugs, whistle, case to store items for travel, and arm bands.

On going costs are shells for gun - cost \$10.00 per box of 100- depending on size of meet - whether it is a 1 or 2 day meet a starter could go through 300 to 500 shells per competition.

If a starter works 6 meets per year, his /her cost would run approx \$275.00 for the season.

starters also have the cost of accommodations (especially at 2 day meets) at an approx cost of \$125.00 per night plus travel (gas).

#### MOTION:

The motion is that each club would set aside in their meet budget an amount of \$50.00 per starter used at the competition. (usually 3 x 50 = \$150.00) plus accommodations if needed. The \$50.00 would be paid to the starters at the end of the meet. The \$50.00 would cover ammunition costs and possibly some gas costs.

## **REPORTS**

## **PRESIDENT**

Once again this year the many hours spent by volunteers and the parents across Ontario were rewarded by the accomplishments of our skaters. From the junior skaters who made the National Junior Team and medalled at World Championships, to Masters skaters who not only achieved great results but also showed by their example the life long benefits of speed skating. We saw a number of Ontario skaters make the difficult step of being named to one of Canada's National Development Teams. And each weekend at Ability meets, Ladder Races and O Cups skaters of all ages were improving their skills and enjoying being involved in speed skating. And of course every member experienced the excitement of watching the Olympics and feeling a connection to all the Canadian skaters and especially to Ontario's own two skaters. Kristina Groves learned to skate in Ottawa while Christine Nesbitt was a long time member of the London Club. There are many volunteers from across Ontario who played a role in helping these great skaters over the years and an event like the Olympics gives extra meaning and satisfaction for the time and effort that is spent by all the volunteers across Ontario.

There were successes this year off the ice as well. At this year's AGM we welcome the new club from Bancroft that was formed over the past season. The total number of OSSA members grew again this year thanks in part to the initiative recommended by Cambridge at last year's AGM and embraced by many clubs. The number of parents and volunteers who registered as Associate members increased dramatically this season and this will help our Association's on going effort to attract additional government support.

The government sponsored High School Program involved seven clubs this season and brought 113 new recreational High School members into the Association. The program also involved a new group of volunteers who helped run the program as well as number of younger members who participated in the Fundamental Leadership course and then had their first opportunity to coach.

The enormous effort by the many volunteers who organize all the races across Ontario is a great accomplishment in itself and this season a special thanks goes to the two Ottawa clubs who hosted both the long and short track Provincial Championships. This season OSSA skaters, coaches and parents had an opportunity to participate in the Ontario Winter Games and a special thanks goes to the Sudbury Club for being the host for the competition.

Sound administration of our Association's business has allowed OSSA to maintain a breakeven policy, posting a positive balance over the past four years combined. The solid financial position allows OSSA to continue to provide financial support for our Development and Training Team athletes. OSSA was also able to help cover the expenses of the volunteers who coach and manage the athletes who represented Ontario at record number of competitions across Canada this season.

Establishing a reputation for good management is an important element in the process of acquiring the maximum amount of support from the Sports Alliance of Ontario and the Ministry of Health Promotion. Our members owe the staff members directly responsible for conducting OSSA's business, Lori Lytle and Jackie

Deschenes, a special thanks for another successful year. Bill Allen joined OSSA's staff under a six month contract during the fall and winter and assisted in the management of the High School Program.

Many OSSA members had an opportunity to participate in SSC's Coaching Symposium in Richmond, B.C. thanks to funds provided by OSSA and SSC. The meetings in Richmond provided our clubs with a better understanding of the program for Long Term Participant and Athlete Development. Speed Skating remains a leader of this initiative in Canada and in November I joined a weekend long session of Branch Presidents and SSC Committee members in an effort to work out some of the practical changes that need to be made to realize the benefits of the LTPAD program.

Our Association has made efforts, during the past few years, to implement some of the LTPAD principles in the organization of our competition rules and schedule. The LTPAD initiative is now moving from being a set of guiding principles to being changes that will result in a new competition schedule, different age categories and differences to the way each Branch will be asked by SSC to run their races.

Time will be spent at this year's AGM conducting an open discussion on the LTPAD driven changes we can expect to see in the coming season and in particular to examine the recent competition changes that have been recommended by the SSC Competition Committee. Our Association can benefit if we are willing to be proactive in our reaction to the recommendations we receive from SSC and can we continue to work together to develop some 'Made in Ontario' solutions.

The AGM will also be the time to continue the process of developing a Long Term Plan for our Association. Following last years AGM the Board agreed on the wording of a draft Long Term Plan that was sent to the clubs and members. To become a useful tool the LTP has to reflect the goals and aspirations of all our members so comments and suggestions on how our Association needs to change are very important. This year's AGM package includes the latest draft of the Long Term Plan along with a review of the comments and suggestions I have received directly from members as well as the issues that were raised at the Presidents meeting that was held in April. The responses to the recent OSSA Survey are also summarized in your AGM package.

Finally I want to thank all of the coaches, club volunteers and skaters whose effort and enthusiasm for speed skating continue to make being OSSA President such an honour. Your dedication and passion for speed skating inspires me to represent your interests to best of our ability and I have been very grateful for the opportunity to contribute over the past year.

## VICE PRESIDENT FINANCE AND ADMINISTRATION

## **Financial Statements**

The financial statements for 2009-2010 reveal an excess of expenses over revenues, i.e., a deficit. The reason is quickly revealed. Merchandise gross profit was only \$14,852, less than half of the profit of the previous three years and well below the \$39,000 budget target (Chart 1).




CHART 1: MONTHLY CUMULATIVE GROSS PROFIT BY SEASON (2009-2010 BUDGET IS \$39,000)

Gross profit was down because the sales of OSSA merchandise were also less than half of previous years and also well below a \$98,000 budgeted sales goal (Chart 2).





CHART 2: MONTHLY CUMULATIVE SALES BY SEASON (2009-2010 BUDGET TARGET IS \$98,000)

Sales and gross profit would have been even lower had it not been for the sale of \$20,685 of skates and helmets to the high school program financed by a Sport for More grant from the Ministry of Health Promotion.

A similar boost in sales and gross profit was experienced at the end of previous year as is quite evident in Charts 1 and 2 for the 2008-2009 fiscal year. During this period, a \$37,500 purchase of skates for the high school program was also financed by the Sport for More grant.

The drop in merchandise gross profit is part of a longer term trend. As revealed in Chart 3, merchandise gross profit has been falling for at least the past five years. Fortunately, the third and final year of the MHP Sport for More grant will be available to purchase more equipment and thereby impact positively on gross profit.

Chart 3 also reveals that the base grant from the Ministry of Health Promotion has been falling steadily for at least the past six years. In 2003-2004, OSSA received \$145,260. By 2009-2010, the grant had fallen to \$69,008. Furthermore, another 15 percent reduction of \$10,000 in the MHP base grant is expected for 2010-2011.

Gross profit and the base grant have fallen by a total of \$155,000 between the 2003-2004 and 2009-2010 fiscal years. This difference amounts to a 74 percent reduction.

The third major revenue source for the Association is membership fees. This revenue source is comprised of club affiliation, club insurance and individual membership fees. Fortunately, it has risen from \$62,000 to \$120,000 over the past six years, a 95 percent increase due to both fee increases as well as a larger total membership. The current membership figure of 2,319 members represents a 71 percent increase from 2003-2004.

Totaling the three revenues sources reveals a net decrease of \$97,000 over the past six years.

Additional comments can be made about the financial statements. VP Finance and Administration costs were up by about \$14,000 primarily due to a significant increase in audit and legal fees. Significant legal fees were incurred in the ongoing adjudication of the 2006 human rights complaint made against the Association and its Board members. A second legal cost was incurred in the mediation of a member versus club conflict. On the

positive side, telephone, internet and website costs were reduced by about \$2,500 thanks to cost savings initiatives made by the Executive Director.

The financial statements show a significant decrease in Ontario Trillium grants. These grants have been obtained in the past by clubs that are required to pass the funds through the OSSA books because they are not incorporated. Hence, the VP Development costs are also down by a similar amount.

The Sport for More grant was obtained by the President and Executive Director beginning in the 2008-2009 fiscal year. It has so far paid out \$107,000 with a final installment of \$67,000 expected this year. It is not only bringing to the Association a significant amount of new equipment. It also covered the costs of ice time and other miscellaneous costs for seven clubs so they could run introductory skating programs. Six months of a third staff person were also covered by proceeds from the grant.

The VP Technical expenses are significantly down from previous years. Similar to the Trillium grants, there was no flow through this year of Calgary Oval fees and expenses. Last year, the fees and expenses each amounted to \$35,000. A real reduction of \$6,000 in travel expenses was recorded by coaches and managers attending out-of-province championships. Technical committee teleconferencing and travel costs were also down by about \$2,500 as were expenses associated with coaching clinics and other officials expenses. Expenses from the provincial and development teams were consistent with the previous year.

Despite the operational deficit, the financial position of the Association has not changed significantly from the previous year. One exception is the 48 percent significant reduction to \$22,000 in accounts receivable, the result of ongoing Board and staff actions to carefully manage and follow-up on this "current" asset. Two years ago, the corresponding accounts receivable balance was \$61,000.

From a financial planning and management perspective, there are a couple of outstanding issues to be resolved by the Association. The first issue is the role of merchandise sales as a future source of significant revenue. In the absence of any specific initiative, sales have steadily drifted downwards and will be propped up by the Sport for More high school grant for the last time in the 2010-2009 fiscal year.

A second issue is to determine the actions to be taken in coming years as the Ministry of Health Promotion base grant slides downwards in 15 percent decrements to the expected \$30,000 range. Fee increases is one answer and to this end, delegates at the 2010 AGM will be asked to approve a revised fee structure. Other revenue sources are grants, sponsorships, lotteries and the many other fundraising initiatives familiar to every club executive. If revenues aren't maintained, programs and other costs evident on the financial statements will need to be cut.

## **OSSA Financial Health**

The total value of the operating fund and the four special purpose funds is \$106,000. This figure represents the net worth of the Association given that it also equals assets less liabilities. This number is also up by about 5 percent from the 2008-2009 year when we concluded that the Association was in a healthy financial situation. We would come to a similar conclusion for the 2009-2010 fiscal year.

## VICE PRESIDENT TECHNICAL PROGRAMS ADMINISTRATION

The 2009-2010 skating season saw a competition format that included minor changes to the 2008-2009 format and overall seemed well received by the membership. Of note is the significantly reduced number of complaints received regarding the format in comparison to the seasons previous.

The major change made to the competition format for the 2009-2010 season was the move to have the PeeWee age skaters removed as an age group from the Ontario Cup ST series and Provincial ST Championships. This change was made in light of OSSA's continuing efforts to move to meet the intent of Speed Skating Canada's Long Term Participant and Athlete Development Model which stresses age and physical development appropriate competition and skills development. The change also allowed other age groups to be increased in number without increasing the maximum number of skaters at an Ontario Cup which further supports some of the fundamentals underpinning the LTPAD.

The change to the PeeWee age group generated a modest number of complaints at the publication of the draft Technical Bulletin. Taking these complaints into consideration, the Technical Committee made adjustments to the competition format to allow PeeWee skaters to skate through the season in the Regional Ability meets but be skated as a gender-specific age class at the Regional Championships allowing for the determination of a Provincial Champion for both genders. This change was met with support of all those who had submitted objections to the change and it is a change that the Technical Committee supports.

At last year's OSSA Annual General Meeting, the Technical Committee put forward the concept of a third level of meet that was intended to offer a "kinder gentler" environment for first-time skaters and parents and those skaters new to competition. The mini-meet is to be a "less than full day" meet without the structure and rigidity of the Regional and Ontario Cup series and, when possible, is to integrate elements of fun and a lesser focus on competition.

While only a few clubs chose to host mini-meets, they were a great success and it is the Association's hope that there will be a greater interest in hosting them in the coming season. Another variation on the theme is an intra-club mini-meet where ice time that is normally used for practice is set aside and the club members compete against each other in a less formal atmosphere. These meets help parents and skaters alike to understand how competitions are structured and what will be expected of them if they choose the competitive development path.

One of the changes to the Technical Bulletin that had the greatest impact on the work of the Technical Committee was the decision to based rankings for the selection to the Provincial ST Championships on the basis of the best three Ontario Cup finishes. This "three of four" criteria allowed for skaters wishing to pursue long track competition opportunities to choose to do so without fear of being penalized. This decision also allowed skaters with conflicting engagements to accommodate them without the need to request a Bye. This changed criterion resulted in a significantly reduced number of Bye Applications and a far simpler review process for the Technical Committee members.

In keeping with SSC practice vis-à-vis byes, all Bye Applications were held in abeyance until just before the Provincial ST Championships. At this time, the applications were shared with the members of the Technical Committee and decisions were made to grant or deny the Bye Applications based a far more complete set of

information and circumstances than had previously been available. The overall result of this change was extremely favourable in that no objection whatsoever was raised to any of the approvals or denials of the applications.

Another significant change made by the Technical Committee involved the decision to have the Regional Championships run as an age class meet for all age groups, not just the PeeWee and Masters groups. This change resulted in a meet that offered a taste of an age class meet to many skaters who had only participated in ability meets to that point, and an opportunity for those skaters who had drifted between Regional and Ontario Cup meets the chance to skate completely age appropriate distances against competition that was well seeded and offered a chance to compete head to head with those skaters that they may face as their development progresses.

The Regional Championships faced two criticisms as a result of how they were structured. The organizers, unbeknownst to OSSA and the Technical Committee, were not able to secure ice for a full two-day meet which required an adjustment of the number of races intended and the Master age groups were divided by age, rather than age and ability. While the PeeWee and Masters groups were afforded the four distances that would be expected of a two-day meet, the other age groups had to be scheduled with just three distances. The issue of the Masters criteria needs to be more thoroughly addressed as the coming season unfolds to either agree to the existing protocol or make adjustments that will allow the championship to be properly seeded and run and still result in fair and reasonable results from the races.

During the season the concept of "even team" relays was tried at Regional meets. Objections based on a perception of the safety were raised and the practice was curtailed until the Technical Committee could consider the issue and decide on the best way to include relays into the Regional stream. The Technical Committee will be presenting a proposal dealing with this issue as part of its 2010-2011 competition format proposal.

The Technical Committee recognized that there was a requirement for a greater participation on the committee for members with greater Long Track experience. This past season the committee included members with greater LT knowledge and this has assisted greatly in better addressing the needs of our members who skate Long Track as their primary sport and those skaters who have not yet made the choice between disciplines and who need to be supported in both.

The more equal representation of Long Track in our Association is an area that the Technical Committee acknowledges as valid and one still requiring additional work and it is the intention to increase the representation of LT on the committee and the Board will be putting forward a proposal in this regard for reference at the Association level.

The selection of a Long Track team to represent Ontario at the Canadian LT Championships played a significant role in the Technical Committee remaining true to the conditions laid out in the Technical Bulletin. For a number of years the Technical Bulletin has required skaters to not only place to be considered for selection to a team, but also to have demonstrated a skating ability that is reflective of a national standard. The nature of Long Track competitions makes this particular aspect of team selection more difficult than Short Track due to varying track and weather conditions. While an argument was made that the Technical Committee should

have relaxed these standards after the selection meet had taken place, it was the committee's decision to stand pat and apply the standards as published and to refer this matter to review for the coming season.

During the 2008-2009 season the OSSA Technical Committee and OSSA's staff formulated an application to the Ontario Winter Games Organizing Committee to seek continued participation in the Games. There were questions as to whether ST speed skating would continue to be included in the Games as the organization of our meets in the past had not differentiated the intent or purpose of the meet. OSSA's application made significant change to the format, the organization and the goals for the OWG meet.

The format put forward for consideration was based on a Trials format with a limited number of invited skaters participating in an intense competition under conditions that are normally not seen. The sixty-four skaters chosen were supported by a large contingent of volunteer coaches, managers and officials. The format put forward to, and approved by, the Games Organizing Committee saw the meet as a sport capacity-building exercise with a large percentage of the volunteers seeking and obtaining upgrades to their qualifications and for many new volunteers an introduction to the finer points of doing more than sitting in the stands and lacing up skates.

The organization of the OWG was seen as such a success that the same format is being proposed for use as the selection meet for Ontario's Canada Winter Games ST selection meet. The Technical Committee has also proposed that in seasons where there is neither an OWG meet or CWG selection meet that a separate Ontario Trials meet be held using the same format. This is intended to provide a further opportunity to grow our volunteer qualifications as well as provide an introduction to the Trials format to our top ST skaters.

The introduction of the Ontario Trials ST format is a significant step forward in further aligning the OSSA competition format with the goals of the LTPAD. The concept of age and skill appropriate competition fits well with the selection or our top skaters and providing them with a competition that introduces many to a new meet format and differentiates the intensity, organization and structure of this type of meet from an age class or ability format.

The Coaching and Officials Development Committees made some good progress this past season. While there is always room for improvement, a large number of coaches and officials were afforded the opportunity for development, mentoring and upgrading through the Ontario Winter Games format and a large-scale Officials clinic held in April. There are plans in place to offer additional opportunity for upgrades during the summer period.

The selection of coaches for the upcoming Canada Winter Games illustrated the need for a more conflict-free selection methodology. The Coaching Development Committee process was not clearly enough defined by its own members to allow for the Technical Committee and Board to be presented with clear recommendations regarding the selections leading to a delayed selection and the possible loss of Provincial funding. The Board has reflected on this issue and it is intended that changes be made to the coaching, and managers', selection methodology and criteria to remove the appearance of conflict and to streamline the process. It is hoped that this new process can be in place for the 2010-2011 season for all selections moving forward through a cooperative effort of the Technical Committee and the Board.

SSC has issued a comprehensive presentation dealing with their view of how the LTPAD is to be implemented. For the last several years, the SSC LTPAD committee has been refining the model and planning for this implementation, but the recent proposal includes change of a magnitude that has heretofore not been seen. The Technical Committee has reviewed the proposal and agrees with the underlying fundamentals of the model, but the competition format that has been proposed is so dramatically different – age group changes, distance changes, changes in track layouts and new regional boundaries – that it is felt that it is crucial to understand how other provincial associations are to react before OSSA works to implement.

The OSSA executive responded to SSC that it is our belief that the extent of the changes proposed are too farreaching to be implemented through a single series of rule changes and that not enough time was being given to the provincial associations to discuss, debate and digest the proposed implementation. OSSA has received a copy of the Federation de Patinage de Quebec's (FPVQ) response to the proposal and it makes the same assertions that we have put forward – more debate, discussion and possible revision is needed before the implementing rules are put in place.

The 2009-2010 season was a great success for Ontario skaters both at home, on the national level and internationally. Ontario sent three athletes – Keri Morrison, Kristy Shoebridge and Robert Watson – to the World Junior Championships in Taipei, Taiwan in January. We also so Ontario skaters participating in other international events and a number of skaters who have previously skated and trained in Ontario skating in Short Track events representing other countries.

Of particular note are Christine Nesbitt and Kristina Groves, both Ontario skaters who proudly represented Canada and came home with Olympic medals. These Ontario skaters who have risen to skate at an international level in both Long Track and Short Track events are fervent examples of the development potential and ability of OSSA's program and their success should be seen as an opportunity to review how we continue to mould our programs to support and develop this caliber of athlete.

While there is still much to be done, especially with our Long Track program, the continued integration of the intent of the LTPAD and a purposeful process for out-of-province meet registration, the 2009-2010 season should be seen as a success. With much of the administrative burden behind the Technical Committee and a relatively stable competition format in place, it is time to tweak, adjust and massage the Technical Bulletin to remove ambiguity, enhance opportunity and promote athletic development.

## VICE PRESIDENT DEVELOPMENT

Since joining the board in October/November of 2009, I have attended every board meeting till March. I also visited the OSSA office to meet the staff and review some of the systems in place and also submitted two written VP Development reports to OSSA and the Board. In addition I have completed the following:

True Sport - Ensured OSSA joined the 'TRUE SPORT' team as was promised at the AGM in 2009.

**Lakefield – head office** - Met with all the staff and reviewed existing policies at the OSSA office.

**Documentation** - Submitted to OSSA draft volunteer policies, personnel policies, board information and also suggested that OSSA develop a draft volunteer screen policy and also review conflict of interest policy.

**Communication** – one area I identified as a concern when I joined the board in the Fall was the lack of communication between OSSA and the general membership. I requested OSSA send out regular emails to the membership to update them on what was happening.

**Website** – I identified as a general member my concern about the membership and how ineffective it was for the membership. Once I joined the Board I requested a new board site be made a priority by OSSA. In the interim I requested regular communication in the form of emails be sent out. In 2010 a website that is interactive and supportive for the membership is necessary for any PSO.

**SSC** – I submitted information for Kathy Elliot regarding issues of development for our Branch – as Graham had already informed her about the high school program I gave her several ideas & suggestions for future funding including a couple of the following;

- Volunteer recruitment and retaining this seems to be an issue right now with many clubs locally (i.e. attracting club board members, parent volunteers in addition even with OSSA in attracting and keeping volunteers). Thus a suggestion might be for grant development that includes trainings or workshops that might help clubs recruit and retain volunteers.
- Collaboration suggestions that our Branch could be a lot stronger if were able to provide leadership for collaboration among local clubs. Thus a suggestion might be for grant development that includes a requirement for clubs to work together and collaborate.

**Newsletter** – I volunteered to research, write and submit to OSSA a quarterly newsletter (I submitted one in late Fall and one in the Winter). Included in the newsletter would be the following:

- OSSA updates
- CLUB updates (gathered from reviewing various club websites)
- PARENT/MEMBERSHIP info (more recently on safety protection in Short Track)
- PROVINCIAL TEAM (National competitions)
- MASTERS (updates)

**Clubs** – In addition to contacting two new potential clubs, I have completed several documents for clubs that I have submitted to the OSSA office including:

- How to start a club (with information provided by Graham Wilkins)
- Club best practices
- Questionnaire for clubs (for AGM)

**Human Resources** – I created an effective evaluation tool to be used for staff evaluations. In addition to requesting OSSA update the 2008 information manual I have also suggested that clear job descriptions need to be written that ensure clarity for staff, especially those newly hired. Administration is not just about finances but Human Resources and because of the difficulties OSSA has had in the past it is very important that employee files are up to date and with clear job descriptions. It is very important that the new board ensures that the administration of the OSSA office includes clear staffing roles, evaluations with input from the membership and up to date job descriptions and personnel policies.

## My Concerns:

OSSA have improved its financial administration and met its required goals and should be commended. However, now that this is in order it is time to really focus and work together on the other areas that have been raised as a concern by the membership and myself including:

- Effective clear and, transparent communication between OSSA and the membership
- Effective OSSA team staff, with clear expectations and roles. New clubs and smaller clubs need more support from the OSSA office.
- Increased funding OSSA needs to increase grant applications and base funding

## My Goals:

My Goals if elected as VP Development:

- Establish the VP development committee with membership from the club Presidents and general membership.
- Work with OSSA to develop a 'how to' series of documents for both new clubs and existing clubs.
- Work with the VP Admin, OSSA board and staff to ensure that clear job descriptions are in place for all the staff that reflects their actual positions including the Executive Director.
- Strategic Planning Now that many of the financial aspects of the administration are healthy it is
  important that OSSA look toward the future and include the membership in developing a clear plan
  that is beyond a visionary statement but includes specific goals with measurable objectives, for
  example a Provincial Coach or Coordinator who is able to work with the Coaches and athletes of
  Ontario both within and outside the Province.

Virtual OSSA – I think we should be moving in the future to have a virtual OSSA, with an effective and up to date website that also is interactive for committees, board and membership. .

When I joined the board OSSA was going through a challenging period both financially and accountability with its membership. I would like to think I played my part with the rest of the board which has turned this into a stronger association with increasing membership.

We did see a decline in sales this year of merchandise from previous years but this was helped with the new high school program grant to purchase skates. The decision was made not to sell OSSA equipment at meets this year. I believe this reduced the visibility for the association to the current membership especially our new members to the sport.

- 1. Going forward we should reduce the type of equipment we carry.
- 2. To continue to support the high school program with merchandise from OSSA and any other program we get grants for.
- 3. Support newer clubs with equipment loans (Ref IPPS skates)
- 4. OSSA to make distribution deals for the OSSA branded merchandise through the other existing retail businesses that attend meets.

I will volunteer on behalf of OSSA to be at key ability meets during next season as I have done in the past.

The other positions on the board are important in what they do for the sport, the membership and the association the new board needs to look at this position and help guide it more to help in the expansion of speed skating in the province and help raise OSSA profile.

Good example this year was the very successful new High School program.

## **EXECUTIVE DIRECTOR**

It has been another challenging year at OSSA. Again this season much of my time was spent with various technical duties. Completing meet entries for our skaters competing out of province in particular was a time consuming task as there are many entries to submit and while most meets request Provincial entry, their published deadlines do not allow time for the Province to compile their entries. Fortunately, our skaters and their families were very enjoyable to deal with throughout the various entry processes. The membership as a whole is pleasant to work with and we have very few late entry submissions to manage. In particular the group that attended the short track Canadians this season was extremely prompt in providing their entries, which was critical given the 24 hour turn around period during which I had to submit our team registration. The Ontario Games participants also deserve recognition not only for their involvement in the Games, but also for their understanding when the Games organizers changed our accommodation location only two weeks before the Games. Jacky Shoebridge was instrumental in working with the organizers to make the move work for OSSA.

Despite all of the technical duties, I did manage to spend time making more administrative changes this year. By changing phone and internet service providers I have cut costs in that area by over 60% while maintaining the same service level. We are in the process of changing website hosts which will also cut the costs in that area by more than 60% while increasing the service level. Further, the receivables for the Association are at the lowest they have been in several years. Several forms were created to formalize processes that were already in place such as the Board of Directors and Committee Nomination forms. I also created a draft communication policy that is still undergoing review and changes. Working from an SSC policy and with club representatives, course facilitators and the coaching committee we have also created a Coaching Course Roles

and Responsibilities document that will help clarify what is involved in hosting a coaching clinic. Hopefully this will make it easier for all stakeholders to hold courses making certification opportunities more plentiful.

Last year I indicated that I hoped to adjust expense claim guidelines, billing and communications policies, as well as evaluate our information manual and by-laws to ensure our current policies serve our members in the best way possible. In service of that goal I have put forward several amendments for Board consideration.

This year we also worked to make direct communication from OSSA to all members more frequent and consistent. The goal of the "Tuesday Email" was originally to send out weekly emails to every member we had an email address for. The list of emails was difficult to manage at times as there are many members in OSSA that have the same email address for multiple family members and we did honour requests to be removed from the distribution list. The email goes out to more than 1400 members. The email was not always out on schedule, but it was an improvement over the communications sent in previous years that only went to club presidents infrequently. I expect to improve this again over the next season and we are planning to send the email every two weeks in a continued effort to find the right balance between communication and irritation.

I was fortunate enough this year to be selected to work at Speed Skating Canada House managing the volunteers in the hospitality functions at the house during the Olympics. The Board of Directors supported this endeavor and I was able to make good connections with many of the SSC staff members and volunteers. SSC was very pleased that OSSA was able to contribute so many great people to the Games including many volunteers who worked at Games Venues. The support of many OSSA volunteers allowed this to happen and hopefully the benefits to our organization will continue for the foreseeable future.

Over the coming year I hope to spend more time improving OSSA's website. I have been working on a new site for several months and it is currently undergoing review by the Board of Directors. We are launching a logo contest for members to create a new logo. Members will have an opportunity to vote on the top submissions and choose our brand moving forward. The current logo will be a choice in the voting. I also hope to improve our marketing and media relations as well as do a better job celebrating the successes of our members.

OSSA's members are unfailingly polite and thankful when speaking to me via email or telephone. Many take the time to complement both office staff members on a job well done and for that we are grateful. Please don't hesitate to contact me by phone or email should you have any questions or concerns. I look forward to continuing to improve OSSA to the best of my ability.

#### Tasks for the year in annual plan:

#### **Hosting manual:**

- a) Reviewed and revision made during summer 2009
- b) Final edition circulated to Branches and Meet Coordinators and posted on website in early October. This was delayed as we waited for translation and we must have it out by first of September this year. Sandra Chénard (English and Chantal Brideau (French) will meet to review revision in July 2010 at an in person meeting to ensure this work is completed.
- c) Can be found on the web site under Competition Committee

#### **Canada Winter Games**

- a) Technical Delegate Short Track Sandra Chénard and Long Track Dennis Duggan
- b) Plans well under way with the technical packages having been sent to the Branches two years previously. The Host Committee in Halifax is well ahead of schedule in their planning.

- c) Short Track will be skating on an International Ice Rink which has been refitted. The facility is well suited for the competition but seating is limited and it is a cold arena. The host Committee is working on these concerns. A successful test event was held in January.
- d) Long Track facility will be a temporary artificial ice oval on the "Commons". This is a centrally located space and will be highlighted during the games. A test event is planned for January 2011.
- e) The only change to the technical package was the skin suit standard was enhanced requiring that skaters suits must be as stated for Canadian Junior Trials in the HP Bulletin.
- f) A Skate technician for both Long Track and Short Track will be on site for emergency skate and blade repair. Applications have been received after posted on the website.

#### **Meet Manager**

- a) All Branches now using the program successfully
- b) Still some flaws that need to be fixed and requests go regularly to the developer
- c) Changes will be made as needed as competition structures change
- d) There is a Meet manager handbook prepared by Sharon Zorman from ASSA. This was sent to the Branches and Branches were asked to post it on their website. CDC did not have the funds to translate it therefore it cannot be posted on the SSC site at this time. A French version is available on FPVQ's site.

## **Competitions within the mandate of the Committee**

- a) Funding provided for Canadian championships, Canada Cup Ranking/Selection, Masters and North American Long Track to hosting Committees
- b) All competitions were well attended
- c) The Canada Open masters has been registered with the IMSSC (International Masters Association) The competition in Quebec City was well attended and we are looking for a host for the 2011 Competition. Calgary will be hosting the World Masters in 2011
- d) NA /CAN Marathon was hosted in Joliette and attendance was strong with many good ideas being forwarded to this committee
- e) North American Long Track had a large entry and days were long and confusion with format and lack of volunteers in the US. Time standards posted in HP Bulletin and on the website
- f) NAST does not currently fit into SSC's competitive structure and will not be held at this time
- g) CDC would like to introduce a Bulletin style information package that contains the process and rules related to each of the competitions that fall with in the mandate. This document would be circulated by early September each year. This format would be less confusing to all members when planning Canadian Competitions.

#### **Competition Calendar**

- a) Development of this calendar continues to be a challenge, as we must always wait for the HP dates to be set before publishing. The committee has asked HP both Short Track and Long Track to consider planning on a two -year calendar base. This is before the two committees at present
- b) The 2010-11 calendar was a challenge since we are waiting decisions from the LTPDA and the AGM but the committee has moved ahead securing some hosts . Still looking for a host for Canadian Short Track Championship at end of March 2011.
- c) 2011 CALT- The committee has chosen to host one National LT championship in 2011 rather than two Regional Championship. This decision was made due to: not having across country attendance so

the committee would like to pilot this event before splitting into two regional events. For 2011 the event will be a hybrids which will include some mass start, Olympic and team events for the T2T athletes as well as those who are older but not yet achieving the HP Canada Cup standards.

#### **LTPAD**

- a) A major task for the committee was to follow up discussions of the larger LTPDA group and begin the process of Competition review. We worked closely with the coaches, officials and HP committees to put these ideas into a practical competition format. These ideas have been shared across the country and much feed back received. CDC finalized the Power Point presentations for Regional Championships and is awaiting HP input from the April Meeting so that National Championship/Selection #3 can be distributed. It should be noted that all feed back is welcome since together we will be stronger. The Power points can be found on the SSC website under LTPDA.
- b) CDC has generated some preliminary meet format templates for both Regional Short Track and Long Track as well as National Short Track Championship format. Feed back has been coming in from various groups who have piloted some activities
- c) Track sizes for different ages and rink size still being discussed by all committees to ensure skaters are participating in the safest environment possible

#### **CONCERNS:**

- a) Review needed for skating equipment standards being used by our skaters
- b) Review needed of skin suits being worn by our athletes
- c) Review medical services being provided at all competitions
- d) If CDC is to continue to build the national calendar we must receive competition dates and locations for HP competitions earlier than in the past
- e) CDC recommends that the committee set the Competition entry fee rather than the Board of Directors
- f) That the NA Alliance be reviewed so that we are reflecting what is occurring currently

The 2009-2010 season as most can imagine was a busy and exciting one both pre and post Olympics games for SSC and its committees. The CMDC as per its mandate worked hard at developing and implementing programs to aid in the development of clubs, membership and skaters.

In addition to monthly conference call meetings the member of the committee met at a face to face meeting October 3-4, 2009 in Ottawa. The committee members also participated in the LTPAD Joint Committee/Branch meeting on November 28-29, 2009 which was also held in Ottawa. The main topics and programs discussed at these meetings helped form some of the foundation for the CMDC direction over the season.

A Brief summary of program CMDC worked on over the 2009-2010 season is as followed:

#### **Festivals**

The intent of the Festivals on Ice program was to provide an opportunity for people of all ages to come together in a fun and safe environment to experience and celebrate the sport of skating in its many forms.

<u>Festival Kits:</u> At the SSC Coaching Symposium (Aug. 2009) CMDC provided each Club with a Festival on Ice Kit. Each kit contained information on how to address the anticipated increase in inquiries during and after the Olympic games. It also provided clubs with tools and ideas to assist them in increasing membership by promoting our sport through the use of a festival theme.

<u>Festival on Ice hosting Grants:</u> Grant money was made available through an application process to assist clubs across the country with the hosting of a local celebration that would invite the general public to join their club for a fun day of skating, games, racing and demonstrations whether on figure skates, hockey skate or speed skates.

CMDC awarded 5 hosting grants of \$1000.00 each. Successful grant applicants were, Fredericton (N.B.), Fort Simpson (N.W.T.), Kelowna (B.C), River City Racers (B.C), and Nunavut.

Smaller grants were made available to 5 additional clubs, Fort St. James (B.C), Esquimalt (B.C), Kamloops Long Blades (B.C), and Langley (B.C) and Chicoutimi (P.Q.).

Larger hosting grant of \$3000.00 each were awarded to 5 centers across the country. These 5 centers represented home clubs of Olympians. These larger Festival events were hosted in conjunction with the dates that their Olympians were skating at the games and were held in Fort St. John, Calgary, Ottawa, Quebec, and Fredericton.

Feedback from all the clubs that hosted an event whether large or small was very positive and in most cases resulted in the acquisition of new club members .These events offered a great opportunity to publicize the existence of a speed skating club within the community, and proved to served as a perfect venue to answer questions the public had concerning our sport and club activities.

## **Long Term Participant and Athlete Participation**

The CMDC spent a good deal of time reviewing the LTPAD and will be encouraging all Branches and Clubs to continue to examine and respond to the guiding principles of the LTPAD.

The committee has begun working on revisions to The Parents Guide and Cutting Edge Pin Program so they will better reflect LTPAD.

CMDC has taken the lead on the production of an educational video being produced to aid members in the understanding of the LTPAD principles and the importance for Branches and Clubs to adopt its principles in the planning of their programs and competitions based on developmentally appropriated programming.

#### **True Sport**

On the path of the LTPAD the committee has been encouraging every Branch, Territory and Club to commit to the True Sport Movement. A poster was produced which featured our athletes and the 6 principles of the True sport movement, **Go For It, Play Fair, Respect Others, Keep It Fun, Stay Healthy, Give Back**. These posters were distributed to clubs for promotional purposes early in the new year.

A committee goal is to have the entire Speed Skating community pledge to the True Sport Movement in the coming year.

#### **Grants**

CMDC realized the need to revisit and revise the existing grants and to identify a process that would ensure our grant s better align with the LTPAD.

While the SEED and SEED lottery grants will remain a new grant, Sport 4Life has been created and will be introduced in the 2010-2011 season. This grant will allow all clubs to apply for money required for the purchase of equipment or to help fund a variety of projects or programs related to aiding club and membership development.

#### **Post Olympic Energy**

A Festival on Ice Phase 2 is currently being worked on for the upcoming season. It is the committee's goal to encourage all clubs to host a festival in their communities next season whether on their own or in conjunction with other nearby speed skating clubs or other skating clubs in the area. The potential for increased awareness and membership in our sport should definitely be a great motivator for all clubs to consider looking into hosting a community skating event in 2010-2011.

- Members continue to share ice time with the Peterborough Club on Saturday mornings starting in September. Ice on the Oval was ready for skating on Jan 6<sup>th</sup> and our club played host to a Toronto production company and cast for a Verizon commercial (can be viewed on U Tube). High School skaters from Wayside Academy skated on the outdoor ice 12 times between Jan 8<sup>th</sup> and February 23<sup>rd</sup>. The program was coached by Chris Coons and included 21 students and 3 parents. The students from Wayside participated in the Peterborough Club's fun race on February 15<sup>th</sup>. - Richard MacLennan of our club had a great season and barely missed making the Olympic Team. He skated in several World Cup events and earned 2 silver medals at the World Junior Championships in Moscow. We hosted a successful Provincial Long Track Championship in January 2010. – Sault Ste. Marie
- Olympics Free Trial night received turnout of approximately 50 skaters and potentially 20 who will join
  this fall. For the first time this summer the Club is offering a Preseason Training Camp with Dryland
  training starting in August and 3 ice sessions in September at an alternate rink prior to our regular
  season starting late September at our home ice. The Club changed President and Treasurer in
  February 2010. Thunder Bay

#### MAJOR CHALLENGES AND LESSONS LEARNED

- Our major challenge was at the beginning of the year, most of our board were new and needed to learn all of their positions. Communication was really good and we all look forward to progressing next season. – Barrie
- Preparing for the surge of interest during an Olympic year we ran out of skates. Dealing with unforeseen issues like an H1N1 clinic that takes over the facility. Finding good fundraising activities for the club. – Brampton
- This past season offered a little frustration in trying to get the Ontario Winter Games information straight. Entering long track speed skaters into competitions was difficult as calls had to be made to confirm receipt of entries. Long Track athletes in Ontario do not have the same support of coaches for meets as short trackers. – Cambridge
- Ice time continues to be one of our major challenges. We are still trying to get more ice time in our current rink and have also started looking at other rinks. Coaching also continues to be a major hurdle for our club. Hamilton
- The City is reducing traditional hours of ice available to us and considering higher fees to cover their expenses. Coaches are key, but subject to transfer and other obligations. – Kingston
- Ice allocations, setting up groupings by age and ability, handling the growth, handling the numbers that came out to try our sport. Finding enough time and people to be able to talk to new people and encouraging them to join them or in the fall. Kitchener-Waterloo
- Dealing with surge of interest during the Olympics. Volunteerism with the club improve member awareness of need for everyone to contribute. Adequate coaching resources. – London
- Getting sufficient volunteers to run the race meet was successful. People came together when needed. – Markham
- Challenges in securing additional ice time from the Town. Some challenges with skaters in the upper rankings finding ability meets that had sufficient space to allow them to compete. Newmarket
- Recruiting new coaches and volunteers. High school Program lack of direction at beginning of the season. Information arrived too late to put together a program. Unbalanced support for long track skaters. Travel expenses are extensive as they must travel out of Province for meets. – Ottawa
- Obtaining coaching clinics. Juggling various age groups and ability levels. Sudbury
- Our club is in a rebuilding mode as a number of our skaters graduated at the end of the 2009 year and
  we have received increased community interest as a result of the Olympics and look to an upcoming
  year with increased membership. Sault Ste. Marie
- Getting parents more involved. Fundraising for our kids to travel to Southern Ontario for meets as parents are paying for expenses themselves. Thunder Bay
- Fast growing club with tons of events and activities, but not as strong a volunteer base = opportunity. How do we provide incremental training time for West end skaters who will not travel to the East end. Skate inventory is not adequate vs skater demand need capital infusion/grant. Toronto

I believe it is important that OSSA Board members set an example for every other volunteer who serves on an OSSA Committee or on the Board itself. Using your position to promote your own interests or the interests of your family is unacceptable and that in my mind is the real significance of the Oval Project. Of course I am still a member of the Lakefield Club and our club's goal is to complete the Oval Project but despite this potential conflict of interest I have never used my position as OSSA President to help that effort and by setting this example I feel I am able to make sure that other members and committees avoid any potential for making decisions that are simply not fair to all of our members.

#### **Association Priorities**

I think it is important to have an administrative structure that is responsive to, and communicates with, the membership. In this regard, I try to respond promptly to enquiries and work hard to communicate continuously with our staff, other board members and our membership.

#### ROGER BUXTON - NOMINEE FOR VICE PRESIDENT MARKETING

#### **OBJECTIVES**

#### **TASKS**

- 2. Develop publicity materials for external parties and for OSSA members.
- 3. Cultivate press and media contacts.
- 4. Examine vendor licencing, TV rights, trademarked items, corporate sponsorship, fund raising events, and similar options as sources of revenue.
- 5. Consider grants to support the investigation and development of new revenue streams.
- 6. Work with the Board to maintain a transparent flow of ideas and information with the clubs.

## **QUALIFICATIONS**

- 1. I began speed skating 15 years ago, and have been competing as a masters skater for the past 10 years.
- 2. I have been the President of the Markham Speed Skating Club since 2002, and have grown it from a small primarily recreational skating club into an established racing club, being now regularly represented at ability meets, at the Ontario Cup series and Ontario age class championships, and at the Canadian age class championships. Membership has more than tripled so that it is now ranked #8 in size in Ontario, and the Club hosted its first OSSA-sanctioned race meet last season.
- 3. I received Speed Skating Canada's Outstanding Administrator award in 2005 for initiating and running the FROM THE START program to introduce nearly 1000 primary school children to speed skating.
- 4. I was a member of OSSA's marketing committee in 2005-2006.
- 5. In my professional career, I have held senior technical and marketing roles in companies doing business with both national and international companies and with provincial, federal, and international governments and agencies. Notes on Comments & Survey Results received during the 2009/2010 season.

June 2009 Survey – On line Survey of Association members who attended the 2009 OSSA AGM.

- Members expressed need for modification to organization of future OSSA AGM break out sessions
- Members supported end of May date for AGM/President's meeting.

Comments made concerning Long Term Plan – The LTP was posted on the OSSA website and emailed to Club Executives on Nov 2009. A short review of the LTP was part of the March OSSA Newsletter.

- Concern expressed that the goal of increasing membership numbers was unrealistic given limited ice time available for the average club in Ontario
- Support for concept of regional training centres can not be used as a way for a single club to recruit skaters from other clubs skaters should remain members of 'home club' have to be established so that skaters do not have to spend too much time traveling to practices.
- More attention needs to be spent on developing programs and events for Masters eventually some form of selection process for attending out of Province/out of Country competitions might be required.

Issues relating to LTP raised at Newmarket President's Meeting – Copy of Long Term Plan & Goals and Objectives was sent to all those who attended meeting

- would lower recreation membership fees increase participation
- can OSSA find a way to support clubs that organize meets or run summer camps through some form of hosting grant
- OSSA can no longer help fund operations through merchandise sales
- Minutes of all Board and Committee meetings need to be taken, reviewed by both the committee, and the Board and then posted on the website.

April 2010 Survey Results – On line Survey was forwarded to all members of Club Executives:

#### **Club Organization**

- 17 of 20 responding clubs hold annual AGMs and Elections
- 14 of 20 responding clubs are incorporated
- 4 of 20 clubs have club insurance policies
   ( for 2 clubs the insurance policy is a condition of facility rental)

#### Competitions

- Majority of respondents favour one day ability meets.
- Majority of respondents feel that O Cup level skaters need to be able to participate in some more relaxed, 'fun type' competitions
- Some members commented that the OWG trials type race was beneficial for young skaters

#### **Provincial Teams, Athlete Support & Training Centres**

- Majority of respondents support existing ranking system
- Majority of respondents support current level of athlete support
- Many clubs support concept of clubs working together to provide additional ice time for some skaters mixed opinions about who should be involved.
- Mixed opinion about whether a 'provincial coach' would encourage skaters to stay in Ontario to train at a higher level
- Support for the concept that OSSA money should be spent on provincial coaches or regional training programs rather than individual athletes

#### **OSSA Organization**

- Majority of respondents feel OSSA administration is providing clubs and members with good support.
- Majority of members feel communication would be improved with a better OSSA website
- Majority of members prefer Presidents meeting be scheduled for Sunday at OSSA AGM
- Majority of members feel OSSA Board should attend President's meeting to provide information and answer questions.
- Small majority of respondents favoured a November President's meeting.

## APPENDIX 5 – COACHING CLINIC ROLES AND RESPONSIBILITIES

Based on the policies and procedures established by Speed Skating Canada (SSC) for holding National Coaching Certification Program (NCCP) courses and the integration and use of National Coaching Certification Program (NCCP) material, developed by Speed Skating Canada (SSC).

#### **SSC Responsibilities**

- 1. SSC will provide Master Learning Facilitators (MLF) and Learning Facilitators (LF) with access to the online material at the level they are qualified to facilitate and in the languages in which they are qualified to teach.
- 2. OSSA is granted the right to use and reproduce this material in a format consistent with the hard copy /proof provided by SSC.
- 3. SSC shall pay directly to the Coaching Association of Canada (CAC), the required NCCP Database entry fees of \$7.50 per coach.
- 4. SSC shall provide free of charge to the MLF/LF, copies of all supplementary reference, program and promotional materials.

#### **Ontario Speed Skating Association (OSSA) Responsibilities**

- 1. OSSA will coordinate the hosting of NCCP courses including:
  - a. Confirm LF.
  - b. Work with Host Club to confirm location, date and time.
  - c. Promote courses to all OSSA Clubs and Members.
  - d. Collect all participant registration fees and ensure participants are members in good standing of Speed Skating Canada.
  - e. Work with Host Club to determine course participation fee based on suggested guidelines provided by SSC.
- 2. Ensure payment of ice and meeting room fees once Host Agreement has been signed with the Host Club.
- 3. Reimburse costs for LF travel, accommodations and meal at per diem rate as per OSSA reimbursement policy and pay LF \$30 per instructional hour.
- 4. Print copies of current course material when required by the instructor utilizing the electronic PDF proofs provided by SSC and provide to LF/MLF for distribution at start of each workshop.
- 5. Ensure all participants are taught using the most recent version of course materials.
- 6. Provide MLF/LF with a contact list of all registered course participants.
- 7. Provide Host Club with \$100. to cover AV equipment rental and refreshments as required.

#### **Host Club Responsibilities**

- 1. Book appropriate ice and meeting space for the course to be held.
- 2. Provide details of ice and meeting room contract to OSSA including date upon which cancellation fees may be levied.
- 3. Complete and sign Host Agreement Form and forward to OSSA Office at least 90 days before course date or later if Host Club has already recruited minimum required number of participants.
- 4. Forward to OSSA cancellation terms and conditions for all facilities required to conduct course.

- 5. Forward to OSSA, for payment by OSSA, all invoices associated with conducting course within 14 days of completion of course.
- 6. Meet LF and participants at start of course and provide hospitality and AV equipment as required.

#### **Learning Facilitator Responsibilities**

- 1. Refuse course participation to anyone not on list of registered course participants.\*
- 2. Submit to SSC, the CAC and OSSA an electronic copy of the Course Registration Form within 30 days of completion of course.
  - 3. Submit to SSC and OSSA a copy of the post course evaluation within 30 days of completion of course.
- 4. Distribute course material to participants.
  - 5. Provide OSSA with an invoice for instructional hours, travel and meal costs in accordance with OSSA reimbursement policy within 30 days of completion of course.
  - 6. Contact all course participants in advance to;
    - a. Confirm participation and payment of course fee.
    - b. Confirm course location date and times.
    - c. Provide list of what items to bring to course.

Copy OSSA on correspondence so that OSSA office can answer any question from participants about the course.

- 7. Ensure that follow up evaluation course registration form is completed and submitted in a timely fashion per SSC procedure as appropriate.
  - \* LF should have the freedom to admit a last minute participant on the condition that course material is available and the LF takes credit card information, including card number, expiry date and security code of course participant.

Ontario Speed Skating Association reserves the right to cancel any course which does not meet the minimum participation requirement prior to the cancellation penalty deadline provided by the Host Club.

## APPENDIX 6 - HIGH SCHOOL PROGRAM REPORT

#### **Program Overview**

OSSA prepared a Club Package that provided clubs that had expressed an interest in the program with an outline of the opportunity and club responsibilities. Clubs were asked to recruit a teacher volunteer from at least one high school close to their rink. The club agreed to reserve at least ten practice times, ideally during the time between the New Year and the School break in March.

OSSA provided brochures and a DVD that the teachers used to recruit students who wanted to try speed skating. OSSA also provided the teacher with the letters required to have the program approved by the local school board.

The goal was to recruit at least 20 skaters for each club's program and the cost for each individual student was \$50. This fee included ice time, coaching and the use of skates that were provided by OSSA. The club registered the students as High School Recreational members.

OSSA organized a Fundamentals Leadership course in early December and 11 new coaches participated in the course that was conducted by Mike Rivet. The course participants who agreed to help coach their club's high school program had their coaching course fee paid by the High School Program.

### **Program Results**

Seven Clubs participated in OSSA's High School Program and together they recruited 113 students who are now recreational members of OSSA. The clubs recruited students with a wide range of abilities and a number of the students progressed during the ten week season to the level where these young skaters now plan to join their clubs as regular recreational members this fall.

Each club received a subsidy from OSSA of \$2,000.00 to cover the cost of ice rental as well as \$750.00 for transportation and equipment expenses. All of the clubs who participated indicated an eagerness to offer a similar program during coming season.

OSSA received the benefit of 113 new recreational members as well as a number of members who helped to organize and coach these new programs. As a result of the High School Program funding OSSA now owns almost 100 new club skates that will be made available for next year's High School Program as well as future club events.

### Challenges & Next Steps

For a Club to run a successful High School Program requires a considerable amount of effort on the part of a group of volunteers at the host club as well as effective support and enthusiasm for the program from OSSA. Each club that participated in the program this year indicated an eagerness to run a similar program again next season which is a sign that the Clubs feel the effort of running the program is worth the effort.

The lesson from this past season is that each club's situation is very different and OSSA has to be flexible in how the program is offered to each Club. The initial level of guidance from OSSA is critical to getting each club's program started. The ultimate success of each program relies on the recruiting ability and enthusiasm of the teacher and coaches who volunteer to run the program at each individual club.

Based on the response from the participating clubs from this past season OSSA will support the seven existing programs for another year and has the funding to support as many as six new programs for the coming season. The funding formula will be adjusted so that clubs continue to receive support and enough incentive to run these programs in the future.

The program's success this season relied heavily on volunteer involvement as well as the support of OSSA staff. The goal for the coming year will be for the program to fund an OSSA staff member, likely hired on a short-term contract, whose primary focus will be the success of the coming season's High School Program.
