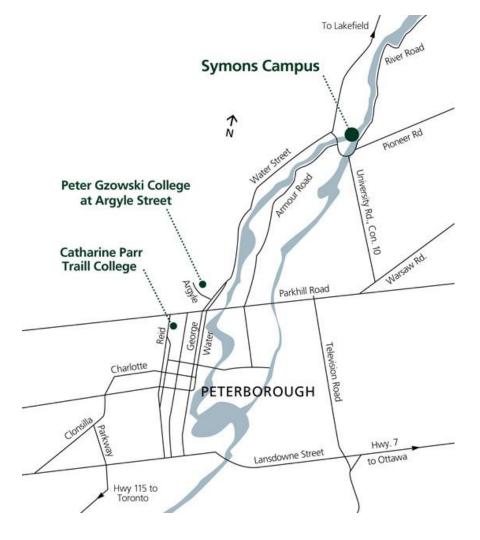
Please note that these directions take you to what is identified as the Symons Campus on the map below.

From the East

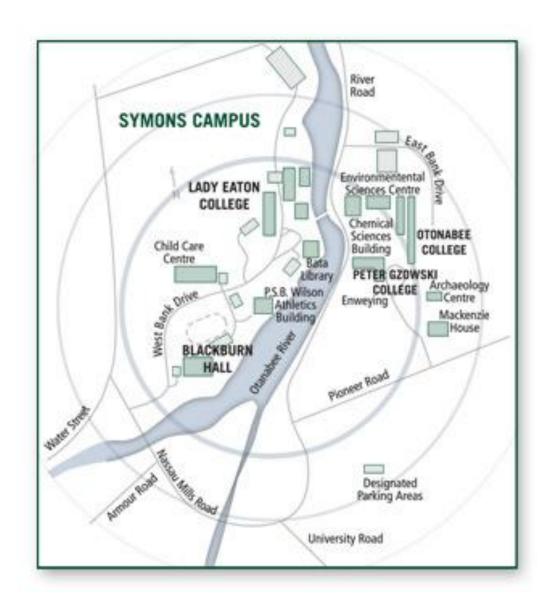
- Travel west on Hwy 7

Annual General Meeting – 2008 Minutes Ontario Speed Skating Association Meeting Space, Peter Gzowski College Trent University, Peterborough, Ontario

a. Welcome

at 9:58 a.m. on May 24, 2008, Graham Wilkins, President, welcomed delegates to the Ontario Speed Skating Association's (OSSA) 2008 Annual General Meeting and called the meeting to order. Mr. Wilkins introduced Yanna Moncion, Speed Skating Canada Sport Program Coordinator, who was attending a Meet Manager training session and would be available for questions during the lunch break.

b. Confirmation of Delegates

Todd Landon, Director of Sport Development, conducted a role call of the clubs and voting delegates present. There were twenty-eight (28) club delegates and three (3) voting directors. Sixteen (16) votes were needed to have a majority on any vote. It was noted that the role would have to be revised during the meeting as other delegates arrived.

c. Agenda

Moved by Doug Flynn, seconded by Mike Rivet, that the agenda previously distributed and printed on page 7 of the reports package for the 2008 OSSA Annual General Meeting be approved.

Motion Carried.

d. Minutes – 2007 OSSA Annual General Meeting

Moved by Luanne Lee-McNabb, seconded by Ian Overman, that the minutes of the 2007 OSSA Annual General Meeting on May 26 and 27 be accepted.

Motion Carried.

The number of present delegates was revised to include thirty-one (31) club delegates and three (3) voiting directors. Eighteen (18) votes were needed to have a majority on any subsequent votes.

e. Vice President Finance and Administration Report

Stephen Arnold presented members with the Vice President Finance and Administration Report as published on pages 12-13 of the reports package for the 2008 OSSA Annual General Meeting.

A. 2007 – 2008 Audited Financial Statements

Moved by Stephen Arnold, seconded by Robert Miller, that the 2007 – 2008 OSSA Audited Financial Statements for the year ended March 31, 2008 as prepared by Graham Mathew & Partners LLP, Chared Accountants, be accepted.

Discussion:

- Doug Flynn asked why there was an expense showing for the Ontario Winter Games understanding that there should be no expense for the Games. Mr. Arnold noted that officiating revenue for the Games is noted elsewhere in the statements making the Games revenue neutral.
- Doug Flynn asked shy the Officials Development Committee expenses do not show up in the audited statements. Mr. Arnold noted that the Officials Development Committee expenses were too small to be noted individually in the audit and was lumped as part of Technical Expenses.
- Don Clarke asked about the results of the OSSA raffle. Mr. Wilkins responded that a report on the raffle had been distributed noting that there were some successes and challenges to the raffle and comments to improve the process would be welcome.
- Roger Buxton asked about the source of the revenue noted on the Calgary Oval fees line of the audit. Mr. Arnold noted that the revenue was collected from the skaters enrolled in the Calgary Oval programs.
- Ian Overman asked about the \$10,000 write-down of accounts receivable. Members of the Board responded that it has discussed ways to address the issue.

Motion Carried.

B. Auditor for 2008 - 2009

Moved by Stephen Arnold, seconded by Don Clarke, that Graham Mathew & Partners LLP, Chartered Accountants, be appointed as the auditors for OSSA for the year 2008 – 2009. Motion Carried.

C. Registration Fees for 2008 – 2009

Moved by Stephen Arnold, seconded by Paul Landry, that the proposed registration fees printed on page 14 of the reports package for the 2008 OSSA Annual General Meeting be approved. Discussion:

- Doug Flynn asked about the distribution of SSC membership cards as he had inquired about membership cards at the SSC Officials Symposium and was told that the membership cards were sent to the branches. Mr. Landon noted that membership cards had not been received by the branch. Mr. Wilkins noted that the inquiry could be posed to Yanna Moncion during the lunch break.
- Given that the recreational category is new this season the difference between recreational and competitive skater categories was discussed.

Motion Carried. (1 opposed)

The number of present delegates was revised to include thirty-two (32) club delegates and three (3) voiting directors. Eighteen (18) votes were needed to have a majority on any subsequent votes.

D. Information Manual Amendments

Moved by Stephen Arnold, seconded by Ian Overman, that the proposed OSSA Information Manual included as an appendix to the reports package for the 2008 OSSA Annual General Meeting be approved.

Motion Carried.

f. Club Reports

Moved by Patti Pokol, seconded by Mike Rivet, that the club reports presented on pages 41 – 76 of the reports package of the 2008 OSSA Annual General Meeting be accepted.

Discussion:

- Ian Overman of the Sault Ste Marie Speed Skating Club requested that OSSA work with SSC to extend the long track season into February when the club has typically had the best ice conditions.
- Doug Flynn of the Kitchener-Waterloo Speed Skating Club noted that its board will remain the same in 2008 2009 with the addition of one Director. Doug also noted that the club grew by 20% in 2007-2008 and has acquired one additional hour of ice for the 2008 2009 season.
- Brian Marsh of the Durham Speed Skating Club asked OSSA how the board will address the concerns of the clubs presented in their reports.
- Cheryl Wilson of the Clarington Speed Skating Club asked if the board will address the needs of the clubs directly.
- Patti Pokol of the Brampton Speed Skating Club offered to host a coaching clinic during the summer.

Motion Carried.

g. Statistician's Report

Moved by Marg Oliveira, seconded by Lianne Franklin, to accept the Statistician's Report submitted by Klaas Hanje and presented on pages 39 0 40 of the reports package of the 2008 OSSA Annual General Meeting and approve the records achieved during the 2007 – 2008 season.

Discussion:

• Pass on thanks to Klaas Hanje for his work.

Motion Carried.

h. Vice President Technical Programs Report

David Stewart presented members with the Vice President Technical Programs Report as published on pages 15-19 of the reports package of the 2008 OSSA Annual General Meeting.

A. 2008 – 2009 Competition Calendar and Competition Format

Jacky Shoebridge presented the proposed 2008-2009 competition calendar.

Todd Landon presented the proposed 2008 – 2009 competition format.

Discussion:

 Discussion about the 2008 – 2009 Competition Calendar and Format was deferred until new business so that the delegates could review the proposals and so the meeting could take its scheduled lunch break.

The 2008 Annual General Meeting was adjourned at 12:49 p.m. on Saturday May 24, 2008.

The 2008 Annual General Meeting was reconvened at 9:09 a.m. on Sunday May 25, 2008.

The number of present delegates was revised to include thirty-five (35) club delegates and four (4) voting directors. Twenty (20) votes were needed to have a majority on any subsequent votes.

8. Vice President Technical Programs Report – Continued

Moved by Will Wallace, seconded by Doug Flynn, that the Vice President Technical Programs' report be accepted.

Motion Carried.

9. Vice President Club and Membership Development Report

Steven Beattie was not present and a Vice President Club and Membership Development's report was not presented in the reports package for the 2008 Annual General Meeting.

10. Vice President Marketing

Damian Brown presented members the Vice President Marketing's report verbally.

Moved by Jessica Zawada, seconded by Ian Overman, that the Vice President Marketing's verbal report be accepted.

Motion Carried.

11. President's Report

Graham Wilkins presented members with the President's report as published on pages 22-23 of the reports package for the 2008 OSSA Annual General Meeting and the OSSA Branch Report to Speed Skating Canada on pages 24-26 of the reports package for the 2008 OSSA Annual General Meeting. Moved by Don Clarke, seconded by Will Wallace, that the President's report and OSSA Branch report be accepted.

Discussion:

• Doug Flynn raised a question concerning the possible conflict of interest between the role of OSSA President and Chair of the Ontario Speed Skating Oval. Mr. Wilkins drew the member's attention to the final page of the Spring 2008 Oval Updated titled 'OSSA and the Oval Project'. The report confirmed that at no time during the past two years had the Oval Project requested or received any financial support from OSSA. In addition a previous OSSA Board had determined that no OSSA staff time would be devoted to assisting the Oval Project. At no time during the past two years has the OSSA Board considered altering this situation. OSSA has permanent right to name an OSSA

member to represent the Association on the Oval Board but at this time there has been no interest in having a volunteer exercise this option. Mr. Wilkins explained that when the final phase of the Oval Project is completed OSSA will have an opportunity to arrange a long term lease for office space in the finished facility. Mr. Wilkins confirmed that when this time arrived he would not be involved in this negotiation.

Motion Carried.

Graham Wilkins presented members with an update on the Ontario Speed Skating Oval (OSSO) as published on pages 27-30 of the reports package for the 2008 OSSA Annual General Meeting. Discussion:

- Roger Buxton asked about the funds raised through OSSA from the Brick Program. Mr. Wilkins
 responded that there is separation between OSSA and OSSO funds.
- Luanne Lee-McNabb asked Mr. Wilkins if he was remunerated in any way from OSSO. Mr. Wilkins responded that he was not.
- Ian Overman asked about the timeline to open the Oval. Mr. Wilkins responded that the Oval should be ready with natural ice for the upcoming season, followed by artificial ice by 2009 2010.

12. New Business

A. Todd Landon presented members with the Director of Sport Development report as published on pages 31-34 of the reports package for the 2008 OSSA Annual General Meeting. Moved by Doug Flynn, seconded by Will Wallace, that the Director of Sport Development's report be accepted.

Discussion:

- Doug Flynn requested that the report be amended to reflect that there were ten (10) participants, four (4) judges, four (4) timers and two (2) clerks of the course at the level 2 officials clinic in Clarington.
- Doug Flynn requested that the report indicate that there were four (4) participants from Ontario who attended Speed Skating Canada's 2008 Officials Symposium in Calgary on April 25-27, 2008.
- Andrew Dempsey asked Mr. Landon why the Director of Sport Development report
 appeared to be a list and does not show that anything was accomplished. Mr. Landon
 responded that he does not have a plan to work from and that he feels that until the
 Association has a long-term plan he is limited to carrying out the day-to-day activities of the
 Association.

Motion Carried with amendments.

- B. Cindy Van Lierop thanked the Association for the opportunity to attend Speed Skating Canada's 2008 Officials Symposium. Cindy noted that delegates from other provinces commented on how progressive Ontario was to send officials from various positions and not just starters and referees who usually get invited to these events.
- C. Roger Buxton asked that the Association standardize registration forms for all meets, standardize the meet Excel sheet and standardize the birthdates format, using written month rather than numerical month in the Excel sheet.
- D. Roger Buxton mentioned the True Sport certification program found at www.truesport.ca.
- E. Don Clarke asked that Roger Buxton give an update on the Canadian Sport Institute in Markham which Mr. Buxton provided.
- F. Competition plan proposal was discussed.
- G. Doug Gibbons asked about how OSSA would proceed on the rule changes to be presented at Speed Skating Canada's Annual General Meeting. Mr. Landon responded that OSSA would accept the rule changes as was indicated by the OSSA membership when the rule changes were presented during the 2007 OSSA AGM.

13. 2008 – 2009 Board of Directors Elections

Luanne Lee-McNabb, Chair of the Nominating Committee, explained the voting procedure that would be followed for the elections to determine the Vice President Technical Programs and the President positions. The election of each position would be conducted on a separate ballot and the results complied by Mrs. Lee-McNabb along with Laura Woodall and Lori Lytle as scrutineers. The number of club delegates eligible to vote in the Board of Directors election was thirty-six (36). Nineteen (19) votes were needed for a majority.

Discussion:

- Stephen Arnold asked that the association amend the by-law to clearly define the voting process.
- John Hreljac asked the final margin of the election not be announced.

Election of the Vice President Technical Programs

- Delegates were given time to review Tony Bean's statement contained in the reports package for the 2008 OSSA Annual General Meeting.
- David Stewart made a brief statement.
- David Stewart was elected as Vice President Technical Programs for 2008 2009.

Election of the President

- David Morrison made a brief statement.
- Graham Wilkins made a brief statement.
- Graham Wilkins was elected as the President for 2008 2009.

Moved by Don Clarke, seconded by John Hreljac, to destroy the ballots of the election. Motion Carried.

Moved by John Hreljac, seconded by Dale Coolidge, that the notice of the results of the election be destroyed within one week of the election.

Motion Carried.

Moved by Jessica Zawada, seconded by Paul Landry, to accept Graham Wilkins – President, Stephen Arnold – Vice President Finance and Administration, David Stewart – Vice President Technical Programs, Damian Brown – Vice President Marketing, and Steven Beattie – Vice President Club and Membership Development as the Ontario Speed Skating Association's Board of Directors for the the 2008 – 2009 season.

Motion Carried.

14. Adjournment

Moved by Don Clarke, seconded by Will Wallace, to adjourn the meeting at 11:30 a.m. on Sunday May 25th, 2008.

PRESIDENT

Over the past year speed skating clubs across Ontario, as well as the Provincial Association, faced the same challenging economic conditions that caused problems here in Canada and beyond. In June 2008 the Ministry of Health Promotion notified the OSSA Board that the Association's base funding grant would be reduced by a further fifteen percent.

Despite the uncertain economy speed skating remained strong across Ontario this season, which speaks to the strong community support for our clubs and the real value that is provided for our members. Registration remained stable and the races were as well attended as during any previous season. Once again the OSSA Board can report that Association remains in a good financial position because our clubs continue to flourish and our members remain committed to speed skating

At our 2008 AGM the new Competition Format was introduced and over the season our skaters, coaches and officials worked together, under the direction of the Technical Committee, to make this new, progressive format a success. Naturally there were a few challenges with the new format and by the end of the season it had become obvious that some medications would be needed, but everyone in our Association is to be congratulated for making this past season a success. The Technical Committee has already started the process of receiving advice and recommending changes for next year's format and the goal is to have an even better format in place going into the fall.

Selection of the athletes who receive support as members of the Provincial Training or Provincial Development Team was delayed this year when it was determined that there were errors made in the original ranking process. We were able to post the correct ranking list by November and our skaters still received the maximum amount of support available through Ontario's Quest for Gold Program. I am very happy to report that as a result of the hard work of the volunteers from both the Technical Committee and the Provincial Selection Committee that OSSA's ranking and selection process now meets the Ministry of Health Promotion's conflict of interest and fairness standard. This year the ranking process has already been completed and the results will available to the members as part of this year's AGM Package.

Every member should feel proud of the results Ontario's skaters achieve as they make the step beyond our Provincial level of skating to compete for positions on national development teams and ultimately the national team itself. Again this year Ontario was well represented by a tremendous group of young athletes who continue to improve their skills and speed in this pursuit. Embarking on this journey requires enormous personal dedication and strength, as well as continued support from the athlete's family and local club. Our Association plays a small part in providing the support all these young athletes need and deserve, and it should remain our goal to increase the level of support if possible.

On behalf of our Association I would like to thank all the clubs that hosted ability meets and Ontario Cup races. Meet organizers, officials, and parents provide such a wonderful service for our skaters and your efforts are really appreciated. Special mention needs to be made of the outstanding meets, the Provincials, hosted by the Kitchener Waterloo Speed Skating Club and the National Championships hosted by the Cambridge Speed Skating Club. A number of different outdoor events in Ottawa, Lakefield and Portland over the season offered our members with some unique skating opportunities and a special thanks is deserved by the members of the Sault Ste Marie Club who hosted the Provincial Long Track Championships.

There have been significant improvements in the administration of our Association's activities over the past season. Over the summer of 2008, from a number of worthy candidates, the OSSA Board selected Jackie Deschenes as our Association's new Director of Administration. The Board's original plan was that Jackie's primary responsibility would be to oversee the day to day organizational responsibilities of the Association. In addition the Board believed that Jackie would be able to initiate a program to increase Association revenues from both government and private sources.

Within a couple of weeks of Jackie arriving at OSSA we were faced with some unexpected challenges. OSSA's Director of Sport Development, Todd Landon, reluctantly decided to return to his position as Provincial Coach in Manitoba. By the time Todd departed in August it had also become obvious that initiating a program designed to solicit new private and corporate support for OSSA would be ill advised given the difficult economic situation. The Board delayed hiring a new Director of Sport Administration and Jackie was directed to assist the Technical Committee in overseeing the management of the racing season and other sport administration responsibilities. Although new to speed skating Jackie brought a fresh perspective to each committee meeting she joined and provided a better line of communication between our various committees and through the OSSA office to the members.

With a new approach OSSA has had more success in establishing the conditions required for our Association to receive additional financial support from the Ontario Government. The Ontario Government is willing to support sport initiatives designed to increase participation and capable of implementing the principles outlined in the Long Term Athlete Development program. The Ontario Government has been very clear that they are less willing to provide financial support for sports that are perceived to be exclusive with a very small membership base. With less than 2,000 members speed skating does not even qualify as a 'provincial sport' in Ontario and it is only through our participation at National Championships, the Canada Winter Games and the fact that speed skating is a recognized Olympic sport that we qualify for the small amount of base funding we currently receive. Unless we increase our membership our base funding will continue to decline each year until we reach a base level of approximately \$40,000. per season.

The Government is willing to support an organized effort to increase our Association's membership. During the summer of 2008 the OSSA Board made an application for government support for a new High School Speed Skating Program and support for this three year program was announced in March 2009. OSSA will be able to provide support for up to 12 clubs over the next three seasons that are willing to develop new High School Programs. This program will also help OSSA hire a new person responsible for sport development. It is expected that the new person will selected sometime during the summer of 2009.

Looking to the future it is important to recognize the incredible strength of our existing clubs and the great programs and opportunities that are being provided by a very dedicated group of volunteers. As an Association it is clear that we have to find ways to attract new skaters, coaches and volunteers and we have to do this without asking our existing volunteers to do more. We need to find more volunteers and develop different programs to attract and engage more skaters.

The Provincial Government has shown that they are willing to provide support for our Association to start down this path but to be sustainable it will require the participation of our clubs and being able to successfully reach out to new sources of public and private support. I know that our Association can meet this challenge in

the years ahead while we continue to develop and support some tremendous young skaters who will soon be emerging as important members on our National Team.

I want to thank every member who has in their own way made our Association so successful over the past season. I want to make special mention of the tremendous contribution made by the members of the Technical Committee as well as the supporting sub committees over the past season. I would hope that every member would take a moment to thank these volunteers for the work they have done over the past year. Our members and our Board have had outstanding support from the OSSA staff this year, Lori Lytle and Jackie Deschenes, and I would like to acknowledge their important contribution. Finally to the club organizers, the race officials, the coaches, the parents and most importantly the skaters I want to congratulate you for your passion for this great sport. Your enthusiasm and dedication inspires every volunteer to try harder and remains our inspiration for the future.

DIRECTOR OF ADMINISTRATION

ADMINISTRATION

DIRECTOR OF ADMINISTRATION

The early tasks of the 2008-2009 Board resulted in the hiring of the new Director of Administration (DA), Jacqueline Deschenes. A job description was prepared, discussed and approved by the Board. The position was posted in a number of outlets resulting in thirteen high quality applicants. The Board ranked the applicants and interviewed a subset. The Board members were delighted when Jackie accepted their offer. They have also been very pleased with a number of initiatives taken by Jackie including an OSSA logo policy, communications cost-savings, DA online calendar, OSSA web design and OSSA-labeled high performance jackets and shirts, to name a few. Jackie's fresh perspective on Association matters has been very beneficial.

In the revised reporting structure, the DA, reporting through the President, is responsible to the Board of Directors. The Office Coordinator, Lori Lytle, reports to the Director of Administration. At the same time, the Office Coordinator continues to respond directly and very effectively to the many queries and requests of OSSA's large membership.

ASSOCIATE MEMBERSHIPS

Through the fall and winter and up to mid-May, 2009, the OSSA office continued to work with OSSA's 25 clubs to register skaters. The most recent figures in Speed Skating Canada (SSC) database where members are registered show a 5 percent increase from 1802 members in 2008 to 1884 in 2009.

The mid-May SSC database shows Ontario has 964 competitive skaters, 212 recreational skaters and 509 associates. As a result, it could be said that for every two competitive and recreational skaters, OSSA registers one associate member. However, when the Cambridge club membership is examined, we find 62 competitive skaters and 103 associate members. It could be said that the Cambridge club reverses the Association ratio and register 2 associates for every competitive member.

The benefits of registering associates are many. For example, it could be an additional source of revenue for any fee above the first \$20 that is rebated to OSSA. In addition, an associate is classified as an Ordinary member that in the case of the Cambridge club doubles their delegate votes at the OSSA AGM from 2 to 4, second only to the Ottawa Pacer's club. These votes count when elections are held and when motions are made on rules and procedures.

For OSSA, Cambridge's associate fee has the effect of increasing OSSA's total membership revenue by \$2,060. Just as important, it takes OSSA's total membership 103 members closer to the next breakpoint of 2,000 members. When this breakpoint is reached, it increases OSSA's eligibility for a higher base grant from the Ministry of Health Promotion and gives OSSA an additional vote at the SSC AGM.

Partly to this end, the Board moved at the February 23, 2009 monthly meeting that all OSSA staff be registered as associate members. Their membership fees are paid for by the Association.

Membership increases in all categories except Special Event, of course, take OSSA closer to the 2,000 member goal. Thus, the 17 clubs that showed a membership increase are acknowledged and congratulated. We especially wish to recognize Durham with a 72 percent increase, Lakefield 60 percent, Toronto 47 percent, Thunder Blades 43 percent, Markham 34 percent and Newmarket 31 percent.

HUMAN RIGHTS COMPLAINT

A threatened wrongful dismissal suit and a human rights complaint made in 2006 is still not resolved due to inaction on the part of the Human Rights Commission. It is referred to in the 2009 audited financial statements as Note 13. However, the Commission recently revised its procedures which may lead to a resolution of this matter. The Board continues to be advised by Hicks Morley Barristers & Solicitors whose expertise is in the area of human resources litigation.

SSC By-Law Change

The SSC 2008 AGM held in Quebec City was the occasion for the delegate's acceptance of a completely revised By-Law. In advance of this occasion, the OSSA Board made several observations on the draft By-Law. These observations were accepted by the SSC Board and approved by the delegates. Two important observations concerned definitions of the Special Event membership category and the beginning and ending dates of the season.

FINANCE

CHANGES FROM PREVIOUS YEAR AND THE ORIGINAL BUDGET

Overall, total revenues were down 12 percent in 2009 as compared to the previous year. Unfortunately, expenses were down only 3 percent resulting in a small deficit in the operating fund. The deficit was \$2,213 which represents 0.6 percent of 2009 total revenues. However, attendees at the last year's AGM may recall a \$20,000 deficit was originally being projected for the 2009 budget. It didn't materialize because the projected third staff person was not hired.

Another change from the original budget was the unexpected 15 percent reduction of \$14,000 in the third year of the Ministry of Health Promotion base grant. The Association was originally informed that the base grant would remain stable for a three-year period. However, the Ministry informed OSSA that the base grant is too large for the Association's membership size. A base grant closer to \$30,000 is more appropriate than the current \$79,000 and unless there is an increase in the Association numbers, the grant will continue to be reduced.

The 10 percent decrease in membership fees between 2008 and 2009 observed in the financial statements occurred because \$5,300 of the 2009 fees increase was already accounted for in the 2008 financial statements presented at last year's AGM.

A very positive change from the original budget was the Ministry's award of \$54,266 in the first year of a three-year *Sport for More* grant. The grant in the second year will be \$52,533 and in the third year, \$67,073. The purpose of this grant is to support the development of a high school skating program that assists clubs in recruiting new members to speed skating. President Graham Wilkins deserves full credit for this success. He doggedly pursued this funding ever since a successful pilot program at the Peterborough Speed Skating Club in 2005.

REVENUE DIFFERENCES BETWEEN 2009 AND 2008

Reasons for the decrease in Association Revenue shown in the financial statements include decreases in donations and sponsorships, coaching clinic revenue and 'Other' development and technical revenues. The Board determined that the economy precluded investing scare staff resources to look for sponsorships and to conduct other fundraising. The budgeted level of coaching clinics did not materialize, fewer Trillium club grants and SSC hosting grants passed through OSSA books, and no training camp and Winter Games fees were received.

The third major source of revenues beyond government grants and Association revenues is merchandise gross profit. Although sales were up by over 20 percent in 2009 as compared to 2008, the cost of merchandise was up disproportionately resulting in the same gross profit as last year (\$34,000).

EXPENDITURE DIFFERENCES BETWEEN 2009 AND 2008

While most expenditure category spending levels were the same as last year, a few changes deserve comment. For example, audit fees fell again. In 2007, it was \$14,600; in 2008 \$9,500 and 2009 \$6,400. The Board and staff spend a lot of time and energy monitoring and discussing the Association's finances. It has resulted in a shorter time that the auditor time has had to spend on the books.

Increased Board and staff time was also spent this past year on accounts receivable, essentially clubs and individuals with debts going back sometimes two and three years. The result was that accounts receivable dropped 31 percent from the 2008 level. Furthermore, the provision for doubtful accounts was reduced from \$10,000 to \$4,300.

To prevent similar problems in the future, the Board is bringing forward changes to the By-Law and Information Manual to tighten payment and collection procedures. These changes are in addition to those made last year, e.g., all purchases are to be made on credit cards, and this year, e.g., 2 percent interest will be charged on outstanding balances aged over 90 days and access to meets will be restricted from clubs not in good standing beginning June 1, 2009 (Board motion D02-09-03 of Feb. 23, 2009). The OSSA office is making every attempt to send out monthly statements although we discovered that there were instances of invoices and statements going to former club officials and in one case, the arena manager. It's in the interest of each club to keep the OSSA office aware of any changes in the executive and especially the president, treasurer and registrar.

All members benefit by expenditures made in the Administration / Finance, Club / Membership Development, and Marketing portfolios. It is only some of the expenditures in the Technical portfolio that benefit only our elite athletes and coaches. Calgary Oval Fees is not one of these expenditures because OSSA is fully reimbursed as reflected in the corresponding item in Association Revenue section. Coaching clinics also benefit all clubs. The remaining \$65,600 spent on the training teams, travel to championships by coaches and managers and other coaching and technical expenses constituted 17 percent of the total of all expenditures.

FEES SCHEDULE

After increases in each of the previous four years, there is only one change to the fees schedule. The Board recognizes that the Ontario economy has not been good for many of its members.

The stated Associate fee is reduced from \$25 to \$20 to reflect what was actually charged last year. After last year's OSSA fee schedule was published, SSC lowered the fee OSSA must forward to SSC for each Associate.

OPERATING FUNDS

Three of the Association's four special purpose funds saw changes. The capital equipment fund was decreased by \$10,500 to pay for the new set of team uniforms and new computers for the Director of Administration and the Office Coordinator. Another \$5,000 was set aside for future Canada Winter Games expenses and \$170 was transferred to the Association's Trust Fund. The purpose of the Trust Fund remains the same: provide facilities, promote speed skating, support competition and provide financial assistance.

OSSA FINANCIAL HEALTH

The total value of the operating fund and the four special purpose funds is \$100,925. This value also equals Assets less Liabilities or, in other words, the net worth of the Association. Given also that total expenditures is effectively equal to total revenues, we can conclude that the Association is in a healthy financial situation.

VICE PRESIDENT TECHNICAL PROGRAMS

I would like to start this report with a note of thanks to the members of the Technical Committee who have faced a tough season given some of the changes that were made in the competition landscape for this past season. The departure of our Director of Sport Development just as the season was to start added to the work of the committee and caused a hiccup or two, but overall, the season was a great success.

The changes that were made through the introduction of Technical Bulletin #26 included a number of items that have, in practice, proven to be less than completely workable and the committee has worked to remedy these issues for next season. There has been both voluminous and helpful feedback during the season and recently, that the committee has been able to factor as the competition framework was revised.

Despite these challenges the committee put forward a competition calendar that did its best to balance the needs of our long track and short track athletes as well as the Ontario Cup and Regional Stream short track athletes. Balancing the desires of those athletes who wish to skate both disciplines and a requirement proved out to tax the Bye process and took a tremendous amount of committee and staff time to manage. As a result, changes to the Bye process were among key items under consideration by the committee as changes are made for the coming season. More stringent guidelines and more stringent application of the new rules will be included for 2009-2010 season, lessening the number of Bye Applications and the latitude used in their consideration.

Just as the Technical Committee was getting set to work through changes for next season, we received a draft copy of the LTPAD (Long Term Participant and Athletic Development) Model that is going to be put forward for adoption at this year's SSC AGM. The implications of these changes are far-reaching and have the potential to force dramatic change on the branches. The committee has begun the process of integrating some of the less controversial changes into next season as a way of adjusting to change over a longer period of time.

TECHNICAL DIRECTOR POSITION

The OSSA Board has approved the formation of a new position – Technical Director – that will be in place prior to the start of the skating season in September. The responsibilities for this new staff member will include:

- assist the Technical Committee in implementing the technical rules and regulations of OSSA
- work with clubs and the Officials Development and Coaching Development Committees to build Association infrastructure
- oversee the newly funded "Sport for More" high school program
- act as OSSA's registrar for all out-of-province meets where registration by branch is required
- act as OSSA's permanent team manager

The recruitment for the position has begun and it is a prerequisite of the position that the successful candidate have a good knowledge of the sport of speed skating and that they have a demonstrated ability to work at the local level to develop clubs.

The posting will be available on the OSSA website and will be emailed to all the clubs. If you are aware of a potential candidate, we would appreciate you sharing the posting with them and encouraging them to submit a resume for consideration.

PROVINCIAL TEAM NOMINATIONS & QUEST FOR GOLD

The ranking of long track and short track athletes has been completed based on Technical Bulletin #22 which remains in effect for the 2008 – 2009 season. Athletes were ranked based on the criteria established in the bulletin. It was the hope of the Technical Committee that the lists could be sent to the Provincial Selection Committee for review and ratification before the end of April, but this did not take place as Speed Skate Canada did not name the National Teams until the first week of May. It is necessary to wait until the National Teams are named in order to be able to adjust our lists accordingly.

As soon as the PSC has completed its work, all nominated athletes will be contacted and asked to state their intentions for the coming season. If an athlete notifies OSSA that they will no longer be skating (retiring, etc.) the affected list will be adjusted and the next athlete will be similarly contacted. The final teams will be named publicly as soon as possible and both the team members and the final ranking lists used to name the teams will be published on the OSSA website.

During the past season considerable discussion was had regarding the criteria that will be used to choose provincial teams for the 2009 – 2010 season. It is well-known that the system laid out in Technical Bulletin #22 is somewhat difficult to understand at times, a lot of work to implement and has been the source of considerable controversy. With that in mind the Committee and the Board asked for input on making changes to how Provincial Teams are chosen in the future. We received some very well laid-out proposals with a surprising number of them sharing a common theme.

The Technical Committee will be proposing a new Provincial Team selection criteria based solely on national and provincial ranking lists removing the perceived subjectivity of Technical Bulletin #22 and its use. This proposal is based very closely on many of the proposals that were submitted for our consideration. Exact details of these criteria will be made available to the membership in June for final comment, with a final set of criteria published prior to the beginning of the skating season.

COACHING AND OFFICIALS DEVELOPMENT COMMITTEES

Both of the Technical Committee's sub-committees have had a busy year and both have suffered from too much to do and not enough participation to complete the work that either needed to get done or that the committees wanted to get done. Like the Technical Committee, both committees are completely reliant on volunteer resources to both conceive and execute committee responsibilities, and while OSSA staff provide tremendous support to the committees, more willing volunteers are key to the success of these mandates. Both committees are going to be reconstituted over the summer and additional members, both officio and ex-

officio, are going to be reconstituted over the summer and additional members, both officio and exofficio, are going to be actively sought out and solicited. The recruitment, development and retention of coaches and officials is a cornerstone to the success of OSSA. Without them the development of athletes is an academic exercise at best.

Despite the challenges faced by the committees a lot of work was accomplished this past season including:

- Two coaching development clinics were held
- Two officials' development clinics were held
- Additional Learning Facilitators are becoming available

Significant emphasis is going to be placed on developing both coaches and officials and both committees are going to be making this a goal this coming season. The Ontario Winter Games is being structured to offer significant mentoring opportunities for both coaches and officials and it is expected that a number of people will be able to gain a level at the OWGs next year.

COMPETITION FORMAT

As noted earlier, the Technical Committee recognizes that there are aspects of last year's competition format that did not play out as well as expected. Changes need to be made to adjust in these areas and to make adjustments moving toward the goals laid out in the draft LTPAD program.

An outline of the changes is to be presented at the AGM in order to allow delegates to provide the final input to a draft competition format document. Within three weeks of the AGM the Technical Committee issue a draft competition format document to clubs who will then be given a defined period for review and comment. It is the intention of the Technical Committee to have a final competition format document posted and circulated by the end of July along with the selection criteria for provincial teams.

BRANCH REPORT TO SPEED SKATING CANADA

Despite the challenging economic environment, member registration in Ontario has remained stable over the past season. Ontario's clubs have continued to provide excellent programs that have resulted in strong skater and family registration.

Ontario made an important effort for the 2008 – 2009 season to modify its competition format both to satisfy the needs of its members and to better adopt the principles outlined in the Long Term Athlete Development program. Ontario continues to organize two levels of competition for its skaters; the regional ability meets as well as a series of four Ontario Cup races for our fastest skaters. The new rules reduced the amount of travel time to races, particularly for our younger skaters and the Association's best skaters were provided with a more beneficial racing experience.

Another important principle of LTAD is developing additional entry points for new members. Over the past year OSSA has worked with our Provincial funding partners to design the High School Speed Skating Program. This initiative will receive financial support over the next three years and Ontario's clubs will be provided with the resources to create a provincially funded program designed to attract high school students to speed skating.

Ontario clubs continued to provide tremendous opportunities for our members. For our short track skaters, our clubs staged 14 regional ability meets, as well as the four Ontario Club competitions. The Kitchener-Waterloo club hosted the very successful Provincial Championships and the Cambridge club did an outstanding job of staging the Canadian Short Track Championships. Ottawa, Portland and Lakefield hosted outdoor long track and marathon events with a successful Provincial Long Track Championships being hosted outdoors by Sault Ste. Marie club.

OSSA has been working over the past few years to overcome the challenge of the continuing reduction of Provincial Government support for our operations and will work with them to reverse that trend.

OSSA hired a new Director of Administration, Jackie Deschenes, in July 2008 and over the past year OSSA has been able to provide more effective and efficient administration for its members.

- Maintaining focus on club's season functions outside of preparing for Canadians. We learned how to recruit our newer families in the club to teach them the value of coming together in a volunteer capacity to create something truly amazing.

- It was a year of transition for the club as we had a big reduction in members. We revamped our direction and long term goals.
 - Clarington
- The Executive must release and divide duties and responsibilities amongst the general club membership. Formation of committees/ special projects - the goal to work together with a clear vision increasing volunteer base.
 - Durham
- The rising cost of ice and securing volunteers have served to be two of the greatest challenges this
 year.
 - Gloucester
- Biggest challenges we had this year were finding out the previous President didn't complete the first report for the clubs' Trillium Grant. We also found out that invoices sent to the previous President's address from OSSA were never put forward for payment leaving our club in arrears. By working together with OSSA and the Trillium Foundation all has been cleared by the end of the season.

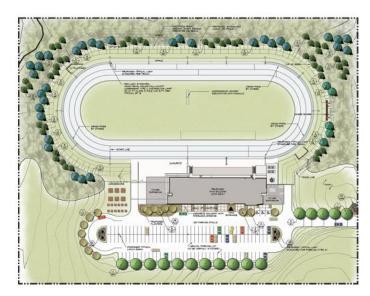

ONTARIO SPEED SKATING OVAL UPDATE – SPRING 2009 START OF THE ONTARIO SPEED SKATING OVAL

The Oval Project was started when a group of Lakefield residents, who were members of the newly formed Kawartha Quarks Peterborough Speed Skating Club, developed the idea of building a long track speed skating oval in Lakefield. The Board of the Ontario Speed Skating Association and the Association's Executive Director, Ian Henigar, embraced the initial proposal and travelled to Lakefield to meet with the local group to encourage them to expand the original concept to include the building of a temperature controlled skating oval in Lakefield.

Incorporation

In the spring of 2001 the volunteer group in Lakefield joined with the Ontario Speed Skating Association to incorporate a not for profit corporation whose goal was to build a temperature controlled long track speed skating oval and an adjoining building that would become the home of the Ontario Speed Skating Association.



Feasibility Study & Business Plan

Members of the new corporation formed a Board of Directors who raised the funds necessary to pay for a feasibility study. The feasibility study summarized the need for a temperature controlled long track speed skating oval in Ontario and concluded that Lakefield would be a good central location for long track speed skaters from across Ontario.

Based on the information provided by this study the original Oval Board recruited additional partner organizations and developed an Oval Project concept that included a number of economic activities so that the finished facility would be economically sustainable. The Oval Project received funding to commission a formal Business Plan to review the future financial activities of a temperature controlled oval and provide an organizational model for building and operating the finished facility.

Capital Campaign

In the fall of 2002 a public fund raising effort was initiated and applications for financial support were sent to both senior levels of government. In the fall of 2003 the Oval Board jointly funded, with the Ontario Speed Skating Association, the Oval Project's first full time employee and an office was opened in space donated by the local municipality in Lakefield

Fund raising efforts resulted in financial commitments from a number of local businesses, individuals and service clubs. Financial commitments were received from all three local levels of government and the Province of Ontario made a \$500,000. comitment through the SuperBuild Fund.

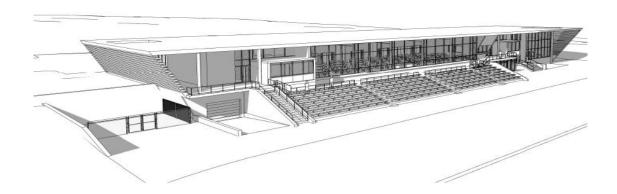
The Oval Project organized a number of major fund raising events that increased the funds available for the Capital Campaign and established the volunteer and staff base required to stage major events. The Leahy Concert that attracted over 5,000 spectators, the Dream Big Dinner, which featured Catriona LeMay Doan as guest speaker, raised over \$40,000.00. In September 2008 the Oval Board organized the 1st Annual Oval Golf Tournament, again with Catriona as the special guest. On May 9th, 2009 the 5th Annual Run the River Race was organized which attracting over 200 participants.





The Oval Project received direct funding for Project Design from Industry Canada through the local Community Futures Board as well as the Province of Ontario's OMAFRA Red Fund. These two grants provided combined with the required matching funds from private sources allowed the Oval project to complete the design and engineering for the temperature controlled oval along with the 15,000 square foot adjoining building

Project Design



The completed Oval Project will include the temperature controlled speed skating track that will have artificial ice from mid November until the end of March. During the spring, summer and fall the concrete track will be used for in line skating and the infield area will be available for community use as a playing field. The Oval Building will house the administrative offices of both the Ontario Speed Skating Association as well as the staff responsible for managing and operating the facility. The Bridgenorth Ennismore Lakefield Rotary Club will manage a 250 person banquet hall which has been designed to be turned into separate meeting rooms. The Oval Building will feature a concession area that can be accessed from both inside and outside the facility which will be operated by the clients and staff of the Canadian Mental Health Association. There will also be a public training, assessment and work out area of the building, along with athlete change rooms.

Unique to the Oval with be the ice creation system which will use geothermal technology to create a cost effective and better quality ice surface for the Oval. This technology will use the 'waste' heat energy that is a by-product of creating the ice surface and use it to heat and cool the Oval facilities and potentially 2000 area homes.

The mechanical design solution for creating the artificial ice will be established as a pilot project for the most efficient and environmentally responsible manner of operating a skating facility. The Oval Board is currently in discussion with a large public company that has expressed interest in becoming a partner in the Oval Project as the utility provider. This system will not only create a cost effective skating surface the system will produce a source of revenue that will help cover the operating costs of the facility.

Phase 1 - Construction & Two Winters of Natural Ice Programming



In the spring of 2007 the Oval Board received the zoning changes and official plan amendments required for the 15 acre Oval site. In the fall of 2007 final Site Plan Approval, in effect the building permit, was issued, and an official groundbreaking ceremony was held on September 24th, 2007.

The site was cleared and a temporary road was built to provide access from the Lakefield Highway. After the topsoil was removed and stored for later use a

substantial cut and fill excavation process was undertaken. This involved cutting into the rock at the east end of the Oval and using the material to fill and compact the centre and west end of the track. The result was a completed construction ready road bed track which was ready to accommodate a natural ice oval by late December 2007.

During the fall of 2008 additional site work was completed with funds provided through the Regional Community Futures Fund. Additional track grading and site drainage were completed. A temporary warming hut and on site water source installed.





An unusually snowy winter of 2008 made the ice surface a challenge but a partial season of skating events took place on the Oval. A number of public and corporate skating events took place on the Oval. The Oval was rented to groups from three local schools and a Master's race took place on the weekend of Feb 2nd & 3rd.

The cold winter of 2009 allowed for a much better season of skating and events. In addition to increased use by local schools and recreational skaters the Oval hosted a two Master's Event as well as the Pond Hockey Tournament. Skaters from Bancroft visited the Oval often during the season with the result that a new speed skating club will be formed in Bancroft starting in the fall of 2009.

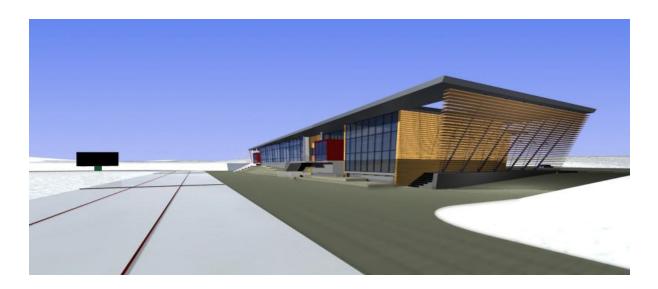
NEXT STEPS

Phase 2 construction will involve the installation of the piping system and concrete surface on the 400 metre track as well as the heat exchange system that will create the temperature controlled ice surface. Phase 3 construction will see the completion of the 15,000 sq. ft. multi use facility adjacent to the temperature controlled track.

Two Development Projects, one on the 35 acres of land located to the North and South of the Oval Site, as well as one on the 18.5 acre site on the eastern boundary of the Oval site, are proceeding through permit and design stage. This development will see the construction of a blend of commercial and residential buildings on the lands adjacent to the Oval site.

These development projects remain a necessary element for the completion of the Oval as the services corridor and road will be an integral part of the private development and will provide services and proper access to the Oval site. The commercial and multi family residential buildings will also provide economically feasible customers for the heat that will be generated by the Oval's heat pump system. The Oval Board will be working with a utility partner to build this innovative system and in partnership take full advantage of the economic benefit of the design. A secondary energy feasibility study is being completed by GeoXergy that will allow the Oval Board to reach a formal development agreement with the utility partner.

The total cost of the completed Oval Project will be \$12 million. To date the Oval Board has spend approximately \$ 1.5 million on Project design and development, \$.5 million on Phase 1 construction and secured the 15 acre site valued at \$.75 million. The Federal Government has committed an additional \$ 1.2 million while the Provincial government has committed \$.5 million while the Oval Board has raised over \$ 2 million in local public and private donations. The accepted formula for funding major infrastructure projects like Oval will see the two senior levels of government commit an additional \$ 5.5 million while the Oval Board will have to raise another \$ 2 million to reach its full fund raising goal which will allow the Oval Project to be completed. Applications for the remaining government funds are now in the hands of both the Federal and Provincial Government.

APPENDIX A – BY-LAW AMENDMENT: DIRECTOR TWO-YEAR TERMS

Rationale: The model for this change is Speed Skating Canada's By-law where an election of one half of the Board is held each year. The proposed amendment to OSSA's By-law provides a better guarantee of administrative continuity which is important for OSSA's long term health.

Article 9.03.1

Existing Article

The Voting Delegates at the Annual Meeting shall elect the Directors and officers of the Association for the ensuing year save and except or another individual who is ex officio a Director and save and except the Secretary of the Association.

Amended Article

The Voting Delegates at the Annual Meeting shall elect the Directors and officers of the Association save and except an individual who is ex officio a Director and save and except the Secretary of the Association. Directors are elected for a two-year term. In odd years, the President, the Vice President Technical Programs Administration and the Vice President Marketing are elected. In even years, the Vice President Administration and Finance and the Vice President Development are elected.

APPENDIX B – BY-LAW AMENDMENT: NOMINATING COMMITTEE RESPONSIBILITIES

Rationale: The proposed amendment clarifies the responsibilities of the Nominating Committee including a confirmation of the applicability of Article 7.09.2, i.e., "The results of the poll vote or ballot shall be recorded in the minutes of the Meeting of Members."

Article 12.06

Existing Article

The Nominating Committee shall:

- a. prepare a list of candidates for vacant offices;
- b. accept any written nominations for elected offices;
- c. make recommendations to the Board of individuals to fill vacancies in the offices, on the Board, or on any committee.
- d. The members of the Committee shall consist of three Ordinary members of the Association appointed by the Board subsequent to the Annual General Meeting (AGM) but in any event not later than the January 31st following the AGM.

Amended Article

The Nominating Committee shall:

- a. Consist of three Ordinary members of the Association appointed by the Board subsequent to the Annual General Meeting (AGM) but in any event not later than the January 31st following the AGM,
- b. Prepare a list of candidates for vacant offices,
- c. Accept any written nominations for elected offices,
- d. Make recommendations to the Board of individuals to fill vacancies in the offices, on the Board, or on any committee,
- e. Conduct by ballot the Election of Directors, and,
- f. Record the results of the ballot in the minutes of the meeting.

APPENDIX C – BY-LAW AMENDMENT: NONPAYMENT OF FEES

Rationale: Non-payment and delays in the payment of fees has consequences for both individual members and clubs. The final notice to be issued by an officer of the Association ensures that the member or club involved is duly informed before membership benefits are revoked.

Article 16.06

Existing Article

If annual memberships, dues, other fees or special assessments are not paid by a Member within thirty (30) days of a notice of non-payment being given by the Secretary or Executive Director, the membership of such Member shall thereupon automatically cease but upon payment of all unpaid fees plus a penalty assessment (not to exceed 25% of the fees so payable as determined by the Board), any such Member shall be reinstated.

Amended Article

If annual memberships, dues, other fees or special assessments are not paid by a Member or Affiliated Club within thirty (30) days of a notice of non-payment being given by the Secretary or Vice President of Administration and Finance, the Member or Affiliated Club shall be declared to be not in good standing and ineligible to receive membership benefits. However, upon payment of all unpaid fees plus a penalty assessment (not to exceed 25% of the fees so payable as determined by the Board), any such Member or Affiliated Club shall be reinstated.

APPENDIX D — INFORMATION MANUAL AMENDMENT: DEFINITION OF SEASON AND MEMBERSHIP FEES DUE DATES

Rationale: This amendment makes the definition of a season consistent with the change made last year in Speed Skating Canada's By-Law. The amendment also makes clear when the prescribed fees are due and the subsequent period of membership benefits.

Article A6: Membership Dues

Existing Article

- A6.01 The annual membership dues shall cover the period from January 1 to December 31 of each year.
- A6.02 Each affiliated club is responsible for the collection of membership dues from its members and for the transmission of the portion thereof applicable to the Association membership (and the portion thereof applicable to SSC membership, if the Association acts as intermediary) to the OSSA office or the Vice President Finance and Administration together with the prescribed forms.
- A6.03 Each affiliated club shall pay the appropriate membership dues to the Association, in advance, on or before December first of each year. (i.e., 2006 fees are due on December 1, 2005.) Any person who joins thereafter shall pay such dues at the time of registration.
- A6.04 No skater shall participate in an event sanctioned by the Association unless his/her dues have been paid and a membership number assigned to him or her.

Amended Article

A6.01 A season begins April 1st of any given calendar year and shall last until March 31st of the following calendar year. Membership paid in one season expires on December 31st of the following season.

- A6.02 Each affiliated club is responsible for the collection of the fees, dues and special assessments detailed in Annex A4 and for the transmission of these fees to the OSSA office or the Vice President Finance and Administration and for registration of members on the Speed Skating Canada (SSC) database.
- A6.03 Each affiliated club shall pay to the Association the appropriate fees and special assessments detailed in Annex A4 as follows:
 - a. Club fees (Affiliation and liability insurance) by December 1,
 - b. Membership fees (individual and family fees) within 60 days of registration on the SSC database but no later than March 31, and,
 - c. Competition fees (sanction and check-in fees) within 30 days of the last day of the competition.

A6.04 No skater shall participate in an event sanctioned by the Association unless his/her membership fees have been paid and the individual has been registered on the SSC database.

APPENDIX E - STARTER EXPENSES

PURPOSE:

To assist the official starter with their personal costs while working a competition

PROPOSAL:

It is proposed that each club hosting a competition will subsidize the costs to the starters for materials used to work a given competition. The host club should also make arrangements to cover the costs for accommodations for the starters , provided they require same, if not already being taken care of either by billeting or club policy to do so as with other officials.

COST STATISTICS:

The purchase of a 22 cal pistol is approx \$200.00 to \$300.00

With proper care would last many years. Each starter should have 2 guns

Gun cleaning solutions & tools - \$25.00 to \$30.00 - should last a couple of years

Other items required are earplugs, whistle, case to store items for travel, and arm bands.

On going costs are shells for gun - cost \$10.00 per box of 100- depending on size of meet - whether it is a 1 or 2 day meet a starter could go through 300 to 500 shells per competition.

If a starter works 6 meets per year, his /her cost would run approx \$275.00 for the season.

starters also have the cost of accommodations (especially at 2 day meets) at an approx cost of \$125.00 per night plus travel (gas).

MOTION:

The motion is that each club would set aside in their meet budget an amount of \$50.00 per starter used at the competition. (usually 3 x 50 =\$150.00) plus accommodations if needed. The \$50.00 would be paid to the starters at the end of the meet. The \$50.00 would cover ammunition costs and possibly some gas costs.
