#### STEP 1: SURFACE PREPARATION

All wood surfaces. To ensure optimum performance from STORM SHIELD™ the following procedures should be followed in their entirety. Proper preparation and application will ensure adequate penetration, adhesion and coloration. All surfaces must be free of dirt, dust, grease, mildew or other contaminates. Before using any chemicals around plants or vegetation, care should be taken to water plants and the ground around them thoroughly so absorption of chemicals is less likely. To minimize any possible damage to plants, shrubbery and grass, the area should be covered with plastic during all cleaning and application procedures. Keep STORM SHIELD™ off all glass and concrete surfaces.

New wood: All new wood, rough sawn or smooth, that has been installed outdoors and exposed to weather conditions for less than 120 days may not accept product adequately. Mill glaze and grain compression from milling equipment, excess tannins, sap and natural residues form a barrier, which limits penetration in new wood. To ensure your wood surface is ready to receive the penetrating stain, apply a small amount of water in several places on the surface you wish to treat. If water stays on the surface and does not penetrate, thoroughly wet the surface by rain or tap water 8 times or more to open wood grain. Repeat the water test. Continue this process until the surface absorbs water immediately. Your wood is now ready to treat. Although STORM SHIELD<sup>TM</sup> may be applied to damp surfaces, treating new wet pressure treated wood may cause pressure treatment salts to exude to the surface. Allow wet pressure treated wood to age a minimum of 8-12 weeks after installation outdoors. STORM SHIELD<sup>TM</sup> may be applied as soon as the surface feels dry and there is not standing water from cleaning procedures or rain.

**Old wood:** Unprotected old wood is typically discolored to various shades of gray to black. This is due to mold, mildew and algae contamination and ultraviolet light attack on the wood surface. Remove contamination with GEMINI WOOD BRIGHTENER PLUS following all label directions or a solution of 1 part household bleach and 1 part water. Always rinse surface thoroughly after cleaning. Pressure washing is recommended for best results. **STORM SHIELD**<sup>TM</sup> may be applied as soon as the surface feels dry and there is no standing water from cleaning procedures or rain.

Previously stained wood: STORM SHIELD<sup>TM</sup> is designed for application on clean wood surfaces. Remove old stains and coatings with GEMINI INJECTABLE SAFE STRIP OR GEMINI SOLID STRIP according to label directions. Chemical stripping may be required in some cases. When applying transparent finishes, it is imperative that the cleaned surface is uniform in appearance. Applying this product over a previously sealed surface may result in non-uniform appearance and poor adhesion if surface preparation is inadequate. STORM SHIELD<sup>TM</sup> performs best if old finish is completely removed. To ensure your wood surface is ready to receive STORM SHIELD<sup>TM</sup>, apply a small amount of water in several places on the surface you wish to treat. If water stays on the surface and does not penetrate quickly, repeat the stripping procedure. Repeat the water test. Continue this process until the surface absorbs water immediately.

#### STEP 2: BEFORE YOU APPLY

Due to variations in wood color and porosity, finish color may vary from desired result. Check color by applying sample on the surface in an inconspicuous area to determine desired effect. Because horizontal surfaces are subject to harsher conditions (foot traffic, standing water, deck furniture, spills, etc.) than vertical surfaces, we cannot guarantee color retention and recommend maintenance coats as needed. Before applying **STORM SHIELD**<sup>TM</sup> clear the surface of all dust, dirt, debris and standing water. **Mix thoroughly before and occasionally during use. Do not tint or thin this product**. When using multiple containers of the same color, "box" or mix all containers into 1 larger container to ensure uniform color.

#### STEP 3: APPLICATION PROCEDURES

**All wood surfaces:** Avoid application in direct sunlight to hot surfaces (produces lighter color). If unavoidable pre-wet the surface with water and apply immediately after surface has no standing water. Apply when surface temperature is between  $50^{\circ}$  -  $85^{\circ}$  F.

**Method of application:** Apply with nylon bristle brush, paint pad, short nap roller or spray (pump up style or airless). When spraying, follow the spray application with a back-brush, roller or paint pad to even out runs, drips, puddles and uneven application.

#### **Vertical Surfaces:**

Always apply product laterally in 3-4 foot sections while maintaining a wet edge. Immediately wipe drips and runs from bare surface with a wet rag or sponge. This is essential to avoid lapping on the next pass over the untreated surface below. A second coat can be applied **immediately** after the surface feels dry to touch. **Do not** apply additional stain that will not absorb into the wood. Do not allow the stain to build and form a surface film.

## **Horizontal Surfaces:**

Apply **STORM SHIELD**<sup>TM</sup> to vertical railings before the deck surface. Cover the deck surface with plastic to catch any runs or drips. Do not allow product to puddle. In order to avoid lap marks; maintain a wet edge by coating boards from one end to the other. Flat surfaces are easily controlled when spray application is followed immediately by backrolling, brushing or wiping with an applicator pad. This procedure assures that differences in wood porosity are subjected to adequate amounts of product. A second coat should be applied **immediately** after the surface feels dry to touch. **Do not** apply additional stain that will not absorb into the wood. Do not allow the stain to build and form a surface film.

**Spread rate:** NEW WOOD – 250-400 sq. ft./gal. per coat. OLD WOOD 200-300 sq.ft./gal. per coat. Rate will vary depending on wood porosity. A two-coat application always yields the best results particularly on horizontal surfaces. Do not apply additional stain that will not absorb into the wood. Do not allow the stain to build and form a surface film.

#### STEP 4: COMPLETION

**Dry time:** 1-6 hours: dry to touch. 1 hour = to touch, 6 hours = Foot Traffic, 24 hours = Full Service. Surface is also ready for light foot traffic at that time. Furniture may be moved back into place after 4-6 hours depending on weather conditions and full service. Do not apply if rain is possible within 24 hours of application.

Thinning and Clean up: No thinning required. Clean up with soap and warm water.
