

## **Avalon is a Covenant Restricted Community.**

In order to maintain the standards of the community, there are Rules and Regulations that all Homeowners (and guests/tenants of the homeowner) are required to follow. Homeowners are responsible for the conduct of their guests and tenants.

Failure to follow the Covenants and Restrictions will result in a warning and then fines:

1<sup>st</sup> Offense = Warning 2<sup>nd</sup> Offense = \$55 Fine 3<sup>rd</sup> Offense = \$80 Fine 4<sup>th</sup> Offense = \$105 Fine

**Each Additional Offense = \$105**

If you are a renter, all correspondence or any other contact with the HOA <u>must</u> be done through your landlord.

- 1) You (or your guests) are not allowed to park a vehicle in the street or in your yard at any time, day or night.
- 2) Trash day is on Friday. You can put your trashcan out Thursday night and it must be in your <u>backyard</u> behind the fence or inside the garage within 24 hours of collection.
- 3) You must keep your lawn mowed and maintained.
- 4) You must not do anything that can be deemed offensive or annoying to neighbors or it is considered a nuisance.
- 5) Semi-trucks, semi-tractor trailers, boats, campers, travel trailers, mobile homes, disabled vehicles, or trailers are not allowed in your driveway or anywhere on Avalon property. This also includes box trucks.
- 6) You cannot store <u>anything</u> in your front yard. All equipment, garbage cans, woodpiles or storage piles shall be kept from view of neighboring homes and streets.
- 7) You <u>must</u> gain approval from the Architectural Review Board before making <u>any</u> external change to your home. All fences must also be approved by the ARB.
- 8) Pets are to be confined as to not become a nuisance. Excessive barking by dogs or vicious animals shall constitute a nuisance and can be ordered by the association to be removed from the property. You <u>must</u> also pick up any pet waste and dispose of it appropriately.
- 9) You cannot do motor vehicle repairs unless it is fully enclosed in the garage.
- 10) Only signs approved by the Board of Directors are permitted. No "open house" or "yard sale" signs.

These are just a few of the Avalon Rules and Regulations.

Please consult your CCR's for a complete list.

The pool is open from 9:00 AM – 10:00 PM seven days a week. To enter the pool area you must have your key and correctly colored pass. Children under 14 are not allowed in the pool without an adult (this is S.C. Law). After 5:00 pm no one under 17 is allowed without their parent or guardian.

To play on the fields/courts you must have your pass with you at all times. NO PASS – NO PLAY. The fields/courts close at dark and there is no loitering. In order for a child to have a guest, the parent must be present.
