## UnitedHealthcare Children's Foundation®

A grant from UnitedHealthcare Children's Foundation (UHCCF) provides financial relief for families who have children with medical needs not covered or not fully covered by their commercial health benefit plan. UHCCF aims to fill the gap between what medical services/items your child needs and what your commercial health benefit plan covers.



## Who is eligible for a grant?

The full list of eligibility criteria is available on [www.uhccf.org](http://www.uhccf.org). Here are a few of the criteria:

- Families who have a child or children with medical needs that are not covered or not fully covered by their commercial health benefit plan
- Financial need of the child's family will be a consideration. For more information, check the Foundation Web site, [www.uhccf.org](http://www.uhccf.org)
- The application must be submitted to the Foundation before the receipt of services. The Foundation does not pay for past medical expenses

## How does the grant work?

If a grant for your child is approved by the Regional Board of Directors, the grant will help pay for approved medical services/items after your commercial health benefit plan submits payment, if any. The grant funds are not paid to you or the child outright – you work with UHCCF to submit invoices/bills for approved medical services/ medical items after your commercial health benefit plan submits initial payment (if any) to the health care provider.

## What is the process for applying?

For specific information about how to apply for a grant, please log onto [www.uhccf.org](http://www.uhccf.org). Once on the Web site:

1. Click on the "To Apply" menu item, then click on "Applicant."
2. Read through the information about the grants. Please be sure to look at the criteria and application checklist to see what information you may need to collect for the application (see sidebar). If you meet the criteria and have all the items listed in the checklist, then you can apply for a grant online.
3. As you enter the application process online ([www.uhccf.org](http://www.uhccf.org)), you will be led through a pre-screening questionnaire to determine eligibility.
4. If you pass the pre-screening questions, you will be offered the full online grant application.
5. Please note that though the application is sent online, some required paperwork must be mailed to UHCCF.

## How long does the application process take?

The online application itself will take approximately 15-20 minutes to complete. The entire application review process varies. If you apply on behalf of your child, meet the stated criteria and have the items in the checklist on hand, please submit an online application.
