



**Eleventh Annual Gumbo Cook-Off,
Raffle and Silent Auction**

Rules and Regulations (please read carefully):

- \$60.00 Entry Fee per Team. If registration is received before March 1, 2019, save \$10 (\$50 total registration cost)! Registrations are accepted at the door.
- Teams can begin check-in at 9:00 am. Cooking can begin after registration. Registration will conclude at 10:30 am.
- The gumbo must be cooked on Park Grounds. Due to limited space and unpredictable weather it is recommended that you bring a pop up tent. No teams will be allowed under pavilion. Tents may be set up after registration on Saturday or on Friday, March 22 from 5-6:30pm.
- Each team can consist of 1-4 contestants. Eight wristbands (total) will be given to teams for entry. Additional guests will have to pay \$10 admission into park.
- Each team must supply all ingredients, utensils for cooking, tables, and portable burners for cooking.
- Heartstrings will provide serving cups, plastic spoons, and paper napkins for those sampling your gumbo.
- Each team must prepare a minimum of 5 gallons of gumbo with 6 judge's portions.
- Gumbo must be cooked from scratch within the time allowed, on site. Roux may be pre-cooked.
- *Teams must keep areas clean during event and are responsible for cleaning their own cooking areas at end of event. **No dumping is allowed in the park.** Trash bins are provided.*
- There will be a cash bar on site in which some of the proceeds will go to Heartstrings & Angel Wings. (Discounted cases will be available for teams to pre-order. **NO GLASS CONTAINERS ALLOWED.** If you bring glass containers on the property, you will be asked to throw them away or remove them from Park grounds immediately.) Please limit drinks brought onto property.
- Awards and prizes will be given for First, Second, and Third Place in each category.
- This year's Cookoff theme is "Louisiana Saturday Night." Please keep this theme in mind when preparing for the cookoff. *We will also have a booth/cooking area decorating contest this year with a specific theme. Please look for more information about this on our website and/or more information will be sent to you after registration.*
- **We are asking each team to bring at least ONE auction item to help the success of our auction fundraiser. It can be a stand-alone item or a gift basket with a variety. This is not required, but appreciated, and it tax deductible. If you would like ideas, please message us and we will send you our current wish list.**
- **Preferred DEADLINE for registration is March 1, 2019. Registration IS accepted at the gate with \$60 registration fee.**

Our Mission

Heartstrings and Angel Wings is a non-profit charity organization which provides clothing and other handmade items for babies in Neonatal Intensive Care Units. The items we provide aid in comforting the babies and uplift the spirits of the baby's family members. Heartstrings and Angel Wings is recognized as tax-exempt under Internal Revenue Code section 501(c)(3).

Why support Heartstrings & Angel Wings?

Babies that are born prematurely face weeks to months in Neonatal Intensive Care. Families of premature babies face longer hospital stays and greater medical expenses for the mother and baby. The birth of a baby born prematurely is often out of emergency and unexpected—there is no time to prepare, there is often no explanation, and the experience is traumatic. After the NICU, some babies face lifelong illnesses or disabilities and a family is forced to make sacrifices and difficult decisions.

Heartstrings & Angel Wings steps in after the baby's birth to help the family and clothe their small miracle. We also provide bereavement gowns to those families facing a loss of their baby. We are a locally based (Breaux Bridge), non-profit organization started by the Patin family after their own experiences and finding out the need for micro preemie clothing. Our clothing is lovingly handmade out of cute material suitable for a baby. Clothing is donated either directly to the family of a premature infant, or given to hospital representatives to distribute directly to their patients.

Heartstrings' goal is to make a family's time in the Neonatal Intensive Care Unit a little easier—providing clothing to fit their 1-5 pound baby is a comfort that cannot be bought in the store. We also provide clothing for bereaved babies and other comfort items for the NICU.
