

We represent Aurelius Capital Management, LP, Fir Tree, Inc., King Street Capital, L.P., King Street Capital Master Fund, Ltd., Monarch Alternative Capital, LP, and Stonehill Capital Management LLC (collectively, the "RMBS Policyholders"), in their capacity as owners of or managers of funds that own residential mortgage-backed securities, in the above-referenced matters. The RMBS Policyholders filed Appeal No. 2010AP1291 from an order of the Dane County Circuit Court on May 27, 2010. That appeal is fully briefed. On March 10, 2011, the RMBS Policyholders also filed a notice of appeal arising from the Dane County Circuit Court's January 24, 2011 order approving the Plan of Rehabilitation of the Wisconsin Office of the Commissioner of Insurance ("OCI") for the Segregated Account of Ambac Assurance Corporation. That appeal has been assigned number 2011AP000561.

On March 15, 2011, OCI filed a motion with this Court seeking to consolidate appeals arising from the May 27, 2010 order (which await this Court's ruling) with those arising from the Circuit Court's January 24, 2011 ruling (for which the record is still being assembled). The RMBS Policyholders intend to file a response to OCI's motion and will do so within the 11-day period provided for in Wisconsin Statute § 809.14.
