Dear Judge Johnston:

I am writing on behalf of our client, the Wisconsin Commissioner of Insurance, as the court-appointed Rehabilitator in the above proceeding, in regard the February 23, 2011 (at 1 p.m.) "Motion Hearing on . . . Rehabilitator's request for hearing on United States Internal Revenue Services' Motion to Dissolve supplemental injunction" (quoting from the Dane County court notice). This hearing Notice was dated February 8, 2011 and subsequently mailed to the parties by the Dane County Clerk on February 9 and received for the first time by us on February 10, 2011. Upon receipt of the Notice, we immediately emailed copies of it to the four lawyers from the U.S. Department of Justice who have entered appearances in the related federal proceedings. A copy of our service on the four IRS lawyers and the hearing notice and post-marked envelope from the clerk are attached for the convenience of your review.

As you likely are now aware, the IRS commenced a new lawsuit in the United States District Court for the Western District of Wisconsin on February 9th, the day after the existence of your hearing Notice was posted on CCAP, but the day before the parties received copies of the Notice or knew the content of the Notice. In connection with the new federal court action against the Dane County Circuit Court, the Wisconsin Commissioner of Insurance and Ambac Assurance Corporation, the IRS moved for a preliminary injunction and asked the federal court for an expedited ruling by February 17, 2011 on the grounds that they wanted the federal court to rule on their new action for injunctive relief prior to the February 23rd hearing in your court referenced in the Notice. Our interpretation of the Notice is that the February 23rd hearing date was set to address the Rehabilitator's request that you set a hearing on the IRS's motion (e.g. a hearing to set a hearing), not that the court would actually address the merits of the IRS's motion on the 23rd.

Before filing its purportedly emergency motion to expedite in the federal court, the IRS never contacted us to inquire as to our understanding of the hearing on the 23rd or whether we

would adjourn the hearing so as to avoid any purported time "emergency" before the district court. To the best of our knowledge, the IRS also made no such request of you or the Dane County clerk, nor did the IRS withdraw the motion which prompted the hearing request. A simple call to us would have rectified that situation because we would have been happy to adjourn the February 23rd hearing to a later date to avoid needless time pressures. This letter will confirm my telephonic request today to Ms. Baux at the clerk's office that the Court take the February 23rd scheduling hearing off the calendar at this time and adjourn it indefinitely to such later date as may be appropriate and requested after Judge Crabb addresses the IRS's new filing. I also spoke with the Dane County Corporation Counsel, Ms. Mackenzie, and she supported this approach. Absent other direction from the Court, we will proceed on the understanding that the hearing on February 23rd is off the calendar.

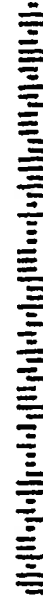
