Dear Mr. Voelker:

The Wisconsin Commissioner of Insurance, as Rehabilitator of the Segregated Account of Ambac Assurance Corporation and Respondent in each of the above-referenced appeals, writes to inform the Court regarding two steps he has taken to promote efficiency and ease of reference for the Court and all parties to these appeals.¹

As the Court is aware, the record on appeal is immense. With over 600 separate documents in the record totaling more than 11,000 pages, it would be administratively inefficient for parties on appeal and the Court to repeatedly search their own voluminous files to review cited portions of those documents. Moreover, the filing of multiple voluminous appendices with likely redundancy in the included documents would exacerbate the inefficiency by requiring parties and the Court to resort to various documents reprinted in multiple sources, without uniformity of citation.

To assist the Court and the parties in avoiding such potential problems, the Commissioner—following consultation with the appellants—has taken two actions to promote uniform citation by all parties to these appeals to the same documents, from the same source. First, the Commissioner has re-created the record on appeal verbatim on a publicly accessible Web page, organized by record number, with hyperlinks to all substantive filings in the record. The page is accessible through the “Record on Appeal” link on the same Web site that has been used with the approval of the circuit court throughout the underlying rehabilitation proceeding,

¹ Because the steps described in this letter were disclosed to appellants and not opposed by any of them, the Commissioner describes those steps in this letter rather than a formal motion. If the Court would like the Commissioner to make this disclosure to the Court in the form of a motion instead, the Commissioner will promptly do so.

The Web page will make citations to the record in briefs (“R. ___”) easier for the Court, the parties, and the public to access and review. A printed version of this new Web page is attached to this letter.

Second, to the same end, the Commissioner has also proposed and worked with the parties to create a Joint Appendix for these appeals, which is enclosed. The Joint Appendix contains all orders of the circuit court encompassed by these appeals, as well as select filings of the Commissioner that are fundamental to the commencement of the rehabilitation and the subsequent Order confirming the Commissioner’s Plan of Rehabilitation, from which most of the present appeals are taken.


The Commissioner proposed these administrative steps to counsel for the appellants last week, and informed them that he would be sending this letter to the Court. No appellant has expressed any objection, and several affirmatively encouraged these steps. One appellant asked that the Commissioner include additional documents in the Joint Appendix, and those documents have been included as requested. The Commissioner has also pledged to work with the appellants and any other interested parties to promptly correct any errors or omissions on the Web page if such matters are brought to his attention.

The Commissioner is hopeful that the new Web page and the Joint Appendix will reduce confusion and the amount of paper in these appeals by providing equal, convenient access to all available documents and enabling parties to cite the record directly (or, as appropriate, the Joint Appendix), rather than filing and citing extensive duplicative appendices with the Court. The Commissioner intends that the Joint Appendix will relieve appellants of the requirement to file their own appendices under Wis. Stat. § 809.19(2).
