PLEASE TAKE NOTICE that Assured Guaranty Re Ltd. (“AG Re”) and Assured Guaranty Corp. (“Assured Guaranty” and, together with AG Re, the “Assured Reinsurers”) appeal to the Court of Appeals, District IV, from the entire final order entered on June 14, 2011, in the circuit court for Dane County, the Honorable William D. Johnston presiding by judicial assignment, in favor of Ambac Assurance Corporation (“Ambac”) and the Wisconsin Commissioner of Insurance, Theodore K. Nickel, as court-

appointed rehabilitator (the "Rehabilitator"), and against the Assured Reinsurers, requiring the Assured Reinsurers to refrain from seeking arbitration of disputes with Ambac, to withdraw a petition to compel arbitration they had filed in New York state court, and to make certain monetary payments to Ambac.

This is not an appeal within Wis. Stat. § 752.31(2).

This is not an appeal to be given preference in the circuit court or court of appeals pursuant to statute.
