Johnston, presiding, in favor of the Commissioner of Insurance of the State of Wisconsin, as Rehabilitator of the Segregated Account of Ambac Assurance Corporation (the “Rehabilitator”), wherein the court approved the Rehabilitator’s Amended Motion to Approve Purchase of Surplus Notes.
