Notice is hereby given that the Federal Home Loan Mortgage Corporation ("Freddie Mac") appeals to the Court of Appeals, District IV, as of right pursuant to Wis. Stat. § 808.03(1)(a), from the whole of the final order entered on May 27, 2010 in the Circuit Court for Dane County, the Honorable William D. Johnston, presiding, in favor of the Office of the Commissioner of Insurance of the State of Wisconsin, Sean Dilweg, and Ambac Assurance Corporation, wherein the court denied the RMBS Policyholders' Emergency Motion to Modify Order for Temporary Injunctive Relief and Motion to Intervene, and the LVM Bondholders' Emergency Motion to Enjoin Consummation of the Proposed Settlement between Ambac and Certain CDS Counterparties, in which motions Freddie Mac partially joined.

This is not an appeal within Wis. Stat. § 752.31(2).

This is not an appeal entitled to preference by statute.
