Dear Judge Johnston:

Although we were not served with a copy, it has come to my attention that an individual named Jonathan Lee Riches filed a *pro se* 3-page handwritten submission styled as a motion to intervene and motion to recuse on June 17, 2010. According to the following public website, http://en.wikipedia.org/wiki/Jonathan_Lee_Riches, Mr. Riches is a prisoner from Kentucky who is listed in the *Guinness Book of World Records* as the world's most litigious person. Riches has previously filed lawsuits against Bill Belichick, George W. Bush, Martha Stewart, Somali pirates, Britney Spears, Jimmy Hoffa, the Roman Empire, the Garden of Eden, and Plato. Mr. Riches' motions identify his present address as a locked federal medical center in Lexington, Kentucky, with a resident number.

All of the statements in Mr. Riches' motion are patently false and have no place in this rehabilitation proceeding. While his motion papers are so eccentric and outrageous, it is tempting to disregard them, the Rehabilitator does not want there to be any unnecessary loose ends in this proceeding. Mr. Riches is not a policyholder and has no standing or other interest to the best of our knowledge pertaining to the subject proceeding. Accordingly, unless you deem it appropriate to have further proceedings, briefing or argument of any nature pertaining to his motions, we respectfully request that his motions be summarily denied. A proposed form of order to that effect is submitted for the Court's convenience.
